We rescued 305 cats and kittens. 244 of these successfully re-homed and we currently have 53 cats in our care (including kittens) and 21 of these are permanent residents. We did more trap, neuter and release of feral/farm cats this year than the previous year and also helped people with lower income to spay/neuter their cats.



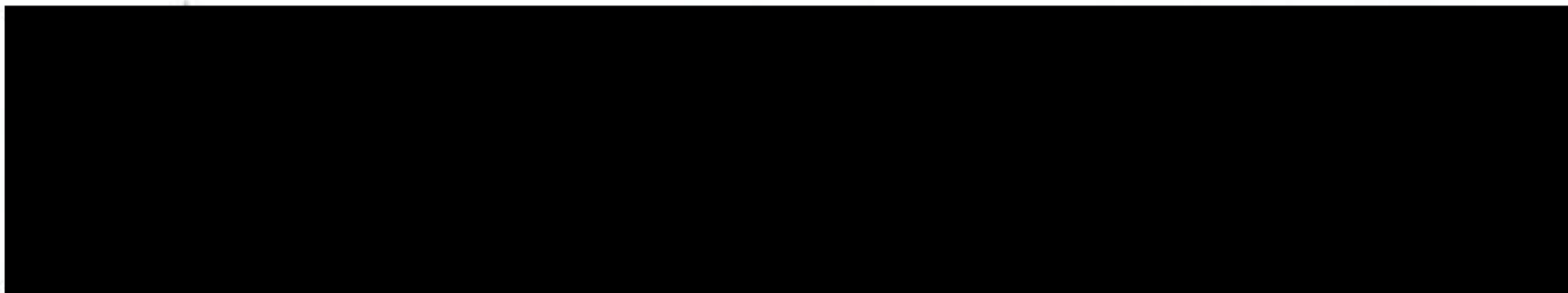

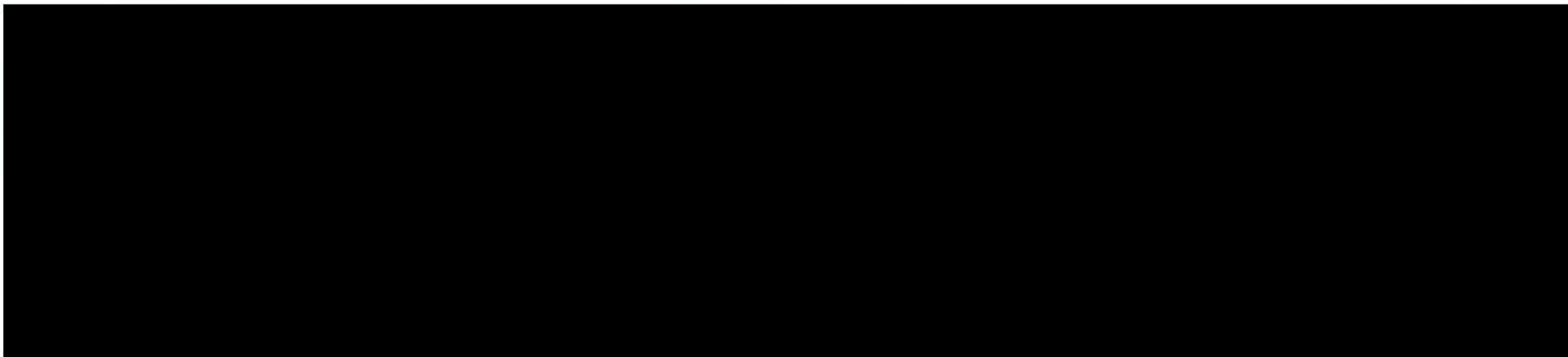
