advance community development, including urban or rural regeneration, following principles of sustainable development, where sustainable development means development which meets the needs of the present without compromising the ability of future generations to meet their own needs. 3.5 To advance education and in particular to promote opportunities for learning, training and employability for the benefit of the Community and the public at large. 3.6 To advance the health and wellbeing of the Community. 3.7 To advance environmental protection or improvement including preservation, and conservation of the natural environment, the promotion of sustainable development, the maintenance, improvement or provision of environmental amenities for the Community and/or the preservation of buildings or sites of architectural, historic or other importance to the community.
