Objectives and activities

Charitable purposes

1.1 To encourage the population of the area to take up water sports and leisure activities. This will be in co-operation with the local education authorities, local health boards, local community planning groups and other local organisations and it will include school pupils and leavers, adults and people with disabilities.

1.2 To facilitate recreational activities and support open regattas and other open events in the area as considered desirable.

1.3 To assist local clubs, organisations and individuals in the area by facilitating courses for personal performance improvement and in coach education.

1.4 To provide a focal point for clubs and the general public to obtain information regarding sport and leisure issues in the area.

1.5 To apply for, collect and hold in such bank accounts as may be opened by the committee funds to be used for the benefit of SSAP and its affiliated members as the committee may direct.

Summary of the main activities in relation to these objects

The promotion of community participation in healthy recreation and competition in the sports of sailing, windsurfing, fishing, rowing and kayaking, through the provision of facilities, coaching and instruction in the afore mentioned sports.

The promotion of interclub communication, support, and interconnected visions for the enhancement of water sports at Castle Semple Loch.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

- During the 2020 reporting period SSAP clubs and their Covid officers drew up detailed risk assessments and worked in partnership with Clyde Muirshiel Regional Park (CMRP) to manage activity on the loch and ensure members safety.
- In response to an increasing number of new water users, especially open water swimmers, SSAP asked CMRP if they could help to protect members of the public by providing some safety notices advising of the water circulation pattern and potential dangers from fast moving boats.
- In March 2021 SSAP approved a request to buy/rent an area of the Lochshore field from West Coast Paddlers (WCP) kayaking club.
- After discussion about the ways to manage the sale to WCP SSAP members agreed to move from the current system of land ownership to one in which each club has an allocated area.
- SSAP clubs also agreed that the SSAP charitable organisation was no longer serving its intended purpose and should be dissolved.
- Public liability insurance was renewed for Lochshore field.
- An area behind existing and planned club compounds was offered to a local group wishing to plant wildflowers in the field.
- All clubs are now on the water and are gradually returning to normal activity as the measures imposed by Scottish Government become less restrictive.

The charity will ensure that sufficient capital is available to complete each part of the project, with working capital being injected by the clubs where necessary. The charity will not hold excess reserves.

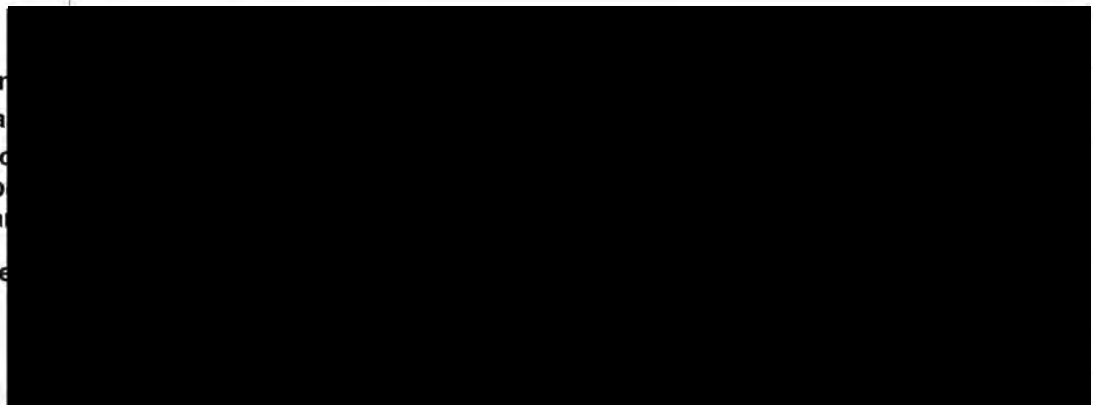
