The project assists widows and orphans (children who have one of more of their parents) of Park Rangers of the Virunga and Kahuzi-Biega National Parks in the Eastern Democratic Republic of Congo (DRC). We deliver funds and support for the delivery of the services the project provides to its beneficiaries.

These services include: a) equipping and training women for independent sustainable livelihoods; b) enabling access to education for children.

The charity also engages in awareness raising of the conservation efforts and challenges park rangers and their families face, to support our achievement of the charitable aims.

Fundraising has been on-going throughout the reporting period, whilst maintaining donor relationships.

Summary of the main achievements of the charity during the financial period

Successful distribution of funds according to the charity's purpose with direct short- and long-term benefits to the beneficiaries, included:

- Securement of agricultural land and tenure for the widows cooperative located in Kanyaboyonga, December 2024
- A one-off contribution to widows groups for emergency food aid in Kahuzi Beiga and Goma during the early period of intense conflict in 2025, enabling the women to remain in situ (hibernation) and stay together.

The charity has minimal reserves. Publically raised funds are committed to direct charitable expenditure. Restricted grant income, when received, is earmarked for specific costs according to the terms of the grant.

The charity is currently supported by volunteers to provide its website maintenance. Trustees also provide website support, access to online platforms (fee paying) to enable secure transfer and storage of data (MEGA) and communication platforms (ZOOM); and cover all travel costs to meetings and provision of promotional material.

Other optional information

Despite the escalation of conflict, risk to life, food insecurity and the occupation by M23 Rwandan backed forces, each of the women's groups in the South Kivu area has persisted.

The support towards subsistence farming and secure land tenure has been an important benefit for them. Although the agriculture project has been paused due to restrictions on the transfer of funds to DRC, the training delivered in the previous year has continued to bring the beneficiaries benefits.

Whilst the charity recognises it is not our charitable aim to support crisis situations; we have remained in contact with the beneficiaries, providing encouragement and support to the groups to enable them to continue with their livelihood initiatives as best as possible.

In early 2025, using the communication networks within the project, we provided externally validated security updates during the invasion to support the groups to make better informed decisions based on reliable information.

Donor interest and grant funded support for initiatives in DRC has become extremely difficult to find due to the ongoing conflict and uncertainty. Whilst the banks remain closed money transfer are limited to small transactions via online payment methods which is limiting our activity.

It is noted that support for the charity's accountancy continues to be provided on a voluntary basis free of charge. Website domain fees, ZOOM (international conferencing) and data storage (Mega) subscriptions, comms and travel, continue to be donated by the board. These costs are tracked and noted in our annual accounts.

Other optional information

The training and development for the agricultural project in Kahuzi Beiga region has benefited this year from working collaboratively with a partner project. Working closely with a Congolese national, Michel Chikwanine, now a Canadian citizen, we are building the capacity for sustainable agriculture within the community where the widows and children reside.

These activities have also led to strengthening the role of the local project assistant in Kahuzi Beiga, broadening his local network, working with others to source local supplies, and support logistics, more effectively when required for the project. Broadening the local network directly contributes to the independence of activities and development and we hope this will continue.

This network also provided logistical support for the recovery of a widow who had been abducted by rebels in another region. By drawing on the PRWOP network, she was supported to gain access to the PANZI hospital in Bukavu, close to where the project assistant and his wife reside, and they were able to host her during the course of the treatment. This was a deeply emotional and challenging crisis for the whole group to navigate and although it is not the aim of the charity to support crisis situations, the group was comforted by the knowledge that the work we have done together created a network on the ground which could provide her with support.

Further development was undertaken by board members of the charity to expand our network of contacts in East Africa. A promising cross over into mental health and wellbeing for park Rangers and their communities may open up access to new funding to support the women's enterprises. There is interest, but generally funding has continued to remain scarce.

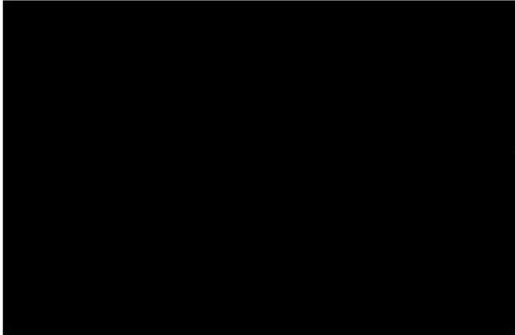
