- To build high quality mountain-bike trails that offer a progressive challenge for riders of all abilities and can be constantly developed with each new generation of riders.
- To manage and improve the diverse habitats across the site and manage the woodland in a sustainable and productive way.
- To encourage use and enjoyment of the site by a diverse range of people for a diverse range of uses.

Summary of the main activities in relation to these objects

- Building trails of green to red grade using volunteer skills and knowledge
- Thinning and removing trees in line with the woodland management plan and underplanting with desirable species.
- Managing wildflower meadows.
- Improving habitats and creating new habitat features.
- Working with volunteer groups, particularly encouraging young people to get involved.
