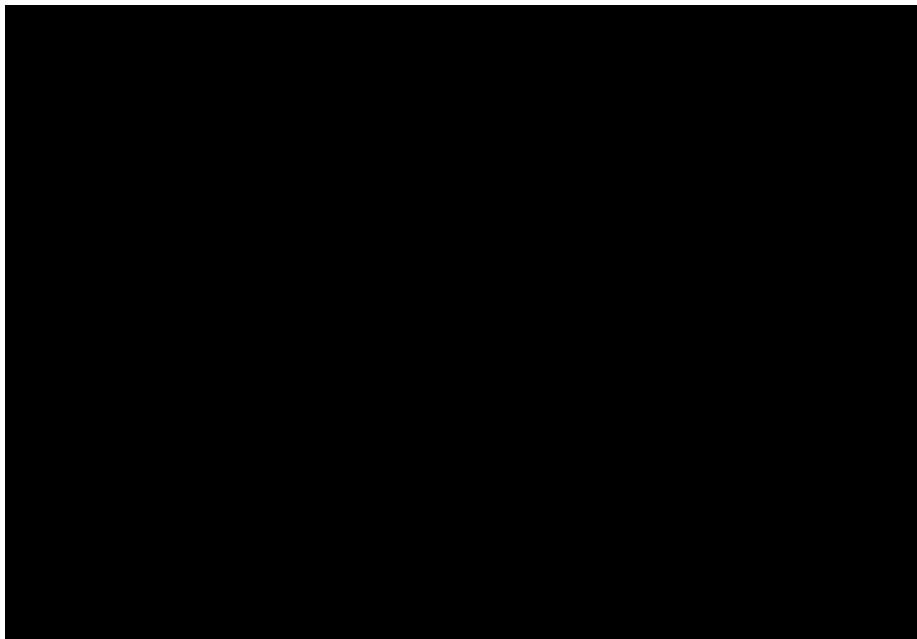

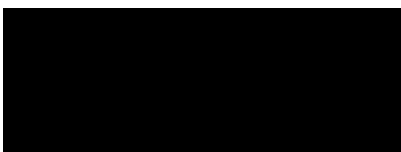

Introduction

Noble Arts Amateur Boxing Club are a Scottish Charitable Incorporated Organisations (SCIO) SC043408 . The organisation was granted charitable status on 12 September 2012.

Management

Noble Arts Amateur Boxing Club are currently made up of a Board of Trustees who meet on a regular basis as well as a number of voluntary members who support and assist with the Charitable aims and objectives of the organisation.

Objectives and Activities

Charitable purpose

The objects of the Noble Arts Amateur Boxing Club are:

To advance citizenship and community development through enabling young people to challenge energy in a positive and controlled manner, and also through actively involving them in committees and sub-groups connected with the design and delivery of the charity's services and thereby building their self-confidence and capacity for group-working;

To advance public participation in sport through the provision of sports facilities and the provision of training and supervision by qualified staff; and To provide recreational facilities and the organisation of recreational activities, with the object of improving the conditions of life for the public in general, and in particular young people from the community.

Activities

The main activities are the promotion of boxing, health and fitness classes to the local community. In addition, over the course of the year, a Food Programme was undertaken to support vulnerable local people.

Statement of Responsibilities of Trustees & Independent Examiner
