**Principal aims and objectives**

The aim of Edinburgh Bible College ('the charity') shall be to promote the advancement of education and religion which is achieved through equipping God's people for God's purposes by training in Scotland and wider afield through personal interaction and distance learning in the teaching of the Bible and historic doctrines of the Christian faith. This will focus on and be structured to encourage their spiritual growth and equip them for effective Christian ministry.

**Principal activities**

Our passion and goal continues to be making solid, biblical, practical and transformational training available to as many people as possible, wherever they live. This is primarily done through virtual classrooms which are held over three days and two evenings of each week in term time, and through the provision of course material which is accessible to those who are registered for eLearning (distance learning).

**Achievements**

We are encouraged by both the quality and quantity of those enrolled to study with EBC in the various routes into study we offer. In the present academic year, there has been particular interest in our Pastoral Theology and Homiletics modules.

We are grateful to God for the provision of Pastor Ramone McKenzie who was appointed as Vice Principal in August 2025, with a view to succeeding Pastor John Brand as Principal in February 2026. This is a major stage in the College's ministry and development, and we move forward with renewed vision and sense of purpose.

**Future plans**

In partnership with the outgoing Principal, Pastor Ramone McKenzie is considering possibilities for the future, especially in the area of profile raising and networking.

**Financial review and position**

Per the Statement of Receipts and Payments on page 5, the charity reported net payments of (i.e., a deficit) for the year of £87 (2024, deficit £1,894).

### **Risks & uncertainties**

Conscious of our somewhat fragile financial basis we continue to explore possibilities of funding from supportive Trusts.

### **Structure, governance, and management**

Edinburgh Bible College ("the charity") is a Scottish Charitable Incorporated Organisation (SCIO) (No. 043657) established on 18 December 2012 and governed by its Constitution.

#### **Organisational structure**

The structure of the organisation consists of:

- The Trustees – who are the organisation's only members
- The Board of Directors – who control the activities of the organisation; for example, the Board is responsible for monitoring the teaching and for monitoring and controlling the financial position of the organisation
- The Council of Reference, drawn from amongst local churches and from wider afield in such areas as Christian ministry, teaching, education, literature, and business – who have the right to attend Annual General Meetings and any Special Meeting. They have an advisory role under the Constitution - they may suggest people to serve as Trustees, inform succession planning and development of the activities of the College, and advise on any useful changes to the Constitution over time.

The Board of Directors ("The Board") comprises the Trustees and the Principal of the College.

The Principal is responsible for the day-to-day management and direction of the College and is directly accountable to the Trustees

#### **Appointment of Trustees**

The Board's procedure in relation to considering a person nominated for the role of Trustee is as follows. If the nominated person is considered to be suitable and has the required skills and experience, the Principal would meet with the person in order to (1) explain the ethos and workings of the College (2) assess the person's eligibility as a potential Trustee and (3) ensure the person's awareness of a Trustee's statutory responsibilities. The nominated person would be given time to reflect on the role of the Trustee and, assuming no reason debarring involvement, the nominated person would be invited to attend the next Board meeting as an observer. Thereafter, the nominated person would meet with either the Chairperson or Vice-Chairperson, and the Principal to further explore the role and involvement of a Trustee. Details of this meeting would be conveyed to the other members of the Board and, in the event of a unanimous decision by the Board, the nominated person would be invited to become a Trustee.

The Trustees serve voluntarily and meet quarterly.

#### **Reserves Policy**

The Trustees aim to retain reserves at a level that would provide sufficient coverage of any operating shortfall that arises for a period of three months.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF EDINBURGH BIBLE COLLEGE

I report on the accounts of the charity for the year ended 31 July 2025 which are set out on pages 5 to 8.

**Respective responsibilities of Trustees and Examiner**

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity Trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

**Basis of independent examiner's statement**

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

## 1. Accounting policies

### 1.1 Basis of preparation

The accounts have been prepared on a receipts and payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulation 2006 (as amended)

### 1.2 Purpose funds

#### Unrestricted

**General fund:** encompasses all income and expenditure relating to the primary focus activities of the charity, other than those for which funding is restricted.

#### Restricted

**Restricted fund:** represents funds donated specifically to subsidise online tuition for church leaders in South Sudan and to provide associated study materials. This activity has come to an end in the year to 31<sup>st</sup> July 2025, and with the donors' permission, the fund has been transferred to the general fund.

### 1.3 VAT

The charity is not registered for VAT and accordingly, expenditure includes VAT where appropriate.

## 2. Charitable expenditure

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for beneficiaries.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity. There was no fee for the independent examination of the accounts because the work was done in a voluntary capacity (2024: £0).
