## **Structure Governance & Management**

### **Constitution**

Lanarkshire Christian Fellowship/Tabor Ministries (TM) is an unincorporated charity, registered with OSCR- ref: SC043693, and is governed by Church Of God Scotland's' constitution. The Charity was granted charitable status by OSCR on 09th January 2013.

### **Appointment of Trustees**

The committee of Lanarkshire Christian Fellowship/Tabor Ministries (TM) normally meets on a weekly basis, as is also for managing day to day operations of the organisation. The committee members are recruited from the membership and appointed at the AGM according to the constitution.

### **Management**

The trustees are responsible for the strategic direction and governance of the Church, whilst day-to-day running is delegated to the chairman, a non-paid member of staff, servicing as the church minister. We also have several volunteer leaders to assist on a Rota basis.

## **Objectives & Activities**

### **Charitable purposes**

The main activities and achievements through the year included:

- 1 - Organising conferences and Seminars for families where people are invited from different church groups and discuss faith related issues and help them to cope with their day to day lives.
- 2 - Organising and facilitate youth seminars and conferences where young people are invited and taught how to handle day to day issues in their lives from Christian perspective and how can they use their abilities in the community they are in.
- 3 - Organising cultural programmes to motivate everyone to be a part of the community.  
Organising Sunday school classes, every Sundays where students are invited from the own group and taught Biblical studies to develop their faith.
- 4 - Organising Youth meetings every once in a month to promote and build their Christian faith which gives them more confidence in their daily lives among their School/ College/Universities.  
Organising Women's group where they invited people within their group or different churches and pray for the community, government and discuss day to day issues in their life.
- 5 - Organising Talent programmes and musical evenings to promote everyone's talents and shape their personality which also builds up their confidence on how to address the public.
- 6 - Organising Carol service where the children and youth sang hymns and songs to senior citizens within the care home.

### **Activities**

1. Sunday Worship Services: Weekly services for praise, preaching, and fellowship to support spiritual resilience and religious advancement. They are open to all and provide a time for worship, Bible-based teaching, prayer

2. Sunday Schools: Biblical teaching for children, providing moral education to contribute to youth development and family support
3. Youth Meetings: Dedicated sessions for young people to explore faith, discuss life issues through a Christian lens, and form supportive friendships, fostering personal development and community ties.
4. Gospel Meetings: Periodic open gatherings, including outreach services, sharing the Christian message accessibly while providing opportunities for conversation, prayer, and signposting to support, promoting spiritual growth and community well-being.
5. Kids Club: Interactive sessions for young children with stories, games, and crafts, nurturing early spiritual development.
6. Discipleship and Leadership Conferences: Conferences and workshops on discipleship and leadership development, offering in-depth teaching and practical skills to deepen faith and enhance service within the church and community, fostering spiritual and communal growth.
7. Fasting and Prayer Meetings: Gatherings dedicated to prayer, often incorporating fasting, for individuals and the wider community, promoting spiritual growth and mutual support while advancing religious harmony.
8. Community Fun Day: Events uniting church members and residents through family-friendly activities like games, food, and entertainment, accessible to all, to strengthen neighbourhood bonds and demonstrate commitment to community service, enhancing social inclusion and cohesion.
9. Music and Testimony Nights: Evenings showcasing personal faith stories and worship through song, providing platforms for sharing spiritual journeys and musical talents to inspire, encourage, and uplift attendees, fostering spiritual growth and creative expression.
10. Conventions: Gatherings for inspiration and networking, advancing religious objectives through collaborative faith activities.
11. Care Home Visits During Christmas: Volunteer visits to local care homes during the festive season, featuring carol singing, sharing the Christmas message, and companionship to combat loneliness, spread cheer, and promote emotional well-being among residents, aligning with community support objectives
12. Tract Distribution: Respectful distribution of Christian literature by volunteers on local high streets and door-to-door, in line with local guidance, offering free resources to those interested without obligation, to share faith messages and provide accessible spiritual guidance, advancing religious outreach and community engagement.
13. Participation in National Conference: Attendance by members and leaders at national conventions and conferences to connect with the wider Christian community, receive teaching, and gain inspiration for local work, enhancing religious collaboration, spiritual development, and the charity's outreach impact.
14. Sunday School and Youth Anniversary: Annual celebration of young people's faith journeys through performances, scripture recitations, and awards recognising participation and achievements, enabling children and teenagers to lead worship while showcasing the vibrancy of youth programmes and the dedication of volunteer teachers, fostering educational and spiritual growth within the community.
15. Church outings (fun/sports/games/food): Periodic outings and sports days that promote wellbeing, inclusion and inter-generational friendship; concessionary places ensure cost is not a barrier.
16. Newyear service: To mark the transition into the new year, a special service was held. This provided an opportunity for the congregation and community to gather for a time of thanksgiving for the past year and to seek God's blessing and guidance for the year ahead through worship and prayer

## **Financial Review**

The main source of funding is from tithes and donations of church members. All funds we received last year were unrestricted and this sum up £35,333.50. The resources expended during the year were £30,405.33. At the end of the year, £46,473.50 remained in the unrestricted fund.

## Independent Examiner's Report to the trustees of

I report on the receipt and payment accounts for the year ended 31st March 2025 set out on page 6

#### **Respective responsibilities of trustees and examiner:**

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under section 43(2) of the Charities Act 1993(the 1993 Act) and that an independent examination is needed.

#### **Basis of the independent examiner's report:**
