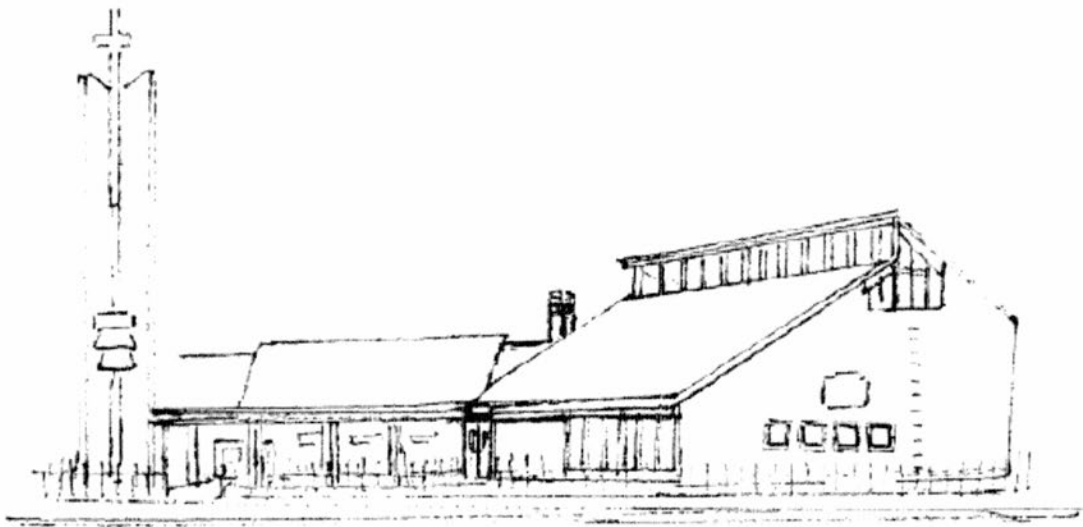

Year ended 31st December 2024

STRUCTURE, GOVERNANCE AND MANAGEMENT

GOVERNING DOCUMENT

The Church is administered in accordance with the terms of Deed of Constitution (Unitary Form)

RECRUITMENT AND APPOINTMENT OF TRUSTEES

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Interim Moderator, who is a member of the Kirk Session, is appointed by Presbytery to fulfil the duties of the Minister during a vacancy in March 2023 and further FTE Minister of Word and Sacrament was allocated to the Church of Scotland commencing 4th January.

ORGANISATIONAL STRUCTURE

The Kirk Session, which meets at least eight times a year is the Governing Body; certain responsibilities are delegated to sub-committees. The main sub-committees of the church are:- Ministry Team, Pastoral, Mission, Finance and Fabric, Safeguarding.

OBJECTIVES AND ACTIVITIES

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Corby, Church of Scotland retained the Interim Moderator appointed by the Presbytery of England and Channel Islands, and the FTE Minister of Word and Sacrament that was appointed. The team continued working with the Auxiliary Minister and Reader.

Corby, Church of Scotland holds family worship at 10 am on Sundays and prayer services every day except Sundays.

Baptisms and the Blessing of children are celebrated as part of the regular Sunday Service.

In addition to weddings, Corby, Church of Scotland also conducts funerals both at the Church and at local crematorium for members of the Church and the community.

Corby, Church of Scotland has a Safe Guarding Policy which is kept up to date through a designated Safe Guarding Coordinator and committee.

Corby, Church of Scotland has a Data Protection Policy.

Corby Church of Scotland has a Conflict-of-Interest Policy

Corby, Church of Scotland is a Fair Trade and Eco Congregational Church and has an ongoing commitment to maintaining this status.

Achievements and Performance

Ministry Team:

Vacancy: [REDACTED] continued as Interim Moderator, [REDACTED] was appointed as an Associate Minister working from the 4th January 2024, along with [REDACTED] locally Ordained Minister and [REDACTED] Reader

Services in Person:

Sunday worship is at 10.00 am. Communion has been at various times during the year. Originally set at once a month, it was reverted in June, to four times a year, excluding special services.

Services via Zoom

Daily Prayer meetings (except Sundays): Includes Bible readings, reflection, prayers and closes with a hymn. During the year special themes included Seven days, seven themes, for the World week of prayer for Peace in Palestine and Thy Kingdom Come.

Weekly Bible Study – The year started with a study of the Gospel of Mark, followed by a study of the Lords Prayer, and finished with the Minor Prophets.

Special Services:

10th January: A service of Induction service took place for Rev Scott McCarthy with the Very Rev Professor David Fergusson preaching. Representatives of the Presbytery of England and local churches were also in attendance. Refreshments were served after the service.

28th March: Maundy Thursday was celebrated with an AGAPE service including a meal.

29th March: Good Friday evening service.

31st March: Outside Sunrise Service.

17th May: Corby Church of Scotland hosted the Shire and Soke (Churches Together in Northamptonshire, Peterborough and Rutland)

29th September, Harvest Festival - Donations of fresh food was given to Eden Park. This is a project for young mums, based in the centre of Corby and made up of thirteen supported accommodations of flats. The tinned food was donated to the Corby Food Bank. The retiring collection was given to Corby Food Bank.

9th November St Margaret Declaration Service. A joint service, which was hosted by Our Lady of Walsingham, Occupation Road, Corby to commemorate the signing of the declaration, followed by refreshments and fellowship. A total of thirty members of both churches attended with several taking an active part in the service. It was agreed in principle that Corby, Church of Scotland would host the 2025 service.

12th November Remembrance Service: This service included the laying of wreaths outside on a memorial erected by the Beanfield's Residents Association. Our Scouts Groups, and two of the denominations who regularly use our church.

Christmas Eve Candlelit Service: This was a traditional service of Nine Lessons and Carols, where once again the denominations who use our church joined us for worship.

Christmas day: A service was held in the church.

Baptisms and Weddings -The Church is made available, for those who wish their baptism and wedding to take place in the context of a Christian Service

Ecumenical:

Churches Together - One of the members of our Ministry team is a member of the Enabling Group of Churches Together in England and is the ecumenical representative for the Presbytery of England and Channel Islands.

Four different denominations have used our church for worship, and other activities throughout the year.

Members of the congregation have attended Easter and Christmas town centre open air services. These services are organised by local Christian churches. Members of the Ministry Team have taken part in these services.

Pastoral:

The pastoral team look after members of the congregation, by personal visits, cards and delivery of flowers.

Mission:

World Mission: Corby, Church of Scotland supports World Mission. Stamps are collected regularly. Ekwendeni Hospital, Malawi continues to be supported by monthly retiring collections. The work of Christian Aid is supported by specific collections, during May and at Christmas time, and the congregation support ad hoc appeals, with retiring collections.

Food Bank: Corby, Church of Scotland supports the local Foodbank by making donations of food and money, prayer and volunteering personnel. Monies donated through their bucket and retiring collections totalled £715.44.

Schools: Work with the two local Schools, Beanfield Primary School, and Red Kite Special Academy continues. Both schools support Messy Church, by the distribution of leaflets to their pupils. The Associate minister works with Red Kite school as its Chaplain.

Messy Church: This mission involves, not only church members, but also volunteers from the community. There are twenty- five volunteers and usually ten volunteers join us each month. There is also a dedicated prayer team. During 2024, there were nine sessions, and we had fifty one families come through our doors, a total of sixty adults and one hundred and eight children.

Shoe Box Appeal: This year the shoe boxes were going to Malawi, in South Africa, seventy-nine shoe boxes were prepared by members of the church and their friends. The Sunday before the boxes were taken to the collection centre they formed an integral part of the service.

The Afternoon Tea and Cake, which started in 2023 has grown in strength over the last twelve months and is well supported by members of the community and congregation.

Corby Highland Gathering: The Associate minister proposed that Corby Church of Scotland had a representation at the Corby Highland Gathering, a two-day event to promote the new Corby, Church of Scotland. The church applied for a grant for this project from the Church of Scotland Seeds for Growth for £1,000 which was approved. The event was over two days, it included free refreshments, based on a mock cocktail called “the burning bush” an area for Messy Church, prayer and fellowship. Giveaways included New Testaments, religious literature based on everyday life, and a special booklet relating to the life and

work of Eric Liddle. Each day had a different section of the community attending. Saturday was local people; Sunday was local and visitors from all over England. There was good engagement with attendees during the weekend, including Christian and non-Christian discussions.

Hall Lets – Corby Church of Scotland as part of their mission allows free use of the halls. This includes a weekly Coffee morning by a group called Care and Share, Home Ed-Performing Arts

Union:

Under the Presbytery Mission plan, it has taken over twelve months from the Union to the sale of the St Andrew's site. An area consisting of a church and hall. The Church of St Andrews was closed immediately, in March 2023, but the hall was allowed to be used until the sale of the building. The exchange of contracts for this site did not take place until the 5th December 2024. The St Andrews manse is still under a rental contract which was agreed before the Union in March 2023. All relevant records have been sent to the Church of Scotland. Unwanted items, that were saleable went to auction, and some memorabilia went to Corby Heritage Centre, and other items have been integrated into the new Corby Church of Scotland.

Communication:

A monthly intimation sheet is available from the church or on line.

Weekly notices are played before and after the service on the AVC screens giving details of forthcoming events, meetings and financial update.

Website - This continues to be a useful tool for information about what is going on within the church, links to bible study, prayers, and intimations. The website continues to receive regular prayer requests.

Age Profile/Attendance:

Although an aged congregation, Corby, Church of Scotland continues to be supportive and generous in the giving of their time, talent, money and prayers, and enjoys fellowship with one another, and within the community.

The average attendance for general services over the year has been forty, with an average of thirty-four watching via You-Tube. The attendance for communion services was forty-eight.

Financial Review:

The template which is supplied by the Church of Scotland has changed and you may notice a slightly different format from the that previously used for the preparation of Receipts and Payments.

Union of the two churches': We were still working through the integration of the two church, and this has an impact of the finances of the church.

Analysis of donations:

Free will Offerings: This year's free will offerings total just over £25,000 and were on a par with last year. Other funds to which the congregation contribute is Coin a Day, Sunday fellowship, social activities which includes the income of £395 from the afternoon teas.

Gift Aid: Due to the union of the two churches on the 1st March 2023, the treasurers agreed that they would claim individually from HMRC up to the closure date of the church. This resulted in only nine months gift aid donations being included in this year's accounts.

Analysis of Other income.

The information here has been transferred from the Receipts and Payments section of the accounts.

The income from hall and sanctuary lets increased by £3127 on the previous year, however this includes £3000 from the rent of St Andrew's Hall let's which ceased in September.

Income increased from funerals due to the number undertaken by members of the Ministry team.

Further income came from sales of assets, a grant from Seeds of Growth, and insurance rebate.

Expenditure:

This year we reduced our deficit by £5,686. Gas and electricity bills have been considerably higher in 2024 due to the end of contracts and the higher renewal charges. The higher insurance cost for the empty property of St Andrew's church was offset by the rental of their manse.


Giving to Grow for 2025 is based on the new formulae. Under the new system, our giving to grow for 2025 is £40,800. However, we have been informed by the Church of Scotland that if we pay this amount, we are only paying 67% towards the cost of the ministry allocated to our Charge, which is £68,000. This is further reduced by a Stipend Endowment income for our church of £892.00 along with a further allowance of £11,196. This means our final Giving to Grow contribution for 2025 is £28,712, resulting in our payment representing only 47% of the cost of Giving to Grow requirements for our charge.

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted funds of £77,827 which with increased expenses expected during 2025 equates to six months reserves.

Statement of Trustees' Responsibilities:

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Corby, Church of Scotland:

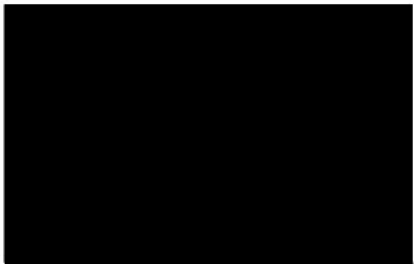
Basis of independent examiner's statement

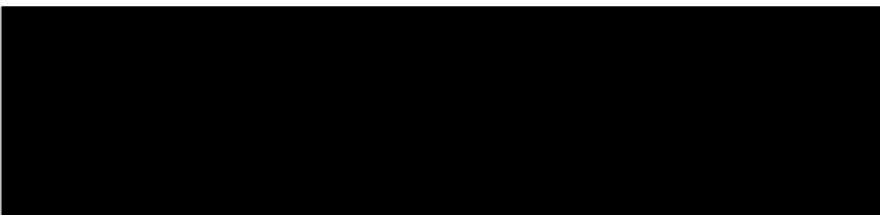
