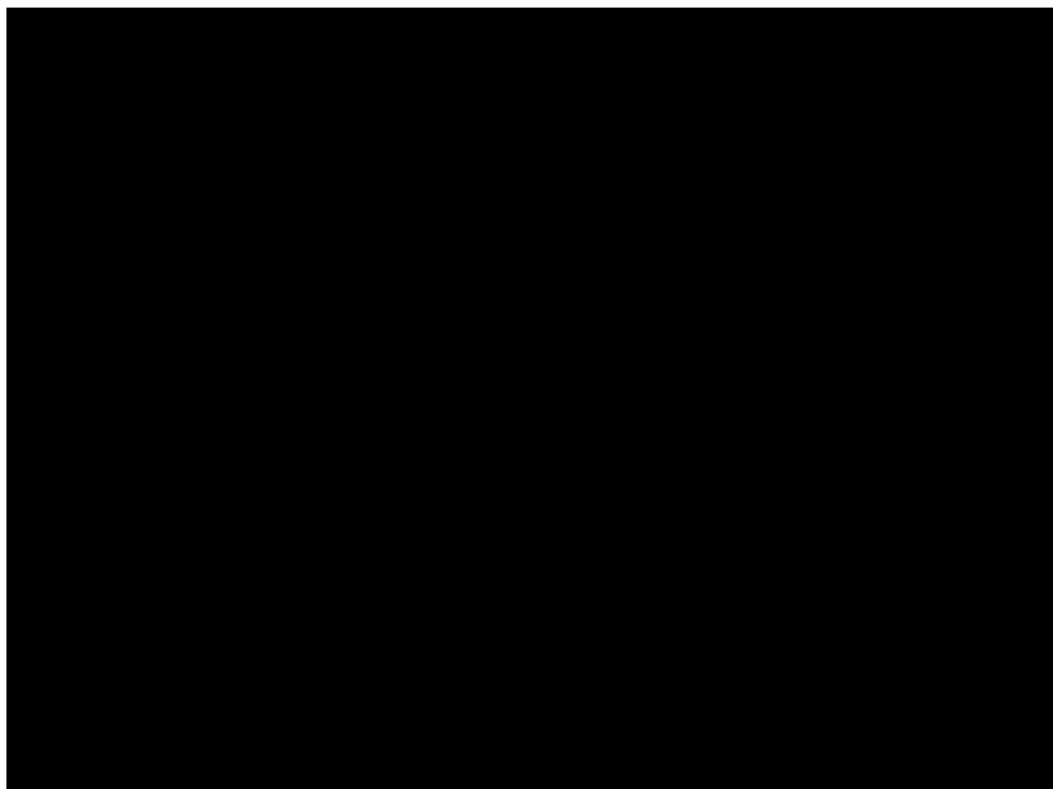

## **Recruitment and appointment of Trustees**

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

## **Governing Document**

The Group's governing documents are those of the Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Scout Association and the Policy, Organisation and Rules of the Scout Association. The Group is a charitable unincorporated association and the purposes and administration arrangements are set out in our constitution.

## **Trustee Recruitment and Appointment**

Trustees are appointed annually at the group AGM from the parents and leaders.

## **Charitable purposes**

The objectives of the Group are as a unit of the Scout Association. The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible

citizens and as members of their local national and international communities. The method of achieving the aim of the Scout Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

## **Activities and achievements**

The Group operates a Squirrel Drey, Beaver Colony, Cub Pack and Scout Troop. All sections ran a range of activities during the year, covering all aspects of the scouting 'balanced programme'. The main activities and achievements of the Group in the year are described on the following pages.

## **Reserves**

The Group's constitution requires the Trustees to maintain and manage a reserves policy for the Group (including a plan for use of reserves outside of the minimum). Total reserves of £6,495.89 were available for general use by the Group at the end of the year. These funds are held in the Group's bank accounts. There are no outstanding payments.


## **Funds**

All the Group's funds are unrestricted. The Group showed a deficit of -£8,481.14 for the year. The deficit reflects expenditure of money raised for the Scout trip to Kandersteg, Switzerland in July 2024 which was carried forward as a surplus from the previous financial year.

**Independent Examiner's Report to the Trustees of the 19<sup>th</sup> Pentland Scout Group**

I report on the financial statements of the 19<sup>th</sup> Pentland Scout Group ('the Group') for the year ended 31<sup>st</sup> March, 2025 which are set out on the following pages.

**Respective responsibilities of Trustees and Examiner**

The Group's Trustees are responsible for the preparation of the accounts in accordance with the Charities and Trustee Investment (Scotland) Act 2005 ('the Act') and the Charities Accounts (Scotland) Regulations ('the Regulations'). The Group's Trustees consider that the audit requirement of Regulation 10 (1)(d) does not apply. It is my responsibility to examine the accounts as required under Section 44 (1) (d) of the Act and to state whether particular matters have come to my attention.

**Basis of Independent Examiner's Statement**

My examination is carried out in accordance with the Regulations. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

We started with 6 Squirrels and 3 adult volunteers and we have grown steadily to 12 Squirrels and 4 adult volunteers and 2 Young Leaders.

We have worked on the squirrel activity and challenge badges with some really exciting sessions lead by our volunteers. # SCOUT SECTION

## A year in Scouting

This past year has been an incredible journey for our scout group, we have some amazing highlights to share! Last summer (2024) was particularly memorable, as our scouts had an incredible adventure at Kandersteg International Scout Centre. The experience was filled with laughter, learning, and a bit of mischief, creating fantastic memories that will be cherished by all. Other highlights include Adventure Camp 24, which presented opportunities for outdoor adventures, teamwork, and resilience. Furthermore, events such as the Canal Festival, Night Hikes, and various practical sessions including kayaking and paddleboarding, backwoods cooking, engineering and STEM based challenges.

We also experienced some changes in our leadership team. [REDACTED] who has been a fantastic Scout Team Leader for three years (following two years as a Cub Section Assistant), is off on a new adventure as the District Explorer Young Leader Unit Leader. We have thanked [REDACTED] for her dedicated service and the many moments of fun she brought to our group. Additionally, we said goodbye to [REDACTED] who moved out of the Pentland district and is now scouting in Kelso. Both of them have left a big mark on our scouting community. The role of Scout Team Leader has been taken over by [REDACTED] who are working with the team to deliver adventure, fun, and, skills for life, and we have welcomed [REDACTED] to the Scout section team as a team member

Our past year's programme has encompassed a variety of themes that contributed to the development and engagement of the Scouts. Key topics included teamwork, preparation for camps and hikes, as well as a focus on skill-building activities such as cooking, navigation, and, cycling. Meetings were also dedicated to promoting Scouting, discussing upcoming events, and fostering leadership through team leadership and planning forum sessions – helping to keep the section firmly Youth Lead. Additionally, several events were planned to enhance community outreach and environmental awareness.

Looking at the stats it was truly an incredible year;

- 4 Chief Scout Awards awarded – these are the highest award available in the Scout section and a great testament to the Scouts involved – with many more on the way
- 220 total badges
- 17 nights away have been offered.
- We have 24 scouts (which is our maximum capacity)

  - o 6 x 12 yrs
  - o 7 x 13 yrs

Looking to the future, we've got exciting plans on the horizon, and new ways for our scouts to develop valuable skills through our engaging programme focused on Skills for Life. Plus, we'll be kicking off more fundraising activities to support our adventures.

The section's spirit remains strong, and the enthusiasm from our volunteers keeps our group vibrant.

We want to extend a heartfelt thank you to our scouts for their energy and joy, which makes our work so rewarding as leaders. Lastly, thank you to the parents for your unwavering support and to all the behind-the-scenes volunteers who keep our group running. Here's to another adventurous year ahead in scouting!

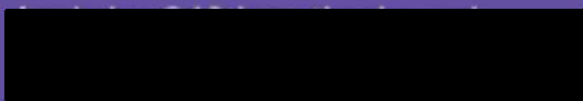
