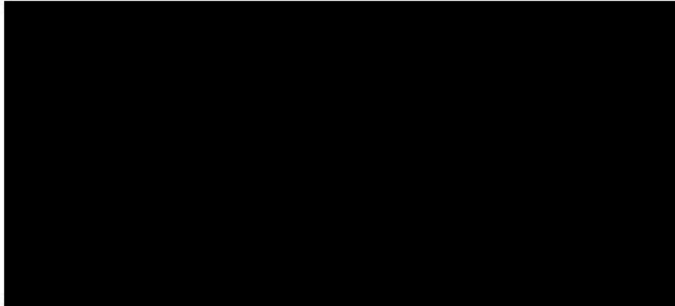

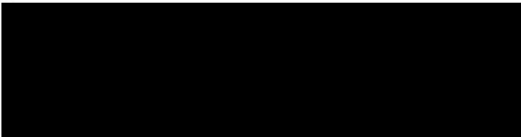

Report of the Trustees

The Trustees of DOUGLAS COMMUNITY SPACES GROUP hereby submit their report and accounts for the legal year ended 31st March 2025

Legal and Administrative Information

Douglas Community Spaces Group is a registered charity (number SC043807) in Scotland. The charity is a Scottish Charitable Incorporated Organisation (SCIO) and is governed by its constitution.

Structure, Governance and Management

The structure of the organisation consists of the charity trustees who are also the organisations only members and comprise the organisation board.

A written application must be submitted to the board for any individual or body wishing to become a trustee and the application will be considered by the board. The minimum number of trustees is three with the maximum number of trustees being twelve. Trustees must retire from office at the AGM and are eligible to re-election. There is currently no formal induction and training programme for new trustees

Charitable Purposes

The objects of the charity's constitution are:

To advance environmental protection or improvement

To advance public participation in sport

To advance community development

Identify opportunities for improvement and development of green and open spaces

Acquiring and /or manage the development of green and open spaces

Promoting access to and responsible use / development of green and open spaces

Providing opportunities to learn about the environment and its conservation through the provision of wildlife-friendly spaces

Providing opportunities to gain skills in gardening and the production of healthy food by establishing community garden(s)

Promoting mental and physical well-being by providing space to allow residents to have contact with nature in green space near their homes

With the support of sports development workers and local sports clubs, encouraging participation in outdoor sport and activities by all ages by providing 'come and try' opportunities

Promoting participants and community spirit by providing and maintaining venues for open-air community events and celebrations, and by organising programmes of such events

Offering opportunities for local people to volunteer in working towards development of green and open spaces for the benefit of the community

Promoting the regeneration of the East End Ward by working with local agencies to improve the physical environment in the area

Activities and Achievements

Governance: -

DCSG continues to hold monthly meetings where finance and business matters are discussed, and any issues addressed.

Physical projects / Activities: -

Douglas Community Park is now an established space which local people and visitors use daily. Children, young people and adults use the space for recreation, play, sport and meeting up.

Over the last 3 years DCSG, often in partnership with other partners, have hosted many activities. Weekly programmes and maintenance are organised. DCSG work with the local management group to deliver free activities helping local people who are struggling with the cost of living.

Nationally, Douglas Community Park, in partnership with Scottish Water, has been recognised at Scottish Government level and has been included as a case study of partnership working to deliver multiple benefits in the Scottish Government's new Flood resilience Strategy

Challenges

- Board members recognise that they need to attract more volunteers to take their ambitious programme forward. Work has started to establish links and partnerships.
- Due to the cost-of-living crisis and challenging public sector budgets, Trustee volunteers (who all belong to a number of other groups) find their capacity to undertake training and wider activity development is becoming more restricted as attention is focussed on delivering free and low cost activities.
- DCSG have received their final years funding from the National Lottery. Future funding will be required to allow for a sustainable transition.

Trustee remuneration and Expenses

The Trustees are not remunerated nor were they reimbursed for any personal outlays

Financial Review

The results for the year are set out on the attached accounts. There is no formal reserves policy in place yet.

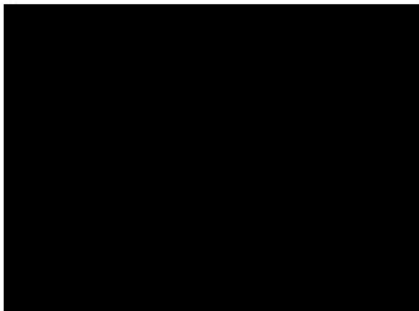
Independent examiner's statement

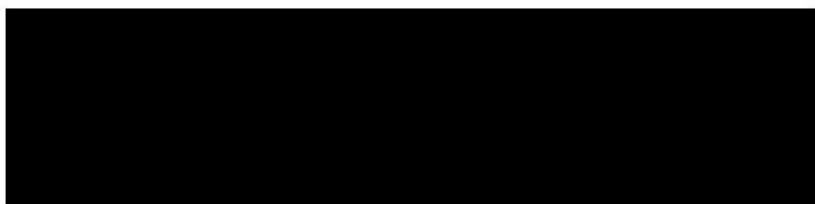
