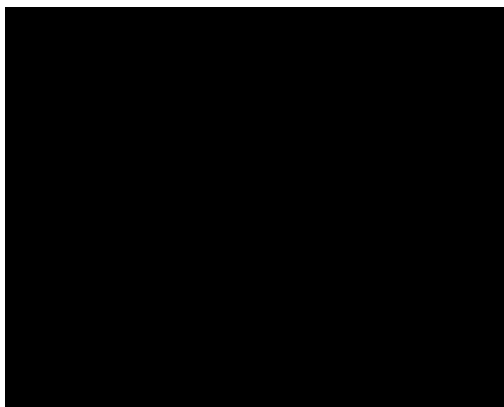

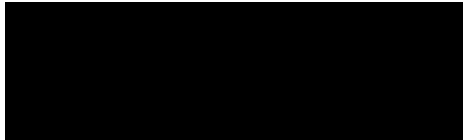

West Lothian Artistic Gymnastics Club continue to work together to drive our vision and ambitions and live and breathe our values.

Young people are at the heart of everything we do at West Lothian Artistic Gymnastics Club, and it is our people that make the difference.

Progression

This has been a successful year for our gymnasts, coaches, and the club and a period of change. Our team of coaches, gymnasts, parents, carers board and partners continue to work together to create a high performing and fun environment where our children, young people and families feel safe, have fun, and develop their skills and aspirations through gymnastics.

Our coaches and management team have planned and programmed the classes and training environments over the last 12 months to ensure every child, young person and gymnast has the best possible experience irrespective of their ambitions. Whether they are here for fun, socialising or to compete for their club or country. Our membership has stabilised with over six hundred members this year with all classes and training programmes delivered face to face. Gymnastics is an exciting sport for everyone, and we have continued to attract new children, young people and gymnasts whilst maintaining our core membership. We have a high performing team, and I would like to take this opportunity to thank them for everything they do, their hard work, commitment, and loyalty, including that extra mile, which is not always about teaching or coaching gymnastics.

This has been a year of change for the club with several key staff moving on to other positions within and out with the sport. We would like to take this opportunity to thank [REDACTED] for their dedication and commitment to the club over many years and wish them every success in their new roles and careers. The club will miss you both.

OUR PEOPLE

Gymnasts

2022-2023 has been a fantastic year for our gymnasts at all levels, including preschool, novice, recreational, intermediate, and competitive. Fun, improvement, new skills, and great performances have been the focus throughout the year.

The club have achieved impressive results throughout the season, and we have watched our children, young people and gymnasts progress through the grades and achieve success at local, Scottish, British, and international level.

This year we have had nine gymnasts selected onto the MAG/WAG Performance Pathway Programme and three gymnasts selected onto the National Performance Programme.

This year 2 of our gymnasts [REDACTED] selected to represent Scotland at the Northern Europeans Championships in Sweden. A successful trip for our gymnasts, staff, and Scotland.

[REDACTED] also successfully gained selection to the GB Squad. This is an amazing achievement for [REDACTED] and the only Scottish based senior male athlete to achieve a placing in the GB squad. Cameron also represented GB at 3 World Challenge Cup events in Stuttgart, Tel Aviv, and Turkey. He successfully won silver medal on floor at Turkey. Congratulations to [REDACTED] This year again [REDACTED] competed in the Scottish and British disability championships.

Congratulations to everyone on their successes, this reflects the quality and commitment of our gymnasts, coaching and management team.

Coaching / Management Team

Our coaching and management team are exceptional and are fully committed to the club, gymnasts and making a difference.

[REDACTED] leads our coaching team, and we continue to operate with five full time coaches and twenty part time/bank coaches. The team provide quality coaching and leadership daily to all the children and young people in our club to make them confident individuals, successful learners, responsible citizens, effective contributors, and amazing gymnasts.

[REDACTED] previous club manager has continued to support us with our governance and financial planning, policies, and procedures. Big thanks to [REDACTED] for her continued support and guidance.

The team have worked closely throughout the year on planning and programming takes to ensure our children, young people and gymnasts are well prepared and ready to make that next step whether it is from pre-school to novice or recreational to competitive. The club offers an exciting pathway to allow our gymnast to fulfil their ambitions and dreams within the sport.

Our coaching and management team ethos is ensuring all gymnasts are supported and nurtured as individuals, both mentally and physically, encouraging them to develop in their own time to their best potential, ensuring their wellbeing is at the forefront.

We have a strong commitment to developing and nurturing the coaching team and to ensure their wellbeing and development is of foremost importance. Key mentorship workshops are held on a regular basis and are designed to meet the needs of all the coaches and staff. The learning and development of our coaches and workforce is important.

Volunteers

Whilst our professional paid workforce continues to grow, we would not be able to operate as a club, without the dedication and commitment of our volunteers, parents/carers, and families. Many volunteers have provided their time and expertise to help make a difference to the club and the gymnast. Thank you.

In addition to our new Board members, we have formed a new fundraising committee who have been exceptional and have raised over £12,000 for the club. They have organised fun nights, movie nights, discos, bonus balls, raffles. This is such a critical area for the club, and we would like to thank them for all their hard work, enthusiasm, and commitment.

This is an area we will continue to work on, and we would like to encourage more volunteers, parents/ carers to get involved. Every little job counts, and we believe every person has skills and experience to contribute to the club's vision and ambition. Get involved.

Partners

Partnerships are important to us, and we have collaborated closely with many partners this year. Particularly Scottish Gymnastics, British Gymnastics, West Lothian Council, sportscotland, local business, local media and press and most important the local community. This is an area we believe we can expand and develop, and we look forward to future discussions with existing and new partners in the forthcoming year.

Places

As well as the importance of our people we know where we play, train, and compete is a huge area for growth and development. Craigwillow Centre provides a suitable place for us to develop the skills and competencies of our children, young people, and gymnast. However, we know from consultation with our gymnasts, coaches, parents, and volunteers this could be hugely improved. This continues to be an area for future discussion and development.

We continue to operate a community benefit lease with West Lothian Council and recognise this is an area for future discussion and development.

Programmes

Throughout the year we have created strong links and networks to the wider community, we have renewed our club accreditation with West Lothian Council, attend West Lothian Sports Council meetings to network with other sporting groups and share learning and opportunities across the local community. The safeguarding of your children is a priority for the club and Linda Kerr, Child protection officer ensures we create a safe and secure environment for our gymnasts to progress. Our coaches and volunteers support the active school's team with the annual school gymnastics competitions, providing judges and coaches to ensure the event is a success.

We continue to build our relationships with the local courier and press updating them on the successes of all our gymnasts to promote achievements throughout the year.

We continue to market the club in a professional manner and use social media, local press, leaflet drops and attending schools and nurseries to help promote the growth and development of the club.

There never is a dull moment within our planning, programming, and delivery.

Teamwork

I would like to take this opportunity to thank all of you for your ongoing support and commitment to the club. It is exceptional. The club would not survive without your contribution and help, irrespective of your role.

It has been a successful year and I look forward to working with everyone in 2023 to achieve our vision and ambitions.

Risk Management

The Management Committee has conducted a review of the major risks to which the charity is exposed. A risk register has been established and is updated at least annually. Where appropriate, systems or procedures have been established to mitigate the risks the charity faces. Significant external risks to funding have led to the development of a strategic plan which will allow for the diversification of funding and activities. Internal control risks are minimised by the implementation of procedures for authorisation of all transactions and projects. Procedures are in place to ensure compliance with health and safety of staff, volunteers, clients and visitors to the centre. These procedures are periodically reviewed to ensure that they continue to meet the needs of the charity.

Induction and training of new trustees

New trustees are appointed by a majority vote of existing trustees and are familiarised with the workings of the charity and its policies and procedures through an induction process provided by other trustees. On going training and support to the trustees is provided through informal briefings.

Financial review

a. Reserves policy

Total funds at 31 March 2023 amounted to negative £10,870 (2022: positive £19,840), of this £22,669 is restricted and a negative £33,539 is unrestricted. The trustees consider that an appropriate level of reserves to cover timing differences between receipts and payments and to allow for any unexpected items of expenditure should be in the region of 3 months operating costs. At 31 March 2023 the freely available reserves were in deficit by £33,539 and it is the intention of the trustees to work towards increasing the level of these reserves to a level sufficient to cover 3 months operating costs.

b. Going concern

The club continue to seek opportunities to grow their income potential through expansion of gymnastic coaching offered. During 2023 and into 2024, more focus will be placed upon traditional fundraising activities to augment the traditional income streams, providing confidence for the continued operation of the club. See note 1.2.

c. Governing document

The West Lothian Artistic Gymnastics Club is a Scottish Charitable Incorporated Organisation, incorporated on 10 April 2013 and is governed by its constitution.

The West Lothian Artistic Gymnastics Club is a registered charity with the Office of the Scottish Charity Regulator and recognised as a charity by H.M Revenue & Customs.

The structure of the organisation consists of a board, who hold regular meetings, and generally control the activities of the organisation; for example, the board is responsible for monitoring and controlling the financial position of the organisation.

The people serving on the board are referred to in the constitution as Charity Trustees, and they are also the members of the organisation for the purposes of the Charities and Trustee Investment (Scotland) Act 2005.

The charity's trustees consider that the audit requirement of Regulation 10(1)(d) of the 2006 Regulations does not apply. It is my responsibility to examine the accounts under section (44)(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently I do not express an audit opinion on the view given by the accounts.

1 Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) (Charities SORP (FRS 102)) and the Charities and Trustee Investment (Scotland) Act 2005.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following Accounting and Reporting by Charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005, which has since been withdrawn.

West Lothian Artistic Gymnastics Club SCIO meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy. The accounts are prepared in GBP, being the functional currency, rounded to the nearest Pound.

1.2 Going Concern

Total funds at 31 March 2023 amounted to a deficit of £10,870 (2022 - surplus of £19,840). Included within total funds were general reserves in deficit by £33,539 (2022 - £15,582). The deficit in reserves at the year end reflects the impact of Covid on the club during 2022/23. Since March 2023 and into March 2024 the club has restructured and reduced salary costs, as well as seeking new opportunities to grow their income potential through the expansion of gymnastic coaching such as additional programming of classes and more access throughout the year to school holiday camps. Focus has been placed on traditional fundraising during the year and in December 2023 we secured a loan of £60,000 to help stabilise and expand the club and in March 2024 the charity has approximately £95,000 of cash available. The measures taken by the club provide confidence to the Trustees of the operation of the club in the next 12-18 months. Given the actions that the trustees have taken, they believe that whilst there is uncertainty, this does not pose a material uncertainty on the charity's ability to continue as a going concern. The trustees therefore believe that it is appropriate to prepare the accounts on a going concern basis.

1.3 Legal Status

West Lothian Artistic Gymnastics Club is a Scottish Charitable Incorporated Organisation and domiciled in Scotland.

1.4 Fund Accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

1.5 Income

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably. Government grants are recognised when it is reasonable to expect that the grants will be received and that all related conditions will be met usually on submission of a valid claim for payment.

1.6 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity.

Support costs are those costs incurred directly in support of expenditure on the objects of the charity.

Charitable activities and Governance costs are costs incurred on the charity's operations, including support costs and costs relating to the governance of the charity apportioned to charitable activities.

1.7 Tangible fixed assets and depreciation

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of financial activities incorporating income and expenditure account.

Tangible fixed assets are carried at cost, net of depreciation and any provision for impairment.

Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

1.8 Leasing and hire purchase

Assets obtained under hire purchase contracts and finance leases are capitalised as tangible fixed assets. Assets acquired by finance lease are depreciated over the shorter of the lease term and their useful lives. Assets acquired by hire purchase are depreciated over their useful lives. Finance leases are those where substantially all of the benefits and risks of ownership are assumed by the charity. Obligations under such agreements are included in creditors net of the finance charge allocated to future periods. The finance element of the rental payment is charged to the Statement of financial activities incorporating income and expenditure account so as to produce a constant periodic rate of charge on the net obligation outstanding in each period.

1.9 Stocks

Stocks are valued at the lower of cost and net realisable value after making due allowance for obsolete and slow moving stocks. Cost includes all direct costs and an appropriate proportion of fixed and variable overheads.

1.10 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.11 Cash at Bank and in hand

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.12 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the charity anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.
