The Academy Project (T.A.P) is a Scottish Charitable Incorporated Organisation and is governed by its constitution. The charity is managed by a committee of trustees consisting on 11 officers: President, vice-president, treasurer, secretary, assistant secretary, and four committee members.

Trustee recruitment and appointment

All officers and committee trustees are appointed by the membership at the annual general meeting. All retire annually except the secretary, assistant secretary and treasurer may serve a maximum of three consecutive years in the same post. All members of at least one year's standing are eligible to be nominated for the committee of trustees. Trustees who have served on the committee for at least one year are eligible to be nominated for the post of president.
