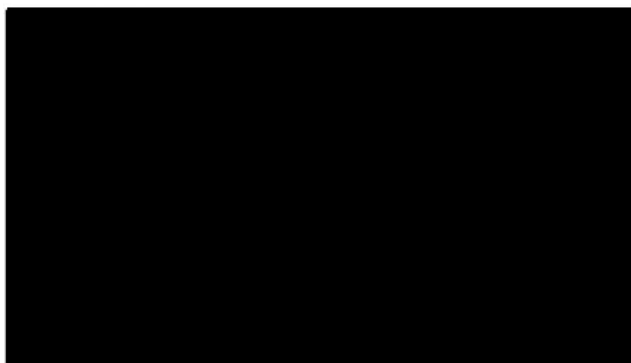
TRUSTEES' AND MEMBERS' REPORT FOR THE YEAR ENDED 31 OCTOBER 2024

The trustees present their report and accounts for the year ended 31 October 2024.

Type of governing document

The charity is an unincorporated association governed by a written constitution. Friends of the Neuro Ward is registered with the Office of the Scottish Charity Regulator no. SC044430. The contact address is: [REDACTED]

Current trustees



Trustee recruitment and appointment

Trustees are appointed in general meeting. Appropriate training and induction is provided to new trustees in the aims, objectives and procedures of the charity.

Charitable purposes

The charity's object is the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage.

Summary of the main activities in relation to these objects

Fundraising / Donations:

23/24 was a strong year for us, both through our own fundraising efforts and that of our supporters. We also made good progress in continuing to raise the profile of Friends of the Neuro Ward.

Most notably, we celebrated the 10th anniversary of the charity by hosting a fundraising dinner dance, The Diamond Ball on 3 November 2023.

Guests included supporters and fundraisers, and sponsors from Aberdeen's business community – whose generosity allowed us to invite 30 staff from across Wards 204, 205 and the Neuro Rehab Unit to attend free of charge, ensuring they were part of the celebrations.

The night included a raffle & auction, with all prizes generously donated, bringing our grand total to **£29,298.73**.

Organised Events

Organised fundraising activities through 2024 included the Aberdeen Kiltwalk, which attracted 19 walkers who raised £8,163.

Once again, we had our biggest fundraising turn-out for The Beast Race – a highly popular muddy obstacle course that takes place in September every year. We sold out of our 50 spaces very quickly, and after excluding the entry fees, our fundraising total for this event was **£14,396**. Due to its ongoing popularity, we have booked (and sold out) of a further 50 spaces for the 2025 event.

We also had two riders take on Ride the North, a large cycling event in Angus in August 2024. They raised a total of **£500** for us.

Individual fundraising

Our largest independent fundraising effort came from five dads in Banchory, who took on an Ultramarathon challenge for Friends of the Neuro Ward, Horizons & a medical centre in Brisbane. Not only did they raise an incredible **£5,407** for each cause, but they also did a brilliant job of raising awareness of our work. They shared their very emotive story in the local press and shared their ultramarathon efforts on socials (including as they ran through the night). The family who inspired the challenge are now keen to help us spend the money in NRU, and we will work with them and staff to ensure it's put to suitable use.

We also had two people take on Run Garioch (**£2,289**), a former patient taking on the London Marathon (**£1,628**), a patient's sister & friend completing the Strathclyde Half Marathon (**£1,820**) and a former patient's daughter doing the Edinburgh Marathon (**£658**) and a family climbing Bannachie (**£2,000**).

A team from a local PT class nominated Friends of the Neuro Ward & Chest Heart and Stroke Scotland to benefit from their fundraising, and they took part in the Kiltwalk and MacTuff (another muddy obstacle course) for us – splitting their effort. We received **£1,074.75** from the group.

We've also gratefully received patient donations from the ward and a small number of funeral donations.

Corporate

We received a standalone donation of £4,000 from Peterson, who named us their charity of the year.

As ever, we are actively encouraging staff to come to us with requests from equipments/upgrades/support and have noticed an uptake in this.

The results are set out on page 5. There was a net deficit for the year of £66,456. The bank and cash balances at 31 October 2024 totalled £325,613.

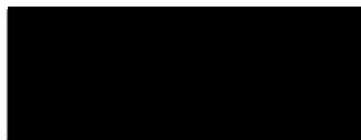
Reserves policy

Risk factors

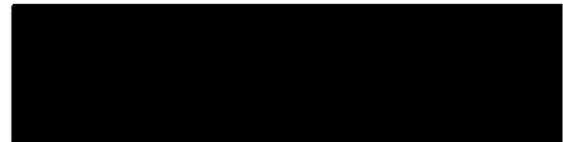
The trustees have assessed the major risks to which the charity is exposed and are satisfied that systems are in place to mitigate exposure to the major risks.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF FRIENDS OF THE NEURO WARD

Basis of independent examiner's statement

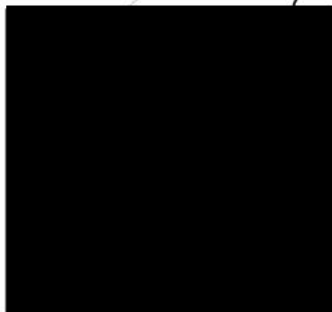

1 Basis of accounting

These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended)

2 Nature and purpose of funds

Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. The trustees maintain a single unrestricted fund for the day to day running of the charity.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes.
