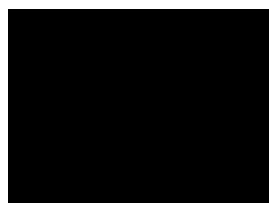
0	<u>February:</u>	Replacing tree protectors in the NW woodland as they were outgrowing the spirals. Weeding and mulching willow trees in Market Garden Pruning fruit trees in orchard.
0	<u>March:</u>	Pruning fruit trees in orchard.
1	<u>April:</u>	The wire tree protectors in the orchard were proving unsuitable as they prevented lateral growth. They still needed deer protection, so new enclosures were designed and built. Stone fruit pruning. Planting a memorial apple tree for [REDACTED] Tree care at The Knock, cut back [REDACTED]
0	<u>May:</u>	Finished building 65 new orchard enclosures. Trimming grass.
0	<u>July:</u>	Repairing extensive storm damage in the woodland. The unusually high summer winds while there was a lot of leaves on the trees caused tree protectors to bend in half and almost flattening many trees.
0	<u>August:</u>	First apple harvest in the orchard. Tree care in the hedgerow.
0	<u>September:</u>	Weeding and mulching shelter belts in Market Garden.
0	<u>October:</u>	Weeding and mulching agroforestry strips in Market Garden. Tree care planning / review meeting.
1	<u>December:</u>	Weeding and mulching orchard and allotment fence trees. Planted a Dawn Redwood tree.
