Its purposes include prevention, relief of poverty, advancement of citizenship and community development. Through its purposes the charity provides for and establishes an environment through which disadvantaged men, women, youth and children are empowered. These groups are empowered by being properly identified and engaged to utilize available resources for their own benefit, that of the Glasgow (Castlemilk, Rutherglen , Govan) Community and its surrounding areas as well as for the sustainable development of the community at large.

Objectives: The Mission of Glasgow Living Waters Church International is 'spearheading revival and building and inspiring lives' through the Christian gospel, tampered with joyful praise and the love of God. Trustee recruitment and appointment

The structure of the organisation consists of the CHARITY TRUSTEES who are also the organisation's members and comprise the organisation's BOARD OF TRUSTEES.

Mental health awareness sessions were held through out the year , on a quarterly basis .These sessions were held by highly qualified Counsellors and mostly through Zoom meetings.

One of our themes as well that we aim to continue till next year is the importance of taking care of our environment and therefore we were able to some activities geared towards that theme , such as cutting grass within our property , litter picking within our community.

The Organisation also held soup kitchen sessions , they was also distribution of emergency food to households and any other basic necessities required to vulnerable families and individuals.

Other optional information

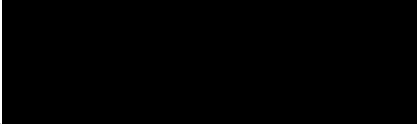
