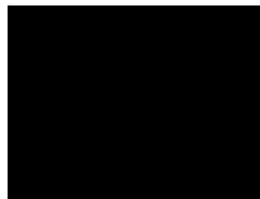

STRUCTURE, GOVERNANCE AND MANAGEMENT

GOVERNANCE

The governing document of the charity is the Constitution of the Silver Rock Foundation (SCIO). The Foundation became a charity on 31 December 2013.

STRUCTURE

The structure, incorporated in the Silver Rock Foundation (SCIO) constitution, consists of a Board of Charity Trustees.

RECRUITMENT AND APPOINTMENT OF TRUSTEES

At each AGM all of the trustees must retire from office but may offer themselves for re-election. For new trustees there is an induction process to ensure they are familiar with and understand the charity's governing document.

OBJECTS OF THE CHARITY

The principal objects are -

- (i) the relief of those in need by reason of ill-health, disability or other disadvantage.
- (ii) the advancement of education, arts, heritage and culture for children and young people in particular in the performing and creative arts.

ACHIEVEMENTS AND PERFORMANCE

The charity had a relatively quiet year but planning continued for future projects.

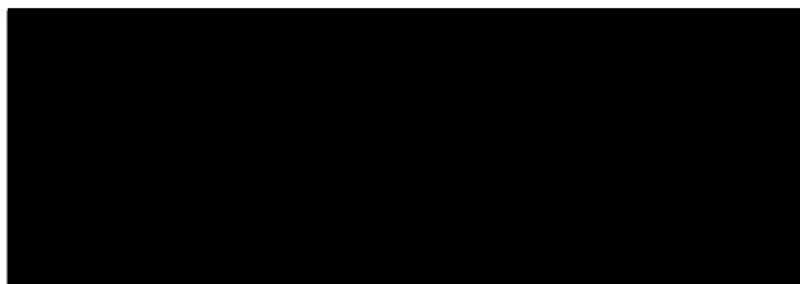
The charity assisted a number of local organisations, mainly involving young people.

Independent Examiner's Report to the Trustees of Silver Rock Foundation (SCIO)

I report on the accounts of the charity for the year ended 31 December 2024.
which are set out on pages 4 to 6.

Respective responsibilities of trustees and examiner

The charity's trustees (who are also the directors of the company for the purposes of charity law) are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1)(a) to (c) of the 2006 Accounts Regulations do not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement

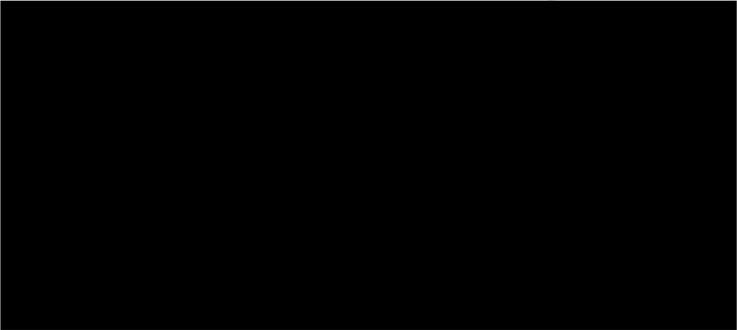
