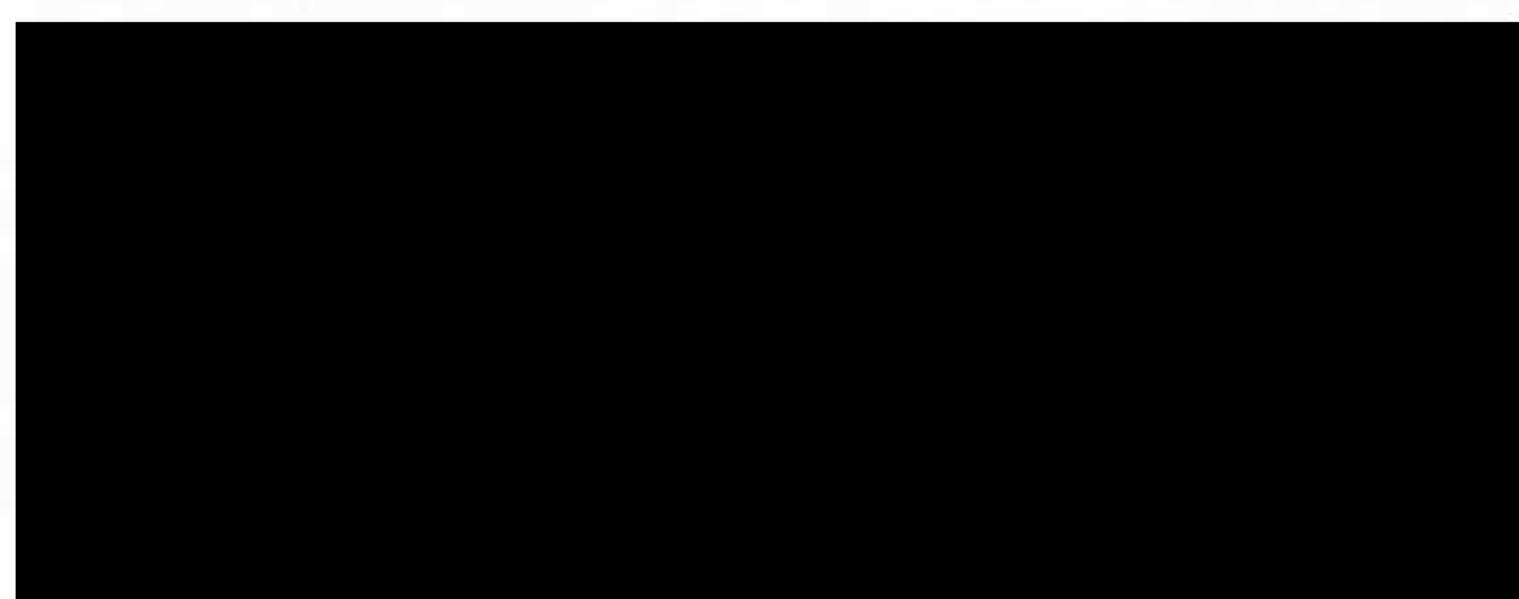


## Funding

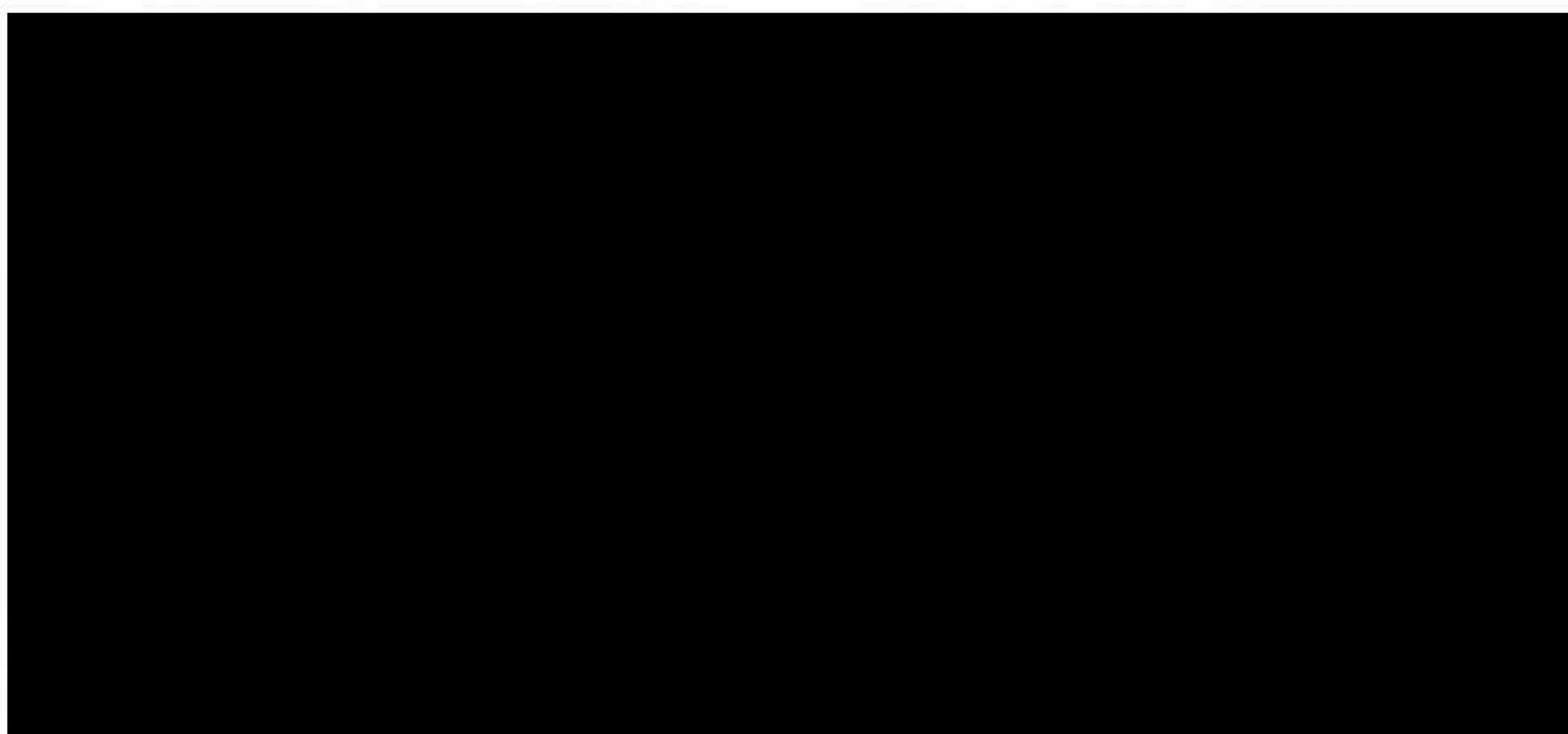
## Independent Examiners Report
