## **DRUMPELLIER CHRISTIAN FELLOWSHIP**

### **REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 MAY 2025**

The trustees present their report and the financial statements for the year ending 31st May 2025. The financial statements comply with the Charities and Trustee (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Accounting and Reporting by Charities : Statement of Recommended Practice.

#### **OBJECTIVES AND ACTIVITIES**

##### **Objectives and aims**

To worship God the Father, to honour the name of his well beloved Son, the Lord Jesus Christ, our Saviour and only Mediator. To obey the Holy Spirit, our guide and teacher. To edify, build up and strengthen each other as members of Christ's body, by his truth as revealed in the Holy Scriptures. To promote Christ's kingdom by holding Evangelistic, Outreach and Prayer meetings

#### **ACHIEVEMENT AND PERFORMANCE**

The Fellowship has now completed its twelve year as a church. Our stated aim was to be obedient to the word of God by gaining knowledge and understanding to allow us to act on the word and bring the gospel message to the community.

This year has been a sad time for us with four of our members passing away, however we give thanks for their service to the fellowship and know that they have gone home to their heavenly Father. One couple have left us choosing to worship in another church and one family has left us to take up a pastoral role in a church in Bellshill. We have been blessed to see growth in numbers attending with four new families now worshipping with us.

##### **Services**

We have maintained our regular programme of services with our Sunday Morning Service focusing on worship and the preaching of the word. Our main focus has been on 2 Samuel following on from last year's study in 1 Samuel concentrating on the life of David learning lessons from his example in following God.

With the exception of the summer months our Evening services continued on the first and third Sunday evenings of the month with guest speakers being drawn from a number of local churches and groups. These services attract attendance from the community.

At our Bible Study on Thursday evenings we spent some time looking at the life of Elijah followed by a study in Paul's letter to the Hebrews.

Prayer remains a priority for the fellowship with prayer meetings being held on a Thursday evening and Saturday mornings with the Elders meeting on a Wednesday morning to pray for the work of the fellowship.

A Christianity Explored course was held with five people involved at some stage in the course with two people completing the course and now worshipping with us.

##### **Children's Work**

This year saw the re-establishment of the Sunday School. We now have a group committed to teaching children and have a core group of four children who attend every week. We have maintained our presence in Townhead Primary School participating in the monthly School Assemblies and working alongside Scripture Union and their Bible Alive Initiative. A drama Group funded by the Coatbridge Churches performed in Townhead and Langloan Schools and were greatly appreciated by the staff and pupils.

##### **Care for the elderly**

We are now into our third year of holding weekly services in Deanston Care Home for a number of residents and their family members who can no longer attend church. This remains well attended and has led us to develop closer relationships with some of the elderly folks and sadly being invited to officiate at funerals.

##### **Community Engagement**

The Food bank has remained open again this year with the faithful donations of food and money from the Fellowship, Tesco Fair Share and the wider community. St Ambrose, St Bartholomew's and Townhead Primary Schools have all made large donations this year which are greatly appreciated. The café area with tea and coffee gives us the opportunity to get better acquainted with those who attend and we have developed a closer relationship with many who come in.

The "Help to Hope" Initiative with its drop in café approach provides a regular place for individuals in the community to get together for a chat. This has been maintained this year and although the attendance is not massive it provides an opportunity to meet with the community both on the street and in the café.

We have retained contact with two agencies the "Overdose Response Team" and "Teen Challenge" who provide professional advice to support those with addiction issues. Routes to work returned this year for a short period and intend to work at times in the area over the next few years.

##### **Building Fabric**

We continue to try to enhance the appearance of the building and this year we have completed work to install new cladding, fascia and guttering and have painted the external walls. New signage has been provided.

Internally the corridor has been decorated.

The boundary wall was in a state of disrepair and became dangerous, as this was a party wall with our adjoining neighbour this work was carried out under the direction of Cairn Housing Association with costs shared.

##### **Bargeddie**

The church in Bargeddie is now in its third year with two church groups continuing to meet and worship there. Lanarkshire Christian Fellowship a Christian Group of India people hold two services one in their own language and one in English in the morning and in the afternoon Bargeddie Christian Fellowship meets with a group of local people attending. This fellowship is slowly growing and developing. We continue to provide support services until they are fully developed and constituted able to be fully independent.

##### **Mission and Giving**

A monthly mission offering has been established to support churches overseas. We continue to support a church in Lahore Pakistan to give food to Christians living in poverty due to their faith. In India we support a monthly woman's conference helping to provide resources.

We continue to tithe a tenth of our monthly income to other charities and agencies in the last year these have included the Moira Anderson Foundation, Tearfund, Airdrie Hospice, Be Strong, Scripture Union, Earl Haig Fund, Glasgow City Mission, Samaritan's Purse, Barnabus Fund and a new Fellowship in Ballasalla Isle of Man.

##### **Outreach**

This year we have continued to reach out to the community through our established initiatives and praise God for the doors that are open to us. We are developing closer relationships with individuals and with the community and participate when we can with the Tenants and Residents group that has been re-established. Our aim is always to be available to people to meet practical needs but also to bring hope in the form of the good news of the Gospel.

This year we appointed an Outreach Coordinator to motivate the congregation to spread the gospel in their own area and circle of friends. We continue to make resources available to support this work. Leafletting has been ongoing throughout the year in Airdrie, Coatbridge, Glenboig and Cumbernauld.

Our services are live streamed on Facebook and a number of people regularly listen in and worship with us through this medium.

In September we were part of the Coatbridge Churches Fun Day held in West End Park. This was an amazing day with an estimated attendance of 2000 people on the day. Two families came to our fellowship through this event.

The Billy Graham Organisation held a Jesus Loves you tour in the Hydro and we managed to fill a free coach that was supplied by TBGO and take a number of local people to the event.

We are trusting God that he will build his church in Townhead Coatbridge.

The trustees record their thanks to all who have assisted in the various initiatives this year and pray God's blessing on them.

#### **FINANCIAL REVIEW**

##### **Reserves policy**

Our finances remain healthy due to the sacrificial giving of the congregation and we continue to tithe 10% of our offerings to other organisations. Funds are still available from the Council Grant to carry out some structural alterations to improve the use of the premises and assist in the proclaiming of the gospel.

##### **Investment Policy**

The charity does not hold any investments. Any surplus cash flow during the year is deposited in suitable bank accounts.

#### **FUTURE DEVELOPMENTS**

In the last half of the year we have taken the opportunity to prayerfully seek God's leading and we await direction from God on how we are to spread the gospel in Townhead.

We are committed to serving God in this area and understand the need to be led by the Holy Spirit on how best to do this.

The future of our fellowship remains in God's hands and we will continue to remain close to him in prayer to understand his leading.

We continue to trust in God for his leading, guiding and protection in the days ahead.

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing document**

The charity was set up on 13th May 2014 and is a charity registered in Scotland. Our purposes and administration arrangements are set out in our Governing document.

##### **Board Meeting Procedures**

The charities trustees are eligible to be reappointed by the members at our Annual General Meeting, which is held annually, and the minimum number shall be two.

The Trustees regularly review the composition of the board to ensure it comprises the mix of skills required to meet the ongoing needs of the charity.

##### **Taxation**

The charity enjoys charitable status for taxation purposes. The Scottish Charity Number is SC044855

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

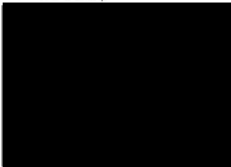

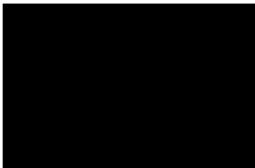

I report on the accounts for the year ended 31 May 2025 set out on pages six to twelve.

**Respective responsibilities of trustees and examiner**

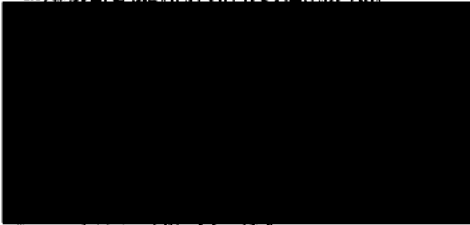

#### **1. ACCOUNTING POLICIES**

##### **Accounting convention**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities and Trustee Investment (Scotland) Act 2005. The financial statements have been prepared under the historical cost convention.

##### **Incoming resources**

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

##### **Resources expended**

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### **Governance costs**

Consists of the costs of the accounts preparation and any other financial services and expenditure incurred in compliance with the legal requirements of the charity.

##### **Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

IT Equipment	33% straight line method
Equipment	25% reducing balance method
Land & Buildings	4% straight line

Any expenditure under £500 is not capitalised.

##### **Taxation**

The charity is exempt from taxation on its charitable activities.
