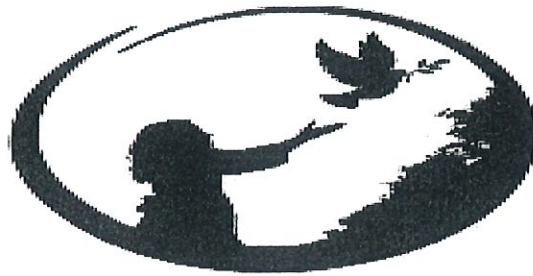

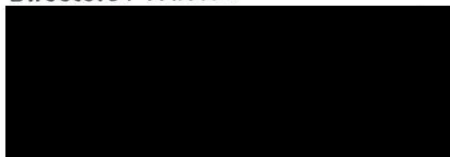

We already have established network throughout the community and will continue to build on them further.

Some achievements and activities:

This year we have continued funding the Rehabilitation Centre and also invested in the growth of our website.

Website Launch Progress

The aim for the website is to generate more donations, raise awareness for the cause and connect with our donors. We have been successful in generating donations consistently throughout the year. We have also been successful in connecting with our donors and other members of the community. So far, we have had many enquiries for future aid trips, Arabic School registrations, and volunteering applications. We will continue to work on the website and add more information regarding previous and future events, appeals and projects.

Rehabilitation Community Centre:

This year we have helped our beneficiaries in the community center by funding £20,000 to help continue running the essential activities of the multi-purpose center.

The first floor provides psychological sessions for the widowed women and the vulnerable children, the second floor provides physiotherapy and speech and language therapy for children affected by the PTSD. The center runs on a daily basis with classes ranging in size between 15 to 20 students. Refreshments are provided as well as training opportunities.

Future activities plan:

The trustees aim to further develop the current services and strive to do the best they can for the beneficiaries. In the future, they will no longer fund rehabilitation center, Individual sponsorships (medical supplies) or orphan sponsors. The trustees hope to generate a sustainable fund by opening a bread making shop.

I report on the accounts of the charity for the year ended 28 February 2025 which are set out on other pages.

RESPECTIVE RESPONSIBILITIES OF TRUSTEES AND EXAMINER

The charity's trustees (who are also the directors for the purposes of company law) are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity's trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility to state, on the basis of my examination as required under section 44(1) (c) of the Act, whether particular matters have come to my attention.

BASIS OF INDEPENDENT EXAMINER'S STATEMENT

My examination is carried out in accordance with the Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently I do not express an audit opinion on the view given by the accounts.

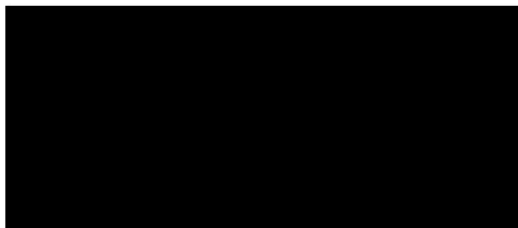
