The members are committed to maintaining the strong brass band local tradition in Dalmellington and are active members of the Scottish Brass Band Association.

In addition, the band will seek to provide entertainment for various audiences and organisations within the area and beyond.

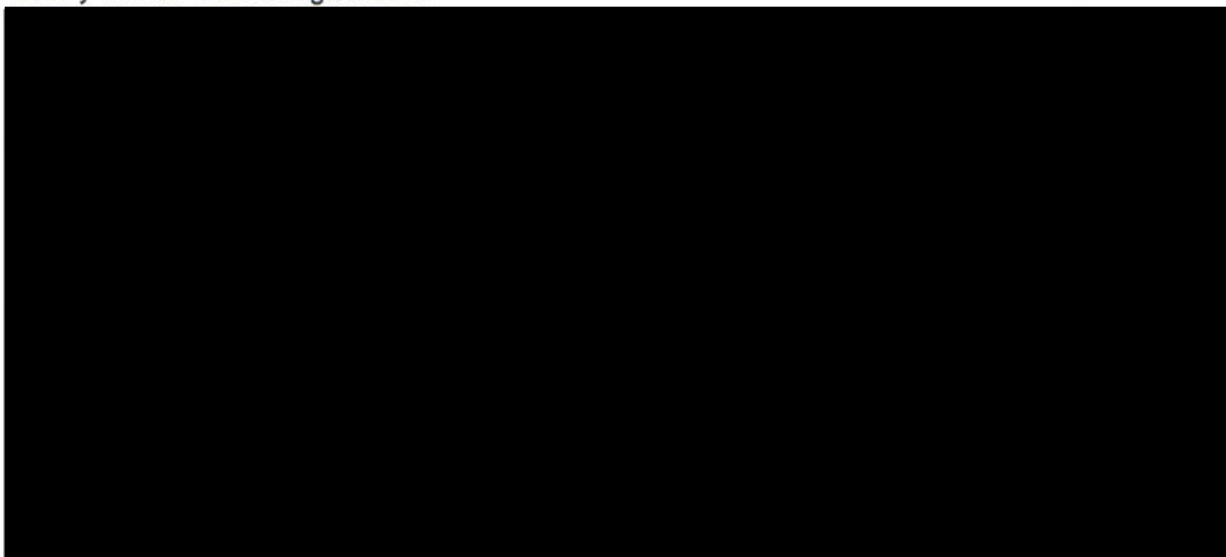
Trustees' Annual Report

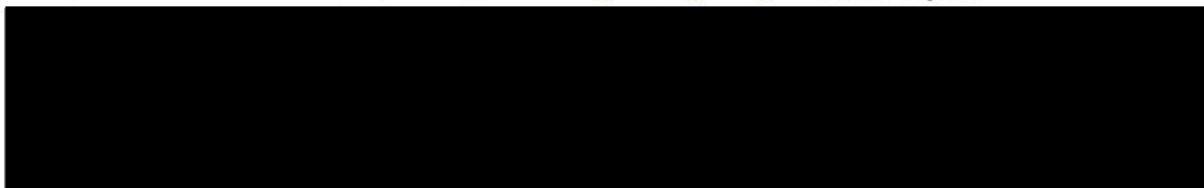

Structure, Governance and Management

Constitution

Dalmellington Band (the Band) is an unincorporated association. It is governed by its constitution which was last amended 30th March 2015. The Band was granted charitable status on 9th March 2015.

Appointment of Trustees and Management

The Office Bearers of the Band Committee, which meets at least 9 times per year, are the Band's Trustees. Office Bearers and Ordinary Members form the Band's Committee. Membership of the Committee is open to all Band members, Parents or Guardians of members of the Band and/or members of the Public elected, or re-elected, at the Annual General Meeting. The Band Committee may invite new members to join the Committee during the year where skills gaps are identified, or resignations have occurred. There can be up to 12 Ordinary members.

The Trustees (Office Bearers) are responsible for the strategic direction and governance of the Band's activities and the full Committee are responsible for executing the decisions of the Committee and day-to-day management of the Band, its members and assets.

Objectives and Activities

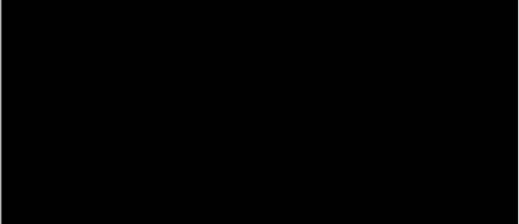
The Band's main objective is to advance local arts and culture by encouraging and promoting tuition for people playing brass and percussion instruments and ensuring the continuation of the brass band founded in Dalmellington in 1864. The Band is a non-profit making organisation, all monies earned are reinvested providing cultural activities, developing musical skills of its members, and providing cultural heritage and entertainment to various audiences in the Doon Valley and beyond.

Financial Review

The net income for 2023 was £27219 and expenditure was £50104. The sources of income are Donations from members and the public £6533, other organisations £1500, the Patrons' Scheme £4085 and Gift Aid claimed from HMRC for donations from previous years. The income from Concerts, Events, Contests, Fund Raising and Sales of Merchandise raised £8281. Income increased due to increased activities of the Band post lockdown restrictions.

The main expenditures of the Band were attending the Scottish Championships in March, the Spring Festival in May, West of Scotland contest in August and the Scottish Open in November. The Brass Academy also attended the Youth Festival in November. The Band also hosted the annual Slow Melody contest and a Brass Academy Workshop in August.

This financial review was approved by the Trustees on 18th March 2024 and is signed on their behalf



Independent Examiner's Report

For the Year ended 31st December 2023

Independent Examiner's Report to the Trustees of the Dalmellington Band

I report on the financial statements of the Dalmellington Band (the charity) for the year ended 31st December 2023, which are set out on pages 5 to 8.

Respective Responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The charity's trustees consider that the audit requirements of Regulation 10(1)(d) of the 2006 Regulations does not apply. It is my responsibility to examine the accounts as required under section (44)(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with regulation 11 of the 2006 Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.

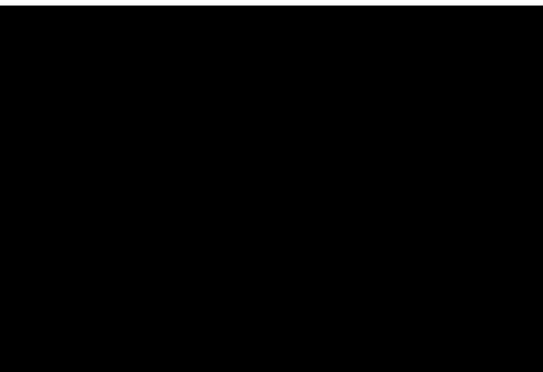
Independent Examiner's Statement

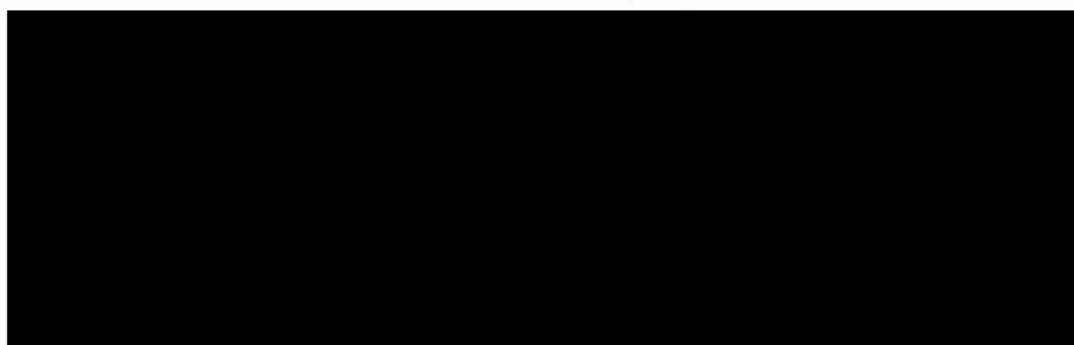

1 Basis of Accounting

2 Nature and purpose of funds

Unrestricted funds are those that may be used at the discretion of the Trustees in the furtherance of the objectives of the Charity (the Band). The Trustees maintain a single unrestricted fund for the day-to-day running of the Band.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes.
