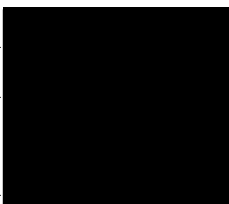

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

As indicated in the last reporting period we initiated discussions with the first of the two bodies selected.

Communication was very difficult because of Covid during the whole year 21/22. It became clear that the owners of the property were reluctant to enter into any form of agreement, either lease or sale, of the land. We had significant support from the residents surrounding the plot of land for development we were proposing. We brought this to the attention of the local Area Committee seeking their help. they wrote to the owners asking them for their agreement to release the land for community use which was rejected.

This initiated discussions with the second of the two bodies who owned a land, this was short lived. A decision had been made for development of the site ruling out any opportunity for HDMS,

The board decided to explore the possibility of establishing a meeting point where we could encourage new members to the shed and find new board members. Registered interest membership stood at 62 at the start of this report period.

It is our intention to keep the development of the shed alive before we consider further action.
