Structure, governance and management

Type of governing document

Constitution. The charity is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its current legal form on 21 May 2015. It has a single tier structure and as such the trustees are the members of the charity.

Trustee recruitment and appointment

According to Clause 17 of the Constitution, the individuals who signed the charity trustee declaration forms which accompanied the application for incorporation of the organisation were deemed to have been appointed by the members as charity trustees with effect from the date of incorporation on 21 May 2015. Membership of the Board of Trustees is open to any born-again Christian called to teach God's Word. At the end of each AGM the Board elects one new trustee and one trustee voluntarily resigns. There must be exactly three (3) trustees. If a trustee resigns prior to the AGM, another volunteer is elected by the remaining trustees.

Objectives and activities

Charitable purposes

To provide religious and educational training in the Bible to adults in Edinburgh and the surrounding area.

Summary of the main activities in relation to these objects

The Charity has not had any activity over the last year. The only other remaining volunteers are myself and one other which is not enough. This Charity is now inactive.

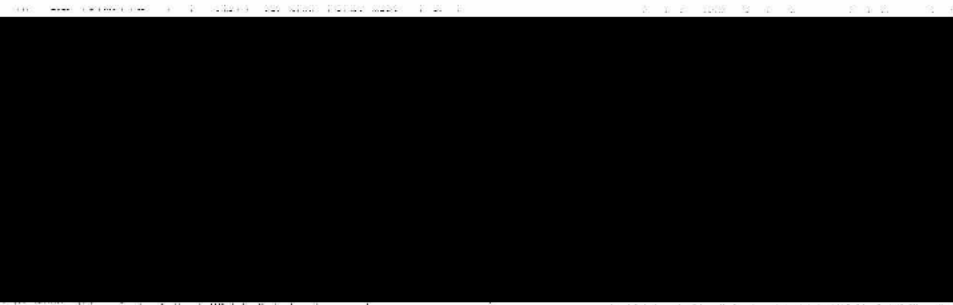
