What the charity does: East of Scotland Jazz Education is set up a) to provide opportunities for the general public to develop skills and confidence in musical performance, particularly but not exclusively in the genre of jazz, and b) to advance the arts through musical education and performance. We do this primarily through running a residential jazz course in Scotland each summer., which is open to players and singers of all ages, abilities and instruments/voices. We offer bursaries for eligible participants of any age who would benefit from attending the course but need financial support in order to be able to do so.

Structure, Governance and Management

Constitution

The Charity is a Scottish Charitable Incorporated Organisation (SCIO) and was registered in its current legal form on 9th June 2015. The charity was previously an unincorporated association but changed its legal form to a SCIO on 9th June 2015. The assets of the unincorporated association were transferred to the SCIO on this date.

Appointment of trustees

The charity operates a single tier structure whereby the charity trustees are also the organisation's only members and comprise the organisation's board. The Board meets up to six times a year. Trustees are appointed at the Annual General Meeting which is normally held in July each year. Under the constitution, there must be a minimum of three and not more than seven elected trustees.

Three new trustees were unanimously elected to the Board on 11th September 2025. [Janer Heffernan](#), James Holland and Alasdair Kelly.

Alison Thomson resigned from the Board on 11th September 2025.

Simon Little was elected Chair of the Board on 22nd September 2025 and James Holland was elected as Secretary on the same date.

Management

The trustees are responsible for the strategic direction and governance of the organisation, whilst day-to-day running is delegated to the administrator, who receives an annual honorarium. The administrator attends the Board meetings to discuss progress and development. We also engage a musical director, tutors and houseparents for the annual Richard Michael Jazz Summer Course. We have a Child Protection policy in place and our staff members have Disclosures under the Protection of Vulnerable Groups (PVG) Scheme.

We have policies and procedures in place for Child Protection & Safeguarding and for grievances. All of our policies and procedures are reviewed and updated regularly and published on our website. Administrators and houseparents attend appropriate training on relevant topics such as first aid and safeguarding.

Objectives and Activities

Charitable purposes

The organisation is established for charitable purposes only, and in particular, the objects are: a) to advance education through providing opportunities for the general public to develop skills in musical performance, particularly but not exclusively in the genre of jazz; and b) to advance the arts through musical education and performance, particularly but not exclusively in the genre of jazz.

Activities

Our main scheduled activity during the reporting year was the Richard Michael Jazz Summer Course, held at Strathallan School in July 2025.

Achievements and Performance

We attracted a good number of participants to our course in July 2025. A total of 77 attended, six more than the previous year.

Financial Review

Our main source of funding continues to be fees charged for attendance at the Jazz Summer Courses, with some additional income from personal donations.

The charity provided grants of £1,201 to three young people to subsidise their attendance at the Jazz Summer Course, £810 of which was funds held in reserve from a 2016 grant by Youth Scotland which was ring-fenced for use of promoting music to young people.

Reserves Policy

The trustees' policy is to maintain minimal reserves at around 2-3 months of normal running costs in order to meet any unexpected expenditure. Reserves at the end of the year were £11,942.25, which is well within the target range.

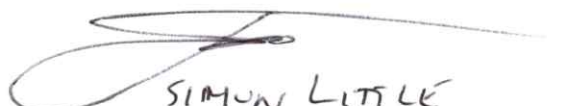
Plans for Future Periods

**Independent Examiner's Report

Independent Examiner's Report to the Trustees of East of Scotland Jazz Education SCIO

I report on the financial statements of the charity for the year ended 31 October 2025, which are set out on pages 5 to 8.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity's trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section (44)(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters.
