Summary of the main achievements of the charity during the financial period	Some highlights of the Year 2024 include the following: • We maintained having virtual and in-person church services. • We maintained the regular fortnightly midweek online services and one Sunday service throughout the year. There was good interaction and good participation during Sunday School classes. Generally, these gave week-long opportunities for brethren to be re-inspired, supported and encouraged. • The Prayer department of the church had their weekly prayer meetings all through the year. The Prayer department also organised two prayer retreats - 8th June and 2nd November. • We now have tracts to distribute during evangelism and prayer outreaches. We had Evangelism and Prayer walks on 8th June and 13th July and distributed Christian tracts/flyers at Inverurie area. • Brethren were also encouraged to attend online Sunday house fellowships started by Fountain of Love Inverurie in collaboration with Fountain of Love Aberdeen. • Increased attendance / engagement at Children and Teen Classes. The Teen choir was also started. • One of our Children Division attendees won Bronze Award at "The Scottish Mathematical Council Mathematical Challenge". • Successful Children & Teens Day out in August 2024 • We thank God for new jobs and graduations. Two children entered secondary school. • The Men's Fellowship held their monthly Prayer fellowship throughout the year during which they prayed extensively for world events – praying the news - and for the brethren. • The Good women's fellowship is still buoyant to the glory of God. • We had fun factory on 9th March 2024, for children from age 5 to 11. • On Saturday, 17th August 2024, we had Summer Barbeque for the community and for the brethren. • On Friday, 2nd August 2024, we had Glorious Tempo – an evangelistic musical outreach programme. The theme was 'Absolute Praise'. [REDACTED] ministered along with RCCG Fountain of Love, Inverurie choir to the glory of God. A few people accepted Jesus and some re-dedicated their lives to Jesus Christ as well.
