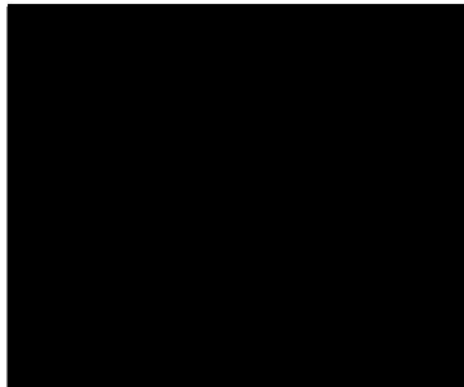

Forfar Open Garden 2024/2025



Purpose

Forfar Open Garden (FOG) charity was set up to provide the Forfar and surrounding area in Angus, with a community garden. Our aim is to positively impact socially isolated individuals, those with a physical, mental health disability, those with special needs or conditions such as neurodiversity and dementia, through involvement in the therapeutic benefits of gardening and nature-based activities. Anyone with a passion for Gardening and supporting those less fortunate are encouraged to get involved.

Chairpersons Report 2024-2025

FOG is a small therapeutic gardening charity, founded 11 years ago by Eleanor Gledhill. Over those years our garden was created, originating from a bare plot of land made freely available by a supporter of the project, and transformed to provide a peaceful and productive garden environment to support our community. Following notice terminating the lease of our current site, the trustees pulled together with our volunteers to form Project Keep FOG to secure a new site, funding and local support for the move and to relocate the garden so we could save our much-loved community garden and grow our services to Forfar and the surrounding area in Angus.



This year has been a year where we have been running Project Keep FOG in parallel with managing and delivering services through our current garden site.

FOG continues to thrive within the community, and this year in May we welcomed the Adult Autism Social Group to the garden who now meet with us every Friday. Visiting groups have included U3A (a local women's support group), Arbroath Flower Club, Forfar Horticultural Society, Kilry Gardening Club as well as the local Guide and Scout groups. We are delighted to continue to support regular visits from local primary schools, nurseries, care homes, a home-schooling group and the Change Mental Health support group. Forfar Academy has joined the regular visitor groups this year with pupils undertaking projects with us such as photographs for creative card making and drone footage to create a time lapse video of our new site transformation. We are delighted to have been awarded a 5 – outstanding rating from Scotland's 'Its your neighbourhood' and we are registered with the Young Person's Guarantee Scheme (DYW). A quick thank you to the Northwood Charitable trust for their support for increasing our community engagement and funding our new logo seen above.

Following last year's success, we opened 2 days for Scotland's Garden Scheme which helped boost our plant sales along with our continued partnership with Murton Trust and Alba Explorers who use our plants to support their projects at local schools. We are very pleased to produce most of our plant sales ourselves either from seed, cuttings or plan division. Fruit and Vegetable sales have also continued to be a great source of income, with many complements on the quality of our produce. Fun days held with examples including Chocolatia recording a podcast from our garden and letting our lucky volunteer's sample their chocolates, Apple pressing and juice consumption along with Pumpkin Carving, grown from last years seed, and of course our annual Volunteers picnic which was a lovely sunny day made special by all the volunteers and their individual contributions.

Latterly, our focus turned to preparing for the Garden move with bulbs being lifted and dried and plants being dug up and potted and placed back in the soil to keep our garden presentable. Our volunteers have been engaged providing ideas for the new garden as well as completing the 'Zen Den' which is already a much-loved place of tranquillity and will be incorporated to our new site.

[REDACTED] has been training to take on the project management for Keep FOG and to step up to take on overall lead for the new garden as Jen steps back to focus on her health and support funding and community engagement. We continue to support our apprentice Lewis Torrie who has really grown with his role and have taken on 2 temporary project workers on a 6-month contract to help us manage the current garden while preparing the new site for with the move.

Project Keep FOG - The team worked with Angus council to firstly identify then, thanks to our trustee Liz, secure a lease for a suitable new site for our garden. After nearly a year of discussions and negotiation our new site, approx. 400m from our current location was secured with Angus council on 30 January. In parallel we secured appropriate planning permissions. [REDACTED] one of our trustees worked with a local architect, [REDACTED] who volunteered, to help secure both permissions

The move funding initially proved very challenging however in early October our luck turned when firstly we secured a postcode lottery grant to cover staff costs to support the move, then a capital grant from the National Lottery to cover demolition, site clearance and a UK Government grant through Angus Council to cover security fencing, gates and disability pathway materials.

Work started the day after we secured our lease to clear, secure and prepare our new site. Due to the knock-on impact of getting utilities into our new site we have managed to get agreement to delay our existing site exit until 5 September 2025. Currently our aim is to move buildings over the summer and start the journey to plant and re-create our much-loved garden late summer 2025. 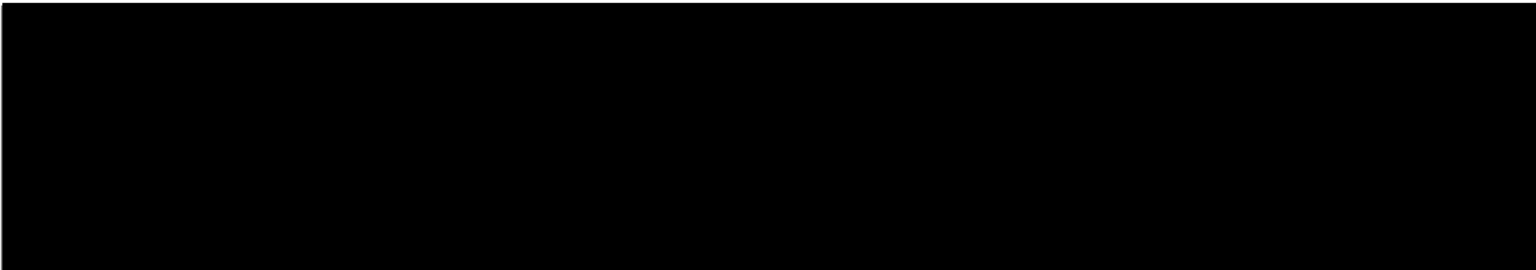
A special thank you to the support from our amazing trustees, volunteers and gardening team they have worked incredibly hard this year to make such fabulous progress. The donations and offers of help from the local community have been amazing and we look forward working with them over the coming months.

Our garden is sustained through the generosity of numerous individuals (you know who you are) and local donors (The original Factory Shop, Asda). Core Grant funding has been secured again from the Mental Health and Wellbeing fund, Baille- Gifford and project support from the Essentia Foundation.

[REDACTED] our Treasurer stepped down at our AGM in August. We welcomed [REDACTED] a regular volunteer at our garden as our new treasurer, she had been shadowing and supporting [REDACTED] since the beginning of the financial year. I'd like to thank [REDACTED] for her support, for simplifying the way in which day to day cash payments were recorded and to welcome Helen to her new role.

I would also like to thank everyone who funds, donates and contributes to our Forfar Open Garden for their generosity and continued support.

Treasurer's Report on 2024-25 accounts

The total income for the year was £82,133 broken down as follows:

Wages

Annual staff wages was £52,022 including LTU for Lewis and £4,972 was claimed back from Angus Council. Wages has increased by £5,416 with £1,380 overtime for KeepFOG.. The increase of just over 11% is mainly due to increased hours worked and the Long Term Unemployed scheme for █████ ended in October 2024.

Core funding

Significant amounts received were:

- Montrose community hub £1,000
- Postcode lottery trust £8,000
- Tayside health board £6,240
- Essential foundation £3,000
- Mental health & wellbeing £20,000
- Northwood charitable trust £5,000

Keep FOG

KeepFOG is expected to be a one off cost to move the charity to a new location over 24/25 and 25/26. We would like to thank the following parties for their grant funding without which we could not achieve project Keep FOG.

- Mental Health & Wellbeing £5,000
- Change for Good £1,000
- National Lottery £1,400
- Angus Council £10,200
- Postcode lottery £10,000 (allocated additional wages for KeepFOG)

Angus Council Community Capital Fund – this fund was received for Project Keep Fog Secure and Pave and has received £35,000 capital grant from the UK Government through the Angus Council Community Capital Fund and will largely cover the materials and contractors to support securing our premises and creating disability pathways. Funding to be released on receipt of invoice and evidence of payment. £10,200 was paid in respect of fencing for new premises. The remainder will be released 25/26 period pending further invoices.

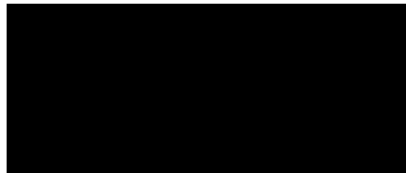
National Lottery – Community Fund (£45,000 Capital and £65,000 Revenue) this significant grant will cover the main contractor cost on Project Keep FOG – Prepare and provide funds for materials and specialist contractual services during Project Keep FOG – Move. Funding to be released on receipt of invoice with £1,400 paid in respect of Eco composting toilet. A deposit of £1,092 has been paid for the new Welcome building and the reimbursement from the National lottery will be included in next year's accounts.



I took over the role of treasurer in August 2024 and would like to thank [REDACTED] for the smooth handover of accounts.

One change I have made with Richard is to devise an excel spreadsheet of the hours worked/holidays/sickness etc and this is now used to be sent to VAA(Voluntary Action Angus) to process wages and stored electronically.

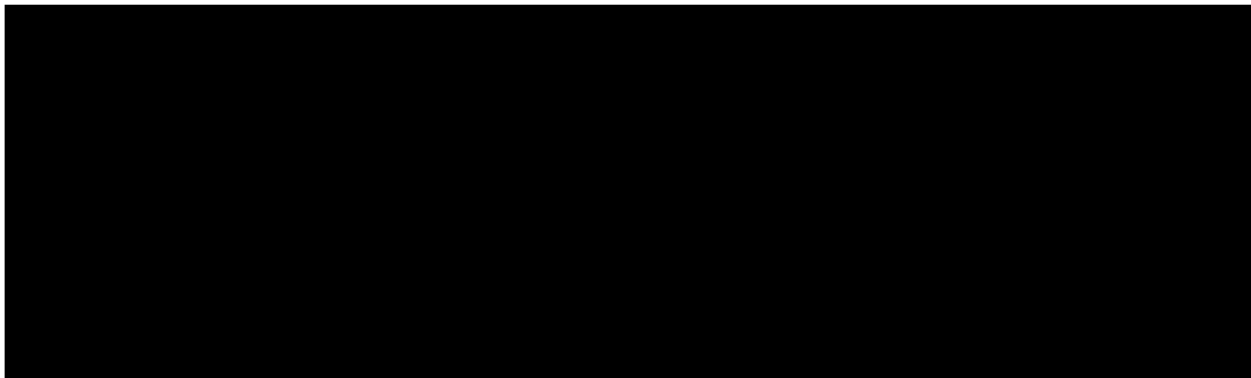

**Independent Examiners Report to the Trustees of Forfar Open Garden

I report on the accounts of the Charity for the year ended 28th February 2025, which are set out on the accompanying pages.

Respective responsibilities of trustees and examiner
