(iii) the observance and maintenance of human rights in accordance with the rule of law. (iv) the prevention of alcohol and drugs abuse and misuse. (v) the prevention of crime including any form of terrorism. 5.1.3 the relief of poverty. sickness, distress and suffering of any persons who are in need irrespective of their nationality, race, ethnic origin and religious beliefs including but not restricted to the relief of those who are the victims of: (i) natural disasters including droughts, earthquakes, epidemics and floods. (ii) man-made disasters including industrial accidents and wars. (iii) the abuse and violation of human rights. (iv) alcohol and drugs abuse and misuse. (v) crime including any form of terrorism. 5.1.4 the advancement of other charitable purposes for the public benefit, to provide recreational facilities and activities in the interests of social welfare with the object of improving the conditions of life for those persons in need of such facilities. and 5.1.5 the advancement of such other charitable objects for the public benefit as the Board of Trustees may from time to time think fit.
