The main programs and events for the year 2024 review are as follows:

- Payments to the solicitors involved in the purchase of the church building

- Celebration of anniversaries such as birthdays and weddings. Three members celebrated landmark birthdays
- Special programmes organised in June and barbecues
- Four church members successfully completed their master's program and got employed with sponsorship.
- Celebrations of mothers, fathers and children on their special days
- Baby christening on 6th July
- Music concert organised on 31st August
- Christmas gifts/hampers for parishioners
