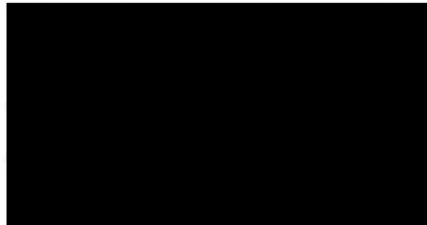

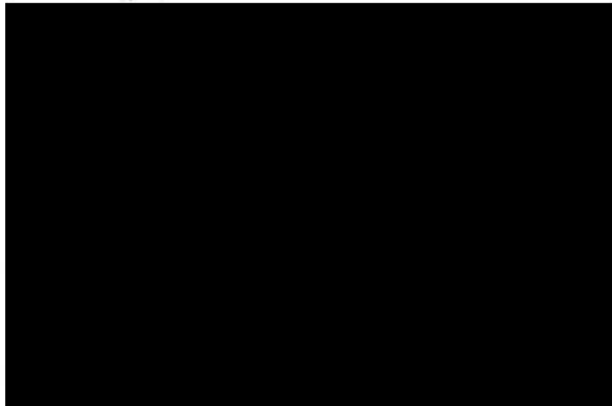

CONSTITUTION

The Charity is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its legal form on 19th October, 2015. The Charity was previously an unincorporated association. The assets of the unincorporated association were transferred to the SCIO on 19th October, 2015.

APPOINTMENTS OF TRUSTEES

The Board of Trustees normally meet four times a year. Trustees are elected by a majority vote at the Board meetings.

OBJECTIVES AND ACTIVITIES

Charitable Purposes

The Charity's purposes are to promote equality and diversity by:

- Raising awareness of disability related harassment and abuse (such as hate crime);
- Encouraging people to report such incidents;
- Working with partners to create safer and stronger communities for people who are elderly, disabled and/or vulnerable; and
- Working with young people, disabled people and partners to promote equality and diversity.

Main Objectives

The Charity aims to change attitudes and behaviours so that disabled and vulnerable people in Scotland feel safe in their communities. To do this they will lead a national movement for CHANGE

C – Create a new disability initiative that helps people to feel connected with their communities.

H – Harness strong partnership working to facilitate changes in attitudes and behaviours.

A – Advance society's awareness of Disability Hate Crime.

N – Network with individuals and groups who have lived and living experience.

G – Galvanise communities to work collaboratively to aim for a Scotland where everyone can feel safe.

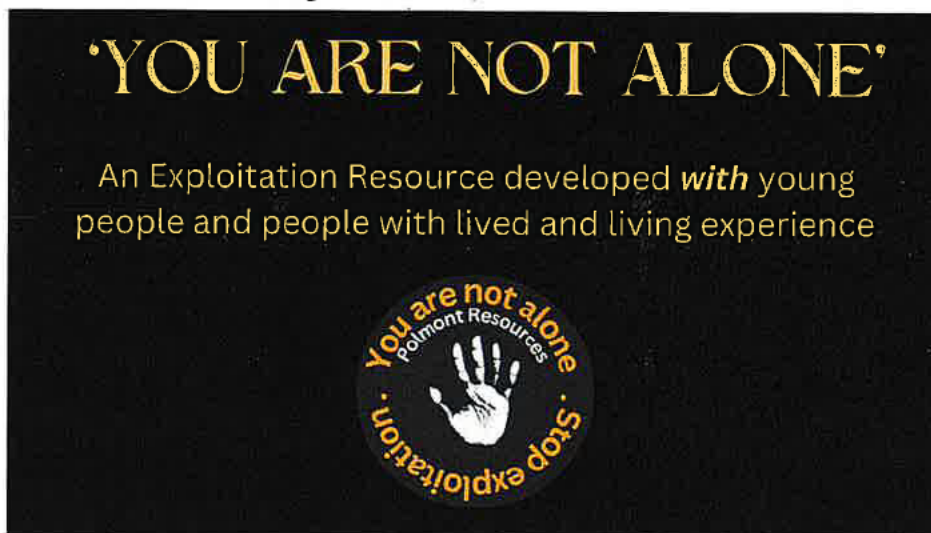
E – Educate and empower a generation of young people to challenge prejudice based behaviour.

Main Achievements 2024-2025

During the period the charity, which has received the Queen's Award for Voluntary Service, has continued to work with children, young people and people with lived and living experience to develop a range of innovative, exciting and accessible resources. The online platform is available FREE for all schools and Police partners in Scotland and is available from iamscotlandeducation.org.uk. There are currently over 2900 teachers and Police Officers using the platform to deliver educational inputs. Resources include, disability awareness, hate crime, alcohol & Substance, UNCRC, Vaping and much more.

In 2024-2025, the team have worked with partners, young people and people with lived and living experience to create the following resources:



This resource was developed in partnership with Polmont YOI and Police Scotland. Young males and adult females from Polmont co-developed the initiative, supported by young people from St Mary's Kenmure, Good Shepherd and Renfrewshire Children and Young People's Team.

The aim of the resource is to raise awareness of, and help tackle exploitation.

The package has been developed for non-mainstream schools, but will be available free. There are 3 main lessons. Which cover gangs, sexual exploitation and radicalisation. There are 7 new short films, based on life experience, as well as a number of information videos and interactive content.

In addition to the 'You Are Not Alone' resource, the team have also developed the following:

Autism Awareness – Primary School



Developed by [REDACTED] the autism awareness lesson will be available for primary school use in the new term. The lesson will raise awareness of what Autism is, how it can impact on a person and what we can all do to ensure that someone who has autism is valued and respected within their school and wider community.

Vape Awareness Resources



Smoking & Vaping Lesson (P7-S2). INTERACTIVE LESSON

Developed in partnership with Police Scotland, the Vape awareness resource is available from P7 to S2 and is included in the Substance Awareness Programme. The lesson is available in two parts and covers topics such as the law, the history of cigarettes and vapes, the health and environmental harms and links to quizzes and support organisations.

The lesson discusses tobacco and vape products, the law, similarities and differences, known health implications, product contents and associated harm, what is addiction, and ways to say no and help available. To deliver the most current content, it is recommended to re-download the lessons before each deliver as all resources are reviewed yearly.



Smoking & Vaping Lesson 2. Developed in partnership with Police Scotland, Lesson 1 is a presentation is can also be downloaded. The lesson discusses the power of marketing, what constitutes a legal vape product, illegal vape products, nicotine free vapes (safer?), disposable vape ban, battery fires and environmental impact. To deliver the most current content, it is recommended to re-download the lessons before each deliver as all resources are reviewed yearly.



Nicotine Pouches. Developed in partnership with Police Scotland, this lesson talks about difference nicotine products, including nicotine pouches. The lesson also covers hand rolling tobacco, cigars, pipes, oral tobacco, heated tobacco, and drugs in vape products.



Nicotine Awareness. Developed in partnership with Scottish Borders NHS, this lesson comes in 7 parts, and covers from S3 to S6. The lesson is interactive, engaging and has various learning styles including video, research tasks and videos. The lesson includes the dangers of nicotine products, understanding vaping - truths and misinformation, marketing and media, exploring the costs, how to get support, and be the change.

My Police on Patrol



Written by [REDACTED] My Police on Patrol has been developed into an interactive online book, animation and lesson, all available from the I Am Me Scotland platform. This book forms part of a set of three books; My Police, My Police, My Community and My Police on Patrol.

Keep Safe

In addition to the development of the new online resources, the Charity has also worked with Police Scotland to finalise the exit strategy for the Keep Safe initiative. During the 10 years the initiative was operational there was:

- Over 1000 Keep Safe places registered on the network.
- 4,448 staff trained on hate crime and reporting.
- 40,000 Keep Safe cards distributed.
- 1,353 ambassadors trained and 588 Police Officers trained.

Disability Friendly

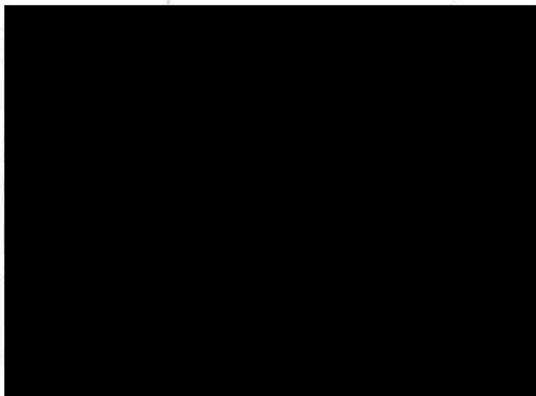
Disability Friendly is a brand new initiative that is being developed with disability groups and disabled people across Scotland. The aim of the initiative will be to help disabled and vulnerable people to feel valued and supported within their communities. Due to pilot in 2025, it is likely the initiative will be available across Scotland from early 2026.

FINANCIAL REVIEW

During the period the Charity received gross funds of £52,127 (2024 - £114,313) and expended £114,590 (2024 - £84,550) which resulted in a deficit at 31 March 2025 of £62,463 (2024 - £29,763 surplus)

Reserves Policy

The Trustees' policy is to retain three months' worth of normal running costs in order to meet commitments and unexpected expenditure. Three months expenditure stands at £28,638 and reserves are £175,686.

Included in the reserves £174,000 has been allocated to cover staff salary costs.

Donated Facilities and Services

The Charity receives the donated services of two members of staff at Renfrewshire Council.

The Charity has a strong partnership with Police Scotland, Renfrewshire Council and the Crown Office and Procurator Fiscal Service (COPFS).

Other strategic priorities include the commitment to:

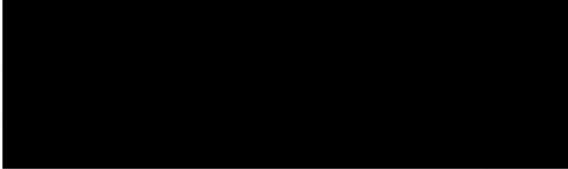
- Build on the excellent health and wellbeing educational platform, focussing on prevention and early intervention (harm reduction):

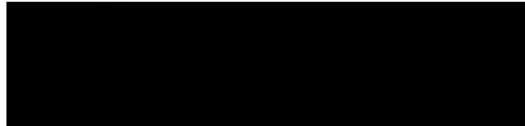
