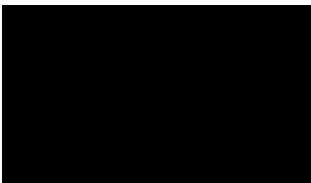

Appointment of trustees

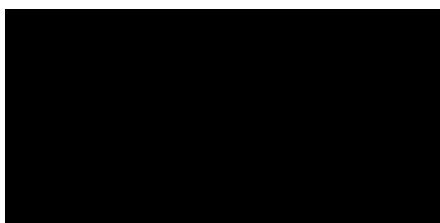
Trustees are elected at the annual general meeting.

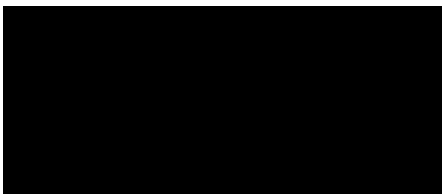
