During the year, the spiritual and emotional needs of members remained a key priority. In response, we organised a range of Bible-based teaching sessions focused on practical life application.

The charity also delivered a successful leadership training programme in collaboration with other parishes, alongside a community barbecue during the summer.

The charity partnered with churches across the country to deliver local Let's Go A Fishing Programmes, an evangelism initiative focused on sharing the good news of the Gospel.

We look forward to building on this progress in the year ahead.

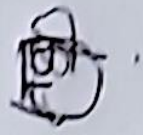

# **Independent Examiner's Report**

## **Independent Examiner's Report to the Trustees of Redeemed Christian Church of God Freedom House Edinburgh (SC046205)**

I report on the accounts of the Charity for the year ended 31 March 2026 which are set out in the following pages.

### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trust Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the act and to state whether particular matters have come to my attention.

### **Basis of independent examiners' statement**

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts (Scotland) Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented to those records.

Other significant expenses were £4,552 (2024: £3,578) for rent, and £7,683 (2024: £10,377) for evangelism materials, training, hospitality, travel, and repairs and maintenance.

During the year, our members’ spiritual and emotional needs became very significant, so was our effort to ensure these needs were effectively attended to, and where necessary, we referred people to different agencies specialised in the areas of their needs.
