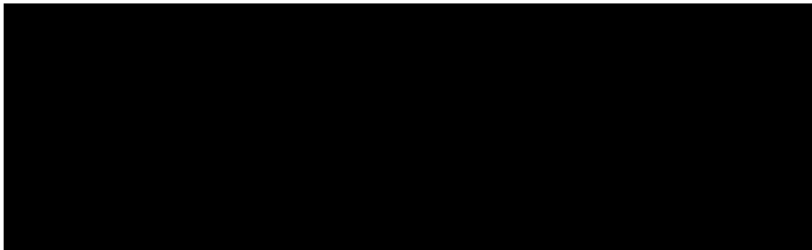

Report of the Trustees

The Trustees are pleased to present their report together with the financial statements of the church for the year ended **31 December 2024**.

Status of Charity and Governing Document

Covenant Church, Newmilns (Free Church of Scotland) is established by constitution. It is a registered Scottish Charity (No. SC046532).

Aims and Affiliation

Covenant Church, Newmilns (Free Church of Scotland) is a congregation of the Free Church of Scotland working towards the common aims set out below. It is a Presbyterian church adhering in its worship and doctrine to the position of the Church of Scotland at the Reformation. The Free Church of Scotland has an explanatory document which explains the origins of the Church and which gives the historical background to the Church coming into being in 1843 and lists documents in which is embodied the constitution of the Church. The document is available on request from the Free Church of Scotland, 15 North Bank St., The Mound, Edinburgh, EH1 2LS.

The Free Church of Scotland currently has over 100 congregations in Scotland, as well as one in London and four in North America, and sister Churches founded by mission work in India, Peru and South Africa. The Church also has a seminary in Edinburgh for the training of ministers and other Christian workers and sustains an extensive missionary programme relative to the size of the church.

The principal activity of the Church is the conduct of public worship and associated matters in the context of local congregations.

Dating from 1843 but with its roots in the Reformation, the Free Church of Scotland owes its distinctive title to its historical struggle to remain 'free' from state interference in its internal affairs. It has close and active relations with many other Reformed churches of Jesus Christ throughout the world and stands firmly in the tradition which accepts the Bible in its entirety as the Word of God and, therefore, derives its forms of teaching, worship, ministry and government from it. The main emphasis of our worship is the preaching of the gospel - the good news of a free and sovereign salvation through Jesus Christ alone.

The congregation of Covenant Church (also known as Covenant Church, Newmilns) aims to maintain the public worship of God and to foster Christian fellowship; to evangelise the local area by proclaiming the gospel of Jesus Christ, to exercise pastoral care and practical compassion for those in need; to uphold and further the interests of the Free Church of Scotland; and to participate in the worldwide promotion of Christian fellowship and the advancement of the Christian faith. All the business and proceedings of the Congregation shall be conducted in accordance with the constitution of the Free Church of Scotland, under the supervision of the Presbytery of the bounds, and in terms

of the Acts, deliverances or directions of the General Assembly of the Free Church of Scotland.

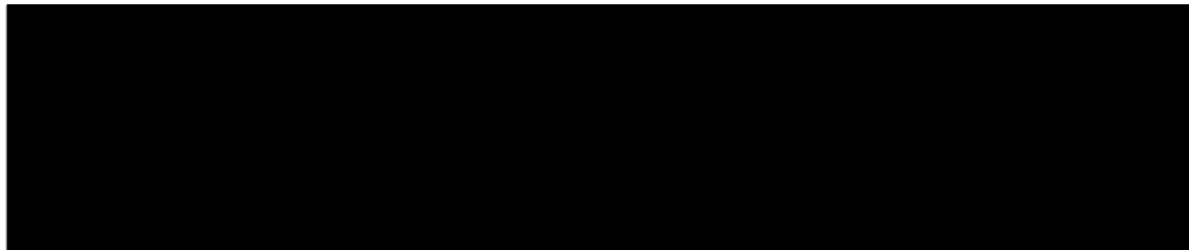
The congregation is authorised by the Church to have a minister paid from central funds of the Church. The minister's manse is the property of the congregation and is held under the Church's model trust deed.

Trustees and Office Bearers

The congregation is governed and administered by elected office bearers (all volunteers) and its minister. The Kirk Session, being the minister and elected elders, has responsibility for spiritual oversight, while the Deacons' Court, composed of Kirk Session members plus elected deacons, oversees financial and property matters. Under Charity Law, the Deacons' Court are deemed to be the trustees of the congregation as those with responsibility for day-to-day management and control. This is distinct from the role of property (congregational) trustees who are responsible only for holding property in trust.

Appointment of Charity Trustees

The Kirk Session exercises its discretion in determining the most appropriate method of electing new Trustees (Elders and Deacons). Any election process must involve the communicant membership of the congregation. There is no fixed term for Trusteeship. Prior to their appointment, new Trustees would have served the Church for some time in various roles and would be familiar with the Church's values, its aims and objectives as well as its day-to-day operations. As part of their induction programme, new Trustees are required to understand their statutory responsibilities as well as the responsibilities of their office within the congregation as elder or deacon.

Activities and Achievements

During the year, the congregation met regularly for public worship and carried out various activities in pursuit of the above stated aims. The congregation normally meets in the Morton Hall, Newmilns – renting use of the Morton Halls from East Ayrshire Leisure – for Public Worship on the Lord's Day. During periods when the Morton Hall is temporarily not available, e.g., refurbishment or closure for repairs, the congregation meet in Darvel Town Hall (another property of East Ayrshire Leisure) in the neighbouring village.

The congregation continues to support the provision of one of the Sunday afternoon services each month in two local care homes.

The congregation continued to meet on Sunday for Public Worship, almost always having both a morning and an evening service. We continued to utilise Facebook live broadcasts of morning and evening worship for those who, for various reasons, were unable to attend in-person and to reach out to those who may not, at least initially, want to join a church service in-person.

The church prayer meeting continued fortnightly in general and weekly during the summer holiday period. We normally meet in the Newmilns CHaT Hub and use the Zoom platform to enable participation in the devotions and prayer time by those unable to attend in-person.

The congregation has three Connect Groups. Two groups meet in-person with a third group continuing to use Zoom technology to function as an on-line Connect group. The purpose of the Connect groups are to connect with one another in fellowship around the word of God as part of connecting with God and growing our relationships with God and with one another.

The connections between the local community and the church congregation continue to develop and strengthen. The congregation actively supports the provision of a 'warm welcome' community hub, cooking classes, and local foodbanks. This has involved people from the congregation volunteering in various ways and/or the provision of financial assistance to support these activities which are supporting people in our communities. One of the elders from the congregation is actively involved with the local Darvel Football Club as their chaplain.

In August 2024, prior to the start of the new school year, the congregation delivered a holiday club for primary school age children. The holiday club was called 'Deep Sea Divers' linking with the theme of exploring the depths of faith in an age-appropriate way. The bible teaching was drawn from the four Gospels focusing on Jesus.

October 2024 saw the congregation host a live theatrical performance of "Eric Liddell: The Chariot of Fire" (by the Searchlight Theatre Company) to engage with the community and share the story of Eric Liddell and his faith in Jesus as part of community outreach. It was encouraging to see about 120 people from across the local community enjoying the performance and staying for informal chat over tea, coffee and cakes.

The carol service was held in the Morton Hall on 08 December. More than 180 people attended. It was encouraging to welcome people from across the community, some of whom have no regular connections with any church, we were also pleased to welcome people from other churches in our communities too. The service included traditional and modern carols, songs from Hope Choir, action song from children's church, bible readings and messages from God's word to encourage and challenge everyone to worship Christ the Son of God who is Immanuel. The majority of those attending stayed after the service for a time of informal fellowship with mince pies and other favourites on offer.

Throughout the year the congregation continued its commitment to support the National Free Church of Scotland both spiritually and financially.

A summary of significant highlights, events and developments of note in the year include the following:

In relation to **congregational activities**:

- The provision of public worship services including the preaching of God's word.
- The continuation of broadcasting worship services on Facebook to facilitate the continuation of public worship, preaching of the word, prayer and fellowship to support the engagement of those unable to attend public worship in-person and reach others not yet attending in-person.
- The Connect Groups meeting, in-person and on-line, to study God's word and grow in our relationships with God and with one another.
- The provision of Children's Church as part of morning worship services.
- The delivery of a holiday club for primary school aged children in August as part of community outreach and activity.
- The hosting of a live theatrical performance of [REDACTED] "The Chariot of Fire" (by the Searchlight Theatre Company) to engage with the community and share the story of [REDACTED] and his faith in Jesus as part of community outreach.
- The holding of a Carol Service to worship God and share with the community the Gospel message of Good News at Christmas.
- The commencement of a Minister in Training within the congregation.
- The joining into membership of the congregation by three people during the year, including one by profession of faith.

In relation to **congregational funding**:

The Trustees record their grateful thanks to God for His gracious provision. Despite continued cost of living pressures on the people of the congregation and wider society, it has been a privilege to see the provision of God for His people through:

- A steady provision of donations from church members via weekly offerings and Gift Aid donations.
- Sustained participation by church members in the Gift Aid scheme.
- Sustained usage of giving by standing order.

Donations and other income received increased from £79,714.53 (2023) to £85,424.27 (2024), having previously decreased from £86,618.80 (2022).

Payments for the year were £89,612.33; increased from £79,098.55 in 2023 and £80,198.87 in 2022. These payments include the contribution to Free Church of Scotland Central Funds of £44,904.00; increased from £41,300.00 in 2023 and from £40,000.01 (2022). From the Free Church of Scotland Central Funds, the cost of the ministers stipend and pension are met as well as other activity of the Free Church of Scotland. Financial support given to our mission partners and other causes was £4,174.70; decreased from £7,403.79 (2023) and £7,807.50 (2022).

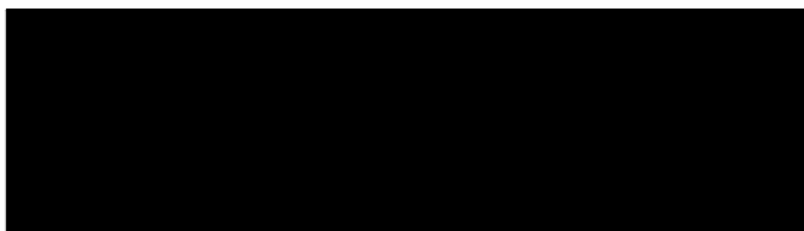
Reserves

Results for the year

As a result of a deficit for the year of £4,188.06 (following a small surplus of £615.98 in 2023 and a surplus of £6,419.93 in 2022) the church held funds amounting to £24,562.57 at 31 December 2024, of which £23,964.10 were unrestricted funds. This represents a decrease of funds held from £28,750.63 at 31 December 2023 (of which £28,182.16 were unrestricted funds).

The trustees are satisfied with the level of reserves retained by the charity.

Report of the Independent Examiner to the Trustees for the year ended 31 December 2024

I report on the accounts of the church for the year ended 31 December 2024 which are set out on page 8, along with the notes on pages 9 and 10.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

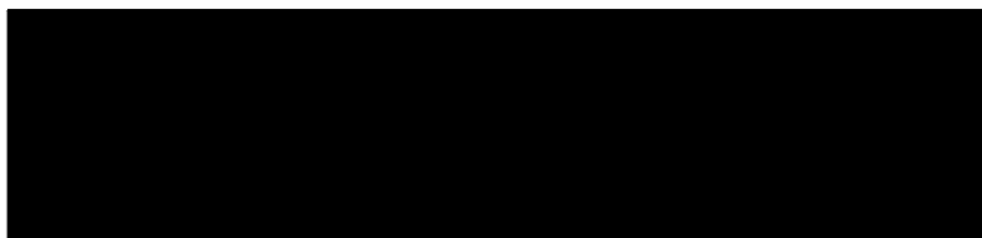

Notes to the Financial Statements *for the year ended 31 December 2024*

1. Accounting Policies

Accounting Convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Charities Accounts (Scotland) Regulations 2006.

Basis of financial statements

The financial statements have been prepared on a receipts and payments basis.

Investments

As the accounts are prepared on a receipts and payments basis the investments are included at cost. Market Value of the investments is disclosed within the notes to the accounts.

Fixed Assets

A statement of the assets held is shown in the notes to the accounts. No depreciation has been applied as depreciation is a non-cash item and therefore should not be included in the receipts and payments account.

Receipts and Payments Account

For the purpose of the Receipts and Payments account as shown on page 8, funds are defined as follows:

Unrestricted funds comprise grants and other income received for the objects of the church without further specified purpose and are available as general funds.

Designated funds represent unrestricted funds which have been earmarked by the Trustees for particular purposes.

Restricted funds comprise income which has been received for the objects of the church and specified for a restricted purpose within these objects by the donor.
