Activities: 'It carries out activities or services itself'

What the charity does: The club is set up to provide recreational facilities and organise recreational events in the field of model aircraft flying with the objective of improving the conditions of life for those persons who wish to be involved in the sport. The club maintains a permanent flying location in Lanarkshire which is operated and maintained by the club's members. It has a club house at the site which provides undercover shelter and a venue for members to meet and socialise. There and a toilet block which is wheel chair accessible. The club provides training for those who wish to learn to fly model aircraft and it holds dedicated weekly training events during the flying season. The club also arranges several fun events during the flying season to encourage it's members, and members from other flying clubs to meet and socialise.

Objectives: The organisation's purposes are to provide social, educational and recreational facilities for the members of the club and to promote interest in all model flying disciplines.

Structure, governance and management

Type of governing document

The governing document of the Hamilton Model Flying Club is the club constitution. This is available on the club's website. The club's activities and contacts with external agencies are managed by the trustees. In accordance with the club's constitution a monthly business meeting is held to discuss ongoing issues and pass resolutions that impact on the running of the club. The Annual General Meeting is held in March each year.

Trustee recruitment and appointment

The club currently has eight positions for trustees drawn from the club's membership i.e., Chairman, Vice Chairman, Treasurer, Secretary, Safety Officer, Web Master, Assistant Web Master and Covid Officer. Each trustee is proposed, seconded and elected to their respective position by the club membership each year at the club's Annual General Meeting.

Objectives and activities

Charitable purposes

To provide recreational facilities and organise recreational activities in the field of model aircraft flying with the objective of improving the conditions of life for the persons for who the facilities or activities are primarily intended.

Summary of the main activities in relation to these objects

Hamilton Model Flying Club has a permanent flying field located near Netherburn in Lanarkshire for members to meet and fly model aircraft. The site is operated and maintained by the club's own members. It has a clubhouse, under cover shelter and a toilet block that is wheelchair accessible as well as facilities to make hot drinks and food. The club has several disabled members.

The club provides training for those who wish to learn to fly model aircraft and holds a dedicated weekly evening training session every week during the flying season. The club has several Scottish Aeromodellers Association (SAA) qualified examiners and two Large Model Association (LMA) qualified examiner who can teach all aspects of model flying and aid until a newcomer is certified as a competent model aircraft pilot to national recognised standards verified by the SAA, LMA and the British Model Flying Association. This certification is required by the club before a pilot can fly a model aircraft solo. The club hosts competitions and open events to non-club members throughout the year. The club supports other youth organisations, such as the Air Training Corp by allowing the use of its facilities and giving training and instruction in model aircraft flying.

Achievements and performance

Summary of the main achievements of the charity during the financial period

At the time of the Annual General Meeting in March the club had 69 members (an increase of 8 from the previous year) 41 of these are adult members (a decrease of 3 from the previous year due to the sad passing of 3 club members during the year). There were 27 junior members. Of these junior members, 21 are associated with the 2166 Hamilton Squadron, Air Training Corps who the club continues to work closely with. The club offers training sessions to the air cadets and this year saw an overall increase of 8 in in the number of air cadets in the club.

Improvements continued to be made to the club's flying site. Last year the pilot stance was moved to a new location on the runway to allow better take-off and landing under easterly wind conditions. However, the drainage in this area was relatively poor and this delayed the installation of the bio-matting planned to improve disabled wheelchair access to the runway and pilot stance. Three new drainage runs have now been installed. This has resolved the drainage problem in the area. Some of the work was done by club members to help keep costs to a minimum. Contractors were used where "in-house" was not possible. To complete the final phase of the disabled access project costs to install bio-matting in the area around the pilot stance will be assessed with the intention applying for a grant to complete this work.

Routine maintenance of the flying site and the grass cutting equipment (tractors, gangers and mowers) continued to be done by the club's members. The repair of the storm damage caused by several named storms which hit the site during the year were also completed by the club's members.

The club's safety rules have been reviewed and a revision issued in a format that is acceptable to the Civil Aviation Authority. This led to a renewed application for authorisation, to fly models less than 25kg up to a height of 1200 ft which was subsequently granted. The Hamilton Model Flying Club site is now recognised by the Civil Aviation Authority (CAA) and a Notice to Airmen (NOTAM) to that effect has also been issued by the CAA.

The club hosted a Training & Testing weekend on behalf of the Scottish Aeromodellers Association and the British Model Flying Association in October. This was very successful with three safety awards being gained, (two SAA Bronzes and one BMFA A certificate). The club currently has several examiners in its membership which places it in a good position to train and certify the competences of new model pilots

Another area of notable success for the club is the fact that three of the club's members now make up the complete F2D British control line combat flying team. As such they will represent Britain in both the British world cup and Spanish world cup competitions later this year.

The club's online website was also redesigned during the year. It has been made more user friendly and easier to update. The website now has a more bright, welcoming feel to it especially for first time visitors.

Brief statement of the charity's policy on reserves

The club's main running costs are the rental costs for the lease of the flying site and the costs of maintenance and the upkeep of the access road. These costs are met from the club's membership fees. The membership fees usually generate more than sufficient funds to cover these activities provided that the members donate their own time and labour to undertake routine maintenance activities. Surplus funds from the membership fees are held in reserve and are used to provide materials and equipment for site improvements or to undertake emergency repairs at the site.

Details of any deficit

This year the club did not have a deficit and showed a surplus of £413 for the year.

Donated facilities and services (if any)

During the year the club received a donation of £450 from the estate of a member who passed away during the year. A further £150 was received for the Scottish Aeromodelling Association for running a national training and testing event at the club's flying site.

C1 Nature and purpose of funds
(may be stated on analysis of funds worksheets)

The club's fund are mainly acquired from the annual membership fees paid by the club's members (£2410 for this year). This year a donation of £450 was received by club from the estate of a club member who sadly passed away. £150 was also received by the club from the Scottish Aeromodelling Association for running a national training and testing event (open to all SAA members) at the club's flying site. During the regular maintenance of the club's website the opportunity was taken to remove unused applications from the site, this resulted in a refund of £102 to the club from the website host. £60 was also received into the club's account from members as a booking deposit for the club's annual Christmas event. This money was later used to partly cover the cost of the Christmas event. The fund are mainly used to pay for the rent and maintenance of the club's flying site and to rent a venue for the club's monthly business meeting and indoor flying sessions.

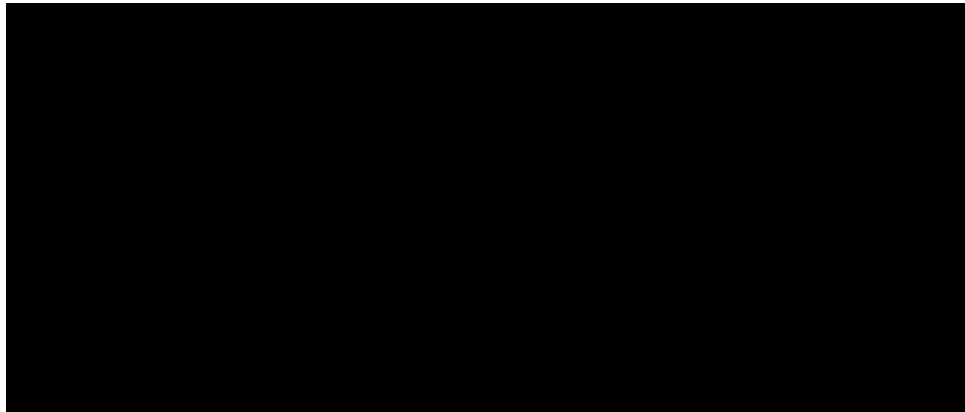
