The Executive Committee has pleasure in presenting their report together with the financial statements & the independent examiner's report for the year ended 31 March 2025

Constitution & Purpose

Largs Community Resillience Team (LCRT) is constituted in terms of the Rules of the Scottish Charitable Incorporated Organisation (SCIO). The Group is a registered Scottish Charity – No. SC047060

The purpose of Largs Community Resillience Team is to save lives. In doing so, we aim to create a resilient North Ayrshire and surrounding area by ensuring that LCRT is able to respond swiftly and proportionately to an emergency in the community as part of an integrated emergency response.

We ensure compliance with the Civil Contingencies Act 2004.

We ensure that LCRT can respond to an emergency in the community through the creating of emergency plans, supplements with training, exercises and plan maintenance with associated operational teams.

We ensure the provision/dissemination of routine warnings received from various agencies including, but not limited to, the Met Office and Enviromental Agencies

Trustees are recruited & appointed in accordance with the Constitution Rules (24.0).

Activities & Achievements

During the past year Largs Community Resilience Team have recruited several new members but have also had some members step down. We have a pool of 35 volunteers from which around half are most active supporting events locally, the Largs Viking Festival being the main event during the year.

The team now have the capability to provide First Aid and we have been called upon to deliver this at a few local events. (Viking Festival, RNLi Duck Race, Yule tide night)

The team have continued to support local pharmacies and vulnerable people with delivery of medication and shopping, although to a lesser extent than previous years as many residents have passed away or moved into residential care.

Overall, the Largs Community Resilience Team are recognised as an essential resource within the local area and residents appreciate having a resource they can call on if required.

Independent Examiner's Report to the Trustees

I report on the accounts of the charity for the year ended 31st March 2025 which are set out on pages 3 to 5.

Respective responsibilities of trustees & examiner
