Providing examples and education on the positive impact that this can have on individuals, including the potential to save lives. - the charity will encourage acts of kindness including but not limited to, doing something kind for someone, smiling at a stranger, texting a friend, calling someone who may feel better by hearing a friendly voice or simply writing a message on one of the LoveLeigh cards provided as part

of the charity days and school awareness days, all run as part of the charity. All activity will support the education of the public on the impact of kindness and the power it has to enrich, lighten and save lives. to promote and raise awareness of support available for those suffering from mental health. Helping with the advancement of health by holding dedicated days that are designed to encourage the public to carry out random acts of kindness to help those who may be in need and to also raise awareness of mental health and break down the stigma that surrounds these illnesses. To raise awareness of the masks that people wear which cover up very serious, mental health issues. Although we are not providing mental health counselling support we will promote and signpost other support networks. We will carry out education and awareness days in schools across Scotland, working with teachers and pupils to start early awareness of the impacts of mental health and discussing how acts of kindness can have positive impact and potentially change lives. Hold coaching workshops to help and support those who are dealing with loss from both suicide and other bereavement.

## Structure, governance and management

Type of governing document

The charity is a Scottish Charitable Incorporated Organisation (OSCR). It was set up on 14<sup>th</sup> February 2017. It has a single tier structure and the trustees who are also the organisation's only members, comprise the organisation's board. The charity has a Constitution Document that governs our operating principles and outlines our purpose and objectives.

Trustee recruitment and appointment

On the date of set up, there were 3 trustees (including the founder [REDACTED]). Another trustee was recruited by the Board in June 2017 and one of the trustees stepped down due to other commitments during Sept 2017.

Another of our trustees stood down due to additional commitments in Dec 2020, and we then took on a 3<sup>rd</sup>.

We are now operating with 3 trustees (including the founder, [REDACTED])

We are open to welcoming new trustees and welcome a number of additional people who offer their help.

## Objectives and activities

### Charitable purposes

The organisation is established for charitable purposes only, and in particular, the objects are:

to advance the saving of lives by:

- ~allowing anyone that has lost someone they love, or is suffering from mental health issues, to share acts of kindness, love, hope and inspiration
- ~the charity will encourage acts of kindness, including, but not limited to, showing kindness to others, smiling at others, contacting friends, leaving random messages or gifts, popping into a home or hospital to shared stories with residents, or by simply writing on one of the LoveLeigh cards that are provided by the charity.
- ~providing kindness boxes and guidance on how being kind can save lives

to promote and raise awareness of support available for those suffering with poor mental health:

- ~helping with the advancement of mental health by holding dedicated days that are designed to encourage the public to carry out random acts of kindness to help those who may be in need, and also to raise the awareness of mental wellbeing.
- ~to raise awareness on how to approach and deal with identifying those that may need help and provide signposting to other support networks. The charity will work with some of these networks to share advice, guidance, support and fundraising opportunities
- ~providing education and awareness days in schools across Scotland, working with teachers and pupils to encourage early awareness of mental well-being, and encouraging everyone to use kindness to help others.

### Summary of the main activities in relation to these objects

We continue to manage our community Facebook page and other social media channels. The community Facebook page has provided a platform for many of members and non-members to get in touch for life saving help. We continue to work with other charities to strengthen this network

We now have an updated website which has also been an effective way of encouraging people to get in touch to help fundraise, but also to get the help that they really need.

This reporting year has been another quite one due to other work commitments for all trustees. However, there has been a lot of interest coming from students taking part in the Youth Philanthropy Initiative (YPI)

## Achievements and performance

### Summary of the main achievements of the charity during the financial period

Kindness packs have been streamlined again, to make them easier to make up and distribute. These were initially made-up using letterbox packaging to save costs and making delivery simpler, however, these are now being priced on weight, making them more expensive. It is now better to use larger boxes to maximise the contents for users.

We continue to work with several schools who participate in the Youth Philanthropy Initiative (YPI). Once again, this has raised the profile of what we do and generated many messages from students who needed to reach out for help. The process of getting schools involved has also raised the much-needed awareness of how students can behave differently to each other to improve mental health and drive down the likelihood of self-harming or suicide because of bullying.

The balloon pins are still very successful in raising awareness and these are being re-purchased for kindness packs and awareness sessions.

We continue to informally team up with a couple of SCIOs, to pass on those who need specialist help that they can provide. Between us, we have successfully helped several community members who are now being supported on a regular basis.

Work on the new kindness and mental health booklet paused due to other time commitments for Trustees and volunteers but will be re-started in Autumn 2025.
