Work to support Pride House organisers and local activists in each of the organising countries where Pride Houses are being planned. These were:

Winter Olympics Milan and Cortina 2026  
FIFA Men's World Cup North America 2026  
FIFA Women's World Cup Brazil 2027  
Olympic & Paralympic Games Los Angeles, USA 2028

We also collaborated this year as a member of the LGBTIQ+ Human Rights in Sport Coalition.

### **Working with international movements:**

We dedicate significant amounts of our time to working with international community groups and activists which sometimes develop into Pride House projects, and at other times don't. For example in the current period a lot of time has been dedicated to working with partners across North America in anticipation of the next Men's World Cup in 2026.

Unrestricted reserves can be spent on the furtherance of our charitable purpose, and decision making on this is at the discretion of our Trustees.

The charity has £1695 in reserves at year ending March 2024.

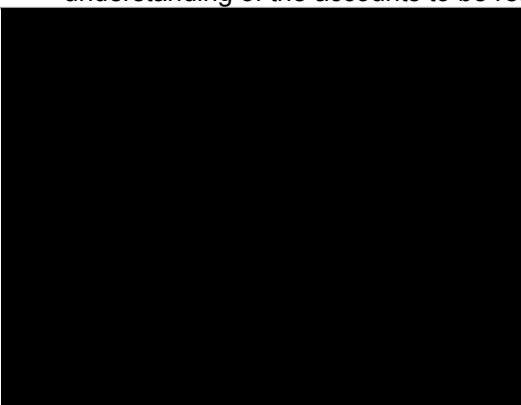
