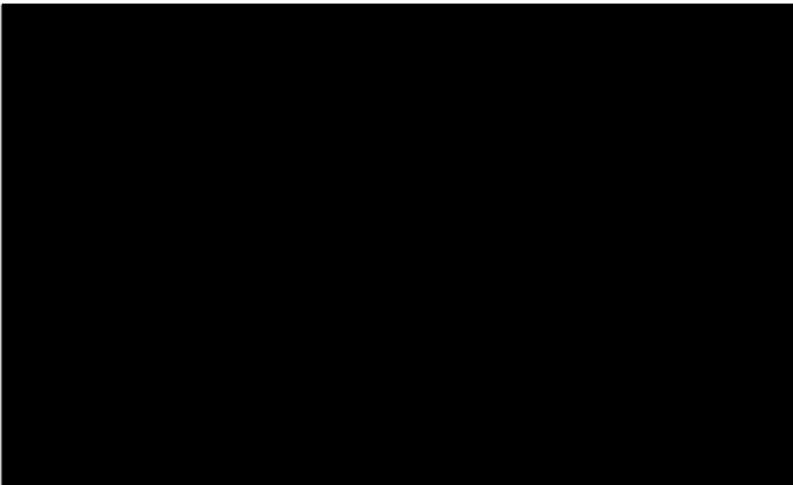

The club also had success at the Nationals and tournaments throughout the year with many players from Primary to Senior players being selected to represent Scotland.

2. To which, in my opinion, attention should be drawn to enable a proper understanding of the accounts to be reached.

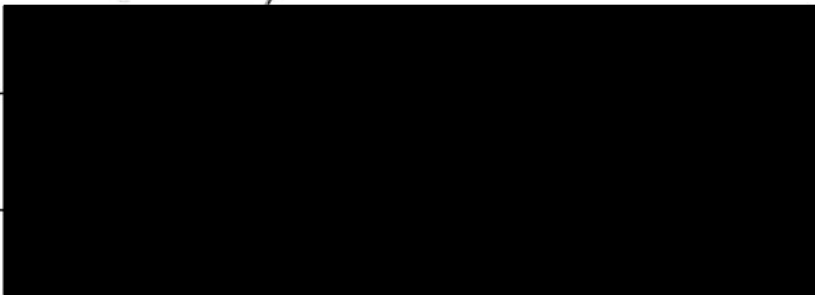
