Pitreavie Primary School and Fife Council for the use of the facilities and surrounding green areas for fundraising events.

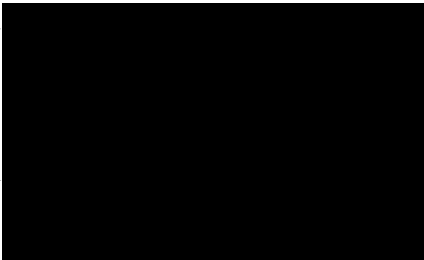
