Our monthly meetings are always well attended every month and we were pleased to welcome lots of new members. Guest speakers, Police Scotland and our local Councillors play a valuable role at the monthly meeting and we are grateful for their attendance and contribution. Lots of local issues have been resolved as a result of our monthly meeting.

**Yearly Events**

We have had a very successful year with an increasing number of events being held and an ever increasing number of people attending. Our Christmas Extravaganza continues to grow in popularity and it was another sell out. Our Burns Supper, St Andrew's Night, Hogmanay party, Festival of Lights were all busy. This year, we also received a visit from HRH The King.

**Monthly Events**

Soup and Sandwich remains as very popular. To reflect increasing costs, we have increased our charge for entry, but it remains good value for money.

**Fortnightly**

The gardening group continues to grow, with a new extended garden. The community garden is open all the time and we encourage everyone to use it. Soon, we shall have a new community hut in the garden.

**Weekly**

All of our weekly activities are very busy, they are: Scatoosh singing group, Sauchie Community Group choir, Carpet Bowls, Film Club, Arts and Crafts Group, and Chatty Latte. Numbers attending have all increased. New participants are welcome.

**Daily**

Sauchie Tiny Tots remains very popular and often is at capacity.

**Partnerships**

Sauchie Community Group continues to build and create new partnerships with other local charities and third sector organisations. Our 'Thank You for the Music' group (which is a sub group of Sauchie Community Group) continues to attend our local care homes every week to sing with residents who are living with dementia.

## Main Achievements

Sauchie Community Group SCIO continues to grow every year. We were delighted to welcome HM King Charles III to Sauchie Resource Centre as part of his Royal Tour. He chatted with volunteers and visited our community garden. We also had a visit from the Presiding Officer of the Scottish Parliament, who was joined by a number of Members of the Scottish Parliament to find out about the work that we do in the area. Both of these visits are testimony to hard and tireless work of our volunteers do every day to contribute to the ethos of the local area, and we are pleased to be able to showcase that on a national scale.

As always, we are extremely grateful to all of those who support our work, including our funders: The Big Lottery, The Robertson Trust, Clackmannanshire Council, Clackmannanshire Third Sector Interface (CTSI) and Volunteering Matters. We are also thankful to the many donations we receive throughout the year; to those who donate when our Sauchie Community Group Choir and Scatoosh are singing at the local supermarkets; to the many people who come along to our concerts and gigs. Collectively, we are in a strong financial position moving forward – despite the many challenges that we have, e.g. increasing costs, particularly energy.

This has been another year of concerts, events, gigs, meetings, activities and collaboration. As you will see from our accounts, everything is increasing in popularity, meaning that demand for our services has risen again. Therefore, we have taken the steps to build a 'wellbeing hut' in the garden, which will open this summer – this will mean that we can put on more activities and reach more people.

An enormous thank you to our Co-community managers [REDACTED] our fantastic board of Sauchie Community Group, and all the volunteers who help with the daily organising and running of the organisation.

Sauchie Community Group SCIO has played its part in this community for more than three decades, and I am delighted that through hard work, determination and a lot of fun, we are in the strongest position as an organisation that we have ever been in, and I am excited for what the future brings for our organisation, our local area and the local community.

## Reserves

The Community Group holds a balance of £41,932.04 of which £9,248.66 is restricted.

The balance of £32683.38 is a general fund and is available to be used in order to run activities and meet unforeseen expense.

**I report on the accounts of the charity for the year ended 31st March 2025**

**Respective responsibilities of trustees and examiner:** The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. **Independent examiner's statement:** In the course of my examination, no matter has come to my attention


1. which gives me reasonable cause to believe that in any material respect the requirements:


