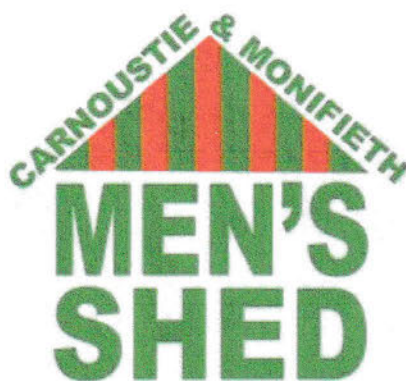

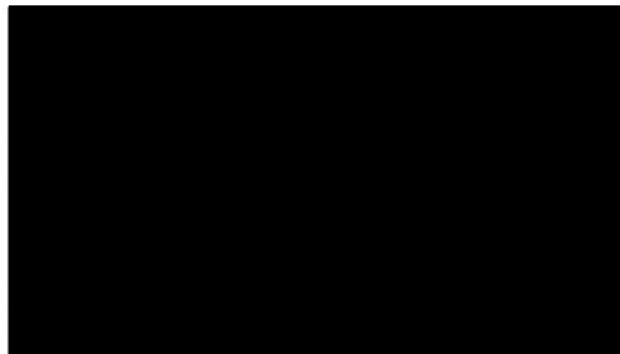

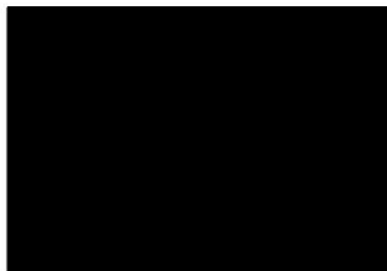

TRUSTEES' ANNUAL REPORT

STRUCTURE GOVERNANCE AND MANAGEMENT

Governing Document

Carnoustie and Monifieth Men's Shed is a Scottish Charitable Incorporated Organisation (SCIO) and it was registered as a charity from 23rd August 2017. Carnoustie and Monifieth Men's Shed have a constitution in place for the running of the charity.

Appointment of Trustees

Trustees are recruited at the Annual General Meeting. The office bearers are elected at the Annual General Meeting, Trustees can be coopted throughout the year. Any Trustee completing three consecutive years must retire from office and be re-elected at the Annual General Meeting.

The board of Trustees meet often to review all aspects of the charity's affairs.

Organisation Structure

The trustees are responsible for the strategic direction and governance of the charity.

There are many volunteers who help with the ongoing tasks of the charity.

OBJECTIVES & ACTIVITIES

The purpose of the charity is to provide recreational facilities and advance social needs, health and wellbeing of men of all ages and backgrounds living in Carnoustie and Monifieth and the surrounding areas by:

- a) Creating, developing and maintaining a facility, namely a Men's Shed
- b) Offering opportunities for men in the Carnoustie and Monifieth area to meet and undertake creative, physical, purposeful and recreational activities of their choice.
- c) Reducing isolation of men in the area thus contributing to their physical and mental well-being.
- d) Developing the capacity of men in the Carnoustie and Monifieth area to share their skills and knowledge with others in the community.

ACHIEVEMENTS & PERFORMANCE

The Annual General Meeting (AGM) was held in the shed on Thursday the 24th of October 2024. It was explained to the trustees at the previous meeting how the process of the AGM occurs and about the election of the trustees. Nomination forms were provided, and two new trustees were appointed. There was good attendance at the AGM and the process ran smoothly.

During the period we were successful with funds from Angus Council and Carnoustie Golf Links which has enabled us to repair the roof of the building, this was major work with scaffolding erected, planning etc. Thank you to Angus Council and Carnoustie Golf Links who provided much-needed support.

Donations were given from individuals for the wooden structures that have been made throughout the year. Carnoustie High School stage production was provided with props.

TRUSTEE'S ANNUAL REPORT

Achievement & Performance cont'd

The trustee's are ensuring that proper procedures are in place to look after the building with fire safety evacuation processes, alarm system, policies updated and up-to-date guidance when people attend the hall, part of the hall is let out to another group and this then provides much needed trading income. Heaters and Solar panels were installed/fixed.

This year has been a special year for us as in January we received a notification from the Lord Lieutenant Of Angus that we would be getting a visit from a VIP ,it turned out that this VIP would be the HRH the Prince of Wales and on the 6th February I had the pleasure of escorting him around the shed and meeting the committee and members it was a wonderful experience for all of us who met the Prince it put us on the map as well as showing our support for mental health and the wellbeing of the community. The prince visited and subsequently sent a letter from Kensington Palace expressing appreciation for the hands-on experience and conveying best wishes for the future. [REDACTED], Member of the Scottish Parliament visited the venue on the 15th of October 2024.

Unfortunately, on a sadder note we lost a founder member a good friend and a gentleman [REDACTED] who passed away in April of this year. [REDACTED] was a guy who everyone liked and got on with everyone a "cannie man" a man who dedicated his last few years to his beloved past time, the Men's shed and he will be sorely missed.

FUTURE EVENTS

There is talk of getting a new website up and running for the future of the shed which will provide better advertising of the charity. Funding applications are to be made to McDonalds and Weir Charitable Trust.

FINANCIAL REVIEW

The results for the period are set out in the attached accounts. The total income for the year was £53,269 (2024 £61,869). The total expenditure was £71,456 (2024 43,866). The results show a deficit of £18,187 (2024 surplus of £18,003). Leaving unrestricted funds of £20,969 and restricted funds of £nil total funds remaining are £20,969.

RESERVES POLICY

The reserves are unrestricted funds which are remaining after any restricted funds have been removed from total funds.

The trustees have considered reserves to be in place this was agreed at a meeting in February 2025 that £2000 should be held within the bank for this purpose. The reserves can be accessed in emergencies and the funds will then be re-established if this occurs.

This year the reserves have been met.

Basis of Independent Examiner's Statement

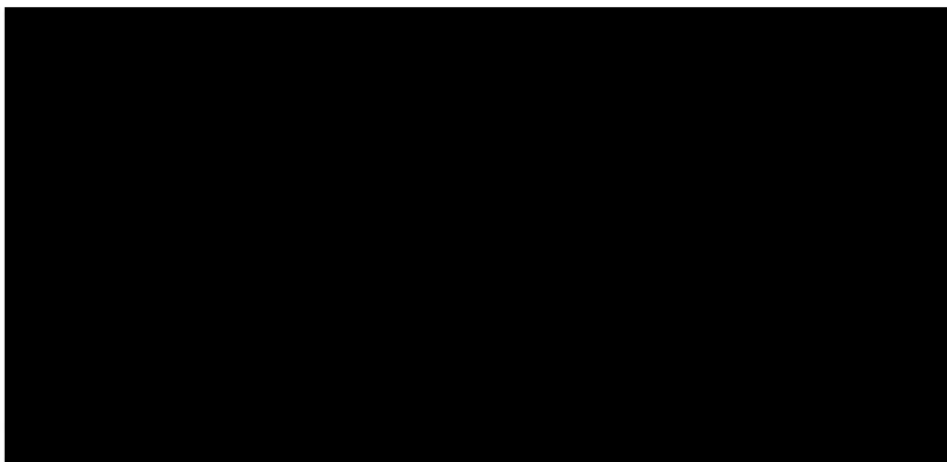

2. To which, in my opinion, attention should be drawn in order to enable a proper understanding of the Accounts to be reached.



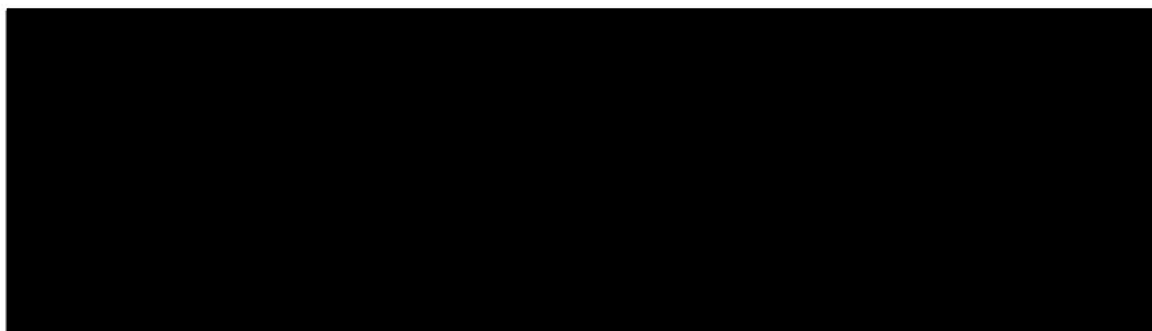

2. Fund Accounting

- a) Unrestricted funds are those that may be used at the discretion of the committee in furtherance of the objects of the charity.
- b) Restricted funds are those that may only be used for specific purposes. Restrictions arise when specified by the donor, or when funds are raised for a specific purpose.
