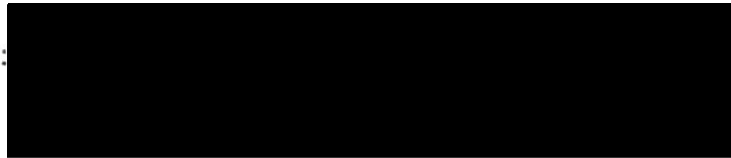

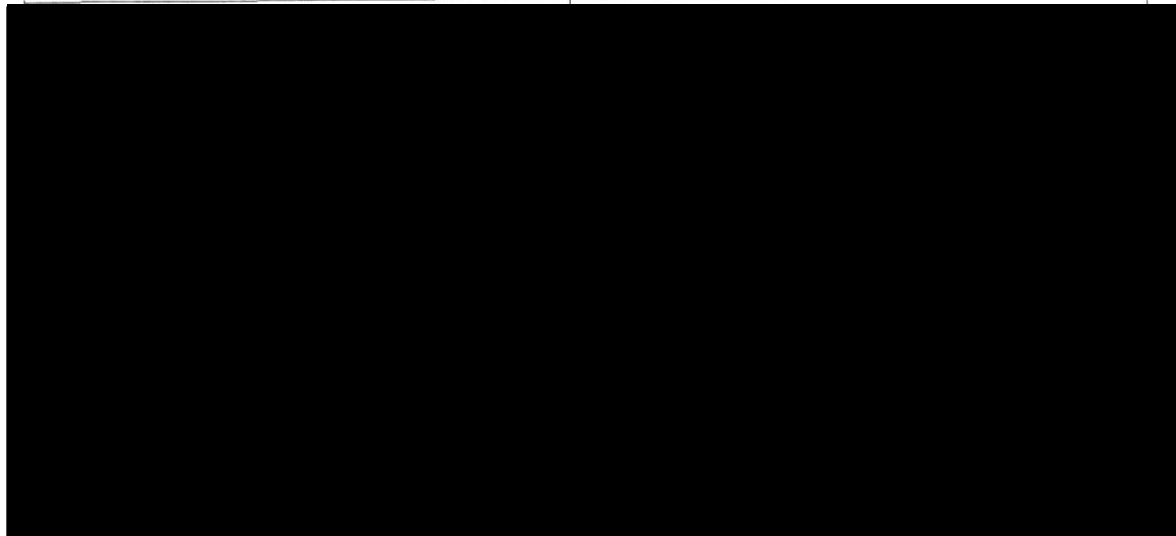

Structure Governance & Management

Constitution:

The Charity became a Scottish Charitable Incorporated Organisation on 26th September 2017. It is governed by its SCIO Constitution which was adopted on 13th September 2017.

Appointment of Trustees

The Board of Trustees, which normally meets at least thrice annually, consists of the charity's Trustees. They are elected at Annual General Meetings. Under the constitution, there must be a minimum of three and not more than nine elected Trustees. The Trustees may co-opt a further three Trustees if they consider it would be in the interests of the charity to do so. Membership of the Board is open to all Members of the charity.

Management:

The Trustees are responsible for the strategic direction and governance of the charity, whilst day-to-day running is delegated to the Secretary and the Chair's Assistant.

Board meetings were held in 2024 on Tuesday 20th February, Tuesday 5th March, Thursday 4th April, Tuesday 21st May, Tuesday 11th June, Wednesday 9th October and Tuesday 10th December.

Objectives & Activities

Charitable purposes:

The advancement of children's education, health and well-being. In furtherance of the same are the following intentions:

- a) to advance awareness of the need for Scottish children - up to and including the age of seven - to benefit from a statutory play-based 'kindergarten stage' before beginning formal schooling.
- b) to promote the role of Early Years education in 'levelling the educational playing field' by ensuring all children have secure foundations for school-based learning underpinned by play - especially outdoors - as being vital for all aspects of children's physical, emotional and cognitive development including health and well-being and, where practicable, outdoor play in the natural environment.
- c) to disseminate information about the importance of supporting children's social, emotional and spoken language development as the foundation for successful educational achievement, having regard to the need for a well-qualified, highly-respected, child-centric workforce, well-informed about the principles of child development in the Early Years.

- d) to relieve stress engendered by premature schoolification and testing, which research now suggests is counterproductive to children's long-term well-being and educational success and therefore more likely to increase than decrease the achievement gap between rich and poor.

Activities:

International evidence shows that children under the age of seven benefit from an educational approach that supports their all-round physical, emotional, social and cognitive development, rather than pushing them towards early academic achievement. Therefore, Upstart Scotland campaigns for a kindergarten stage for children aged three to seven believing that through play (especially outdoors and in natural environments), their inborn learning drive will flourish.

Our aspiration across the calendar year of 2024 continued to that of raising our profile further, and to increase our engagement with politicians and other significant personnel who might influence our campaign positively. It is clear that appealing to our elected politicians is key to changing our education and childcare structure. Board members are also aware that sustaining our campaign will require additional finance and, if possible, calling upon personnel with campaigning knowledge and expertise. Our evaluation of these aspirations is good and we consider that we have made progress, and 2025 might result in the appointment of a campaign organiser with the support of some external funding.

The work undertaken by our Board of Trustees and our registered supporters has realised success resulting in the following quantitative data; we have 12,955 followers on X (formerly Twitter), 12,699 followers on Facebook, 430 subscribed members nationally and up to 400 delegates have registered and attended our training events.

Our challenge with regard to publicity is raising our profile to convince prospective parents and carers of the benefit of our campaign, something we hope to focus on further in 2025.

During the course of 2024, we set up and hosted an Upstart stall at the Scottish Parliament. The stall attracted a significant number of MSP's representatives of the five major political parties.

The Chair met with [REDACTED] SNP MSP and Minister for Children and Young People. She and [REDACTED] SNP MSP are both very supportive of our campaign [REDACTED] [REDACTED] will be hosting a cross party round table event in the summer of 2025 with our campaign as the focus.

Upstart convened and hosted a very successful hustings event preceding the UK Parliament election in July 2024. The Husting was hosted by broadcaster [REDACTED] [REDACTED] and included cross party representatives. The event was well attended and raised our campaign profile further. [REDACTED] also advocated for our campaign in BBC Scotland's 'Debate Night'.

During the course of 2024, Board members suggested that we should elect three members of the group to form a 'Steering Group'. This was duly formed and the steering group's brief consisted of three areas: Policy and Influencing, Financial Modelling and Challenging Questions. To support this work, the Steering Group has produced three such titled papers.

Submissions have been made to the following bodies: Barnardos, The Robertson Trust and Cattanach with a view to securing funding and personnel with campaign experience. Various meetings have been convened to discuss the potential for such. Further work is scheduled for 2025.

The Chair also met with [REDACTED] Scotland's Children's Commissioner, to discuss, share and identify where our work shares common aspiration.

The main objective of our campaign is to raise the formal starting age of primary school, replacing the present early stage of primary school with a kindergarten stage focused on play and a developmental approach. However, below our main objective, there are three sub-objectives as follows: sustaining our 'Play not Tests' campaign to ensure the removal of P.1 SNSA Assessments, ensuring that 'Realising the Ambition' is applied consistently in every establishment across Scotland and, to appeal to all major political parties to include our campaign on their party manifesto for the 2026 Scottish Parliament elections.

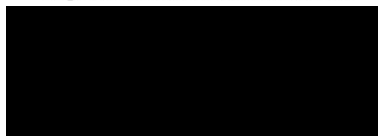

Independent examiner's report to the Trustees on the unaudited accounts of Upstart Scotland.

I report on the accounts of the SCIO for the year ended 31st December 2024 which are set out on the previous 4 pages.

Respective responsibilities of Trustees and independent examiner

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006.
