During the period Iconic Developments (Lomond Banks) were continuing to pursue planning permission for their development in the Balloch area.

We regularly liaise with Iconic Developments with respect to space allocation for a community watersports hub and community access to changing and other facilities which forms a part of their overall community use of the proposed facilities.

The planning application was with Loch Lomond and the Trossachs National Park (LLTNP) planning department who rejected the application however it has been called in by the Scottish Government. We are hopeful a final resolution either way will allow the hub to progress within the proposed development, or a clear decision that allows us to take forwards our work independently.

The Community Sports Hub continues to have support from West Dumbartonshire Council and LLTNP.
