Achievements and performance

Summary of the main achievements of the charity during the financial period

2025 was the fourth full year since the pandemic concluded, however, we appreciate that the impact of COVID-19 is still ongoing and affects many in terms of long-term health factors. At the Centre, we have maintained a range of measures that includes good ventilation standards, hand hygiene, and the supply of PPE for optional use. We have recognised that one of the many significant impacts of COVID was to create a sense of uncertainty in the presence of numbers and always welcome folk to the Centre whether for the first time or as someone returning, accepting that a build-up of both activities and attendance would take time and also fluctuate.

Promoting a strategy to rebuild the Centre after the dramatic impact of COVID and a succession of global issues, we recognised the need to diversify external income generation through hire hires and new groups, however, the Centre, is an area of low disposable incomes and could not escape the adverse impact of the cost of living. Reviewing income and expenditure each year since 2022, hall hire has fluctuated but declined in 2024 however our arguments to the City Council that the main development grant had been eroded by years of inflation was accepted, and all Centres gained a modest uplift to cover operational costs. Income from local groups declined as folk made hard choices on their own spend. We reviewed our spend to maintain building and security standards for some repair liabilities as tenant liabilities to make up from previous years. 2025 reflecting a rebalancing of income and expenditure over a four-year period of profit and loss.

Across a seven-day week we now welcome some 250 folk to participate in activities, some are led by qualified tutors and others by a lead volunteer. Our Centre programme is presented on our website, and we use social media to broaden the reach to build support for the Centre. We have fully appreciated the hardships faced by so many in these uncertain times from the cost of living and energy prices in a period of high inflation and have maintained our cost of entry as low as possible so as to minimise any

Our current policy is to ring fence a sum within unrestricted funding that is sufficient to cover operating costs for a minimum period of six months.

The Trustees have agreed to continue to gift the use of the Centre at no cost to RGU Physio outreach to enable a vitally needed local exercise clinic to run under the supervision of their qualified tutors. We have also agreed to gift the use of the Centre to Ten Feet Tall Theatre Company for the development of artistic and acting skills in a hard-to-reach community with little disposal income to pay for tuition. Wherever possible, donations have been sought to contribute to the work of the Centre

Partnership Collaboration.

We have continued and extended our collaboration with other third sectors organisations that includes Pathways, Robert Gordon University, Lochside Academy, Aberdeen Cyrenians and Aberdeen University. We have recently been able to welcome SAMH to provide a local outreach in Torry for their services given the mental health crisis that has been experienced by hundreds of people affected by RAAC in their homes.

We record our appreciation to Aberdeen City Council for their package of financial support that includes a development grant and this assists us in undertaking innovative activities and developing new initiatives that can be enjoyed at the Centre thereby preventing the cost of access being a barrier to inclusion.

Reaching Out

Across a seven-day week we now welcome some 250 folk to participate in activities, some lead by qualified tutors and others by a lead volunteer. Our Centre programme is presented on our website, and we use social media to broaden the reach and support for the Centre. We have fully appreciated the hardships faced by so many in uncertain times from the cost of living and energy prices in a period of high inflation and have maintained our cost of entry low so as to minimise any barriers to participation in activities. We cater for all ages in our activities and look to broaden activities within the times available each day and evening.

Volunteers

Since the pandemic, we have sought to rebuild a pool of volunteers to support the Centre, however, like all third sector and community organisations the ability to volunteer limits time by those who need to maintain contract hours and often have carer calls on their time. We greatly appreciate their gift of time to the Centre and are working with ACVO to create a package of support and mentoring opportunities.

The Trustees agreed to gift the use of the Centre at no cost to RGU Physio outreach to enable a vitally needed local exercise clinic to begin under the supervision of their qualified tutors. We have also agreed to gift the use of the Centre to Ten Feet Tall Theatre Company for the development of artistic and acting skills in a hard-to-reach community with little disposal income to pay for tuition. Wherever possible, donations have been sought

Other optional information

Partnership Collaboration.

We have continued and extended our collaboration with other third sectors organisations that includes Pathways, Robert Gordon University, TLC, Aberdeen Cyrenians and Aberdeen University, However, an absence of funding support to Lead Scotland led to their withdrawn from outreach at the Centre, whilst Aberdeen Foyer lost their field worker and have not been able to fund a replacement.

We record our appreciation to Aberdeen City Council for their package of financial support that includes a development grant and assists us in undertaking innovative activities and developing new initiatives that can be presented by the Centre thereby preventing the cost of access being a barrier to inclusion.

Reaching Out

Across a seven-day week we now welcome some 200 folk to participate in activities, some lead by qualified tutors and others by a lead volunteer. Our Centre programme is presented on our website, and we use social media to broaden the reach and support for the Centre. We have fully appreciated the hardships faced by so many in uncertain times from the cost of living and energy prices in a period of high inflation and have maintained our cost of entry low so as to minimise any barriers to participation in activities. We cater for all ages in our activities and look to broaden activities within the times available each day and evening.

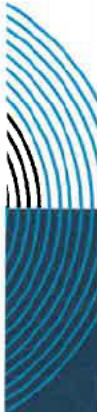
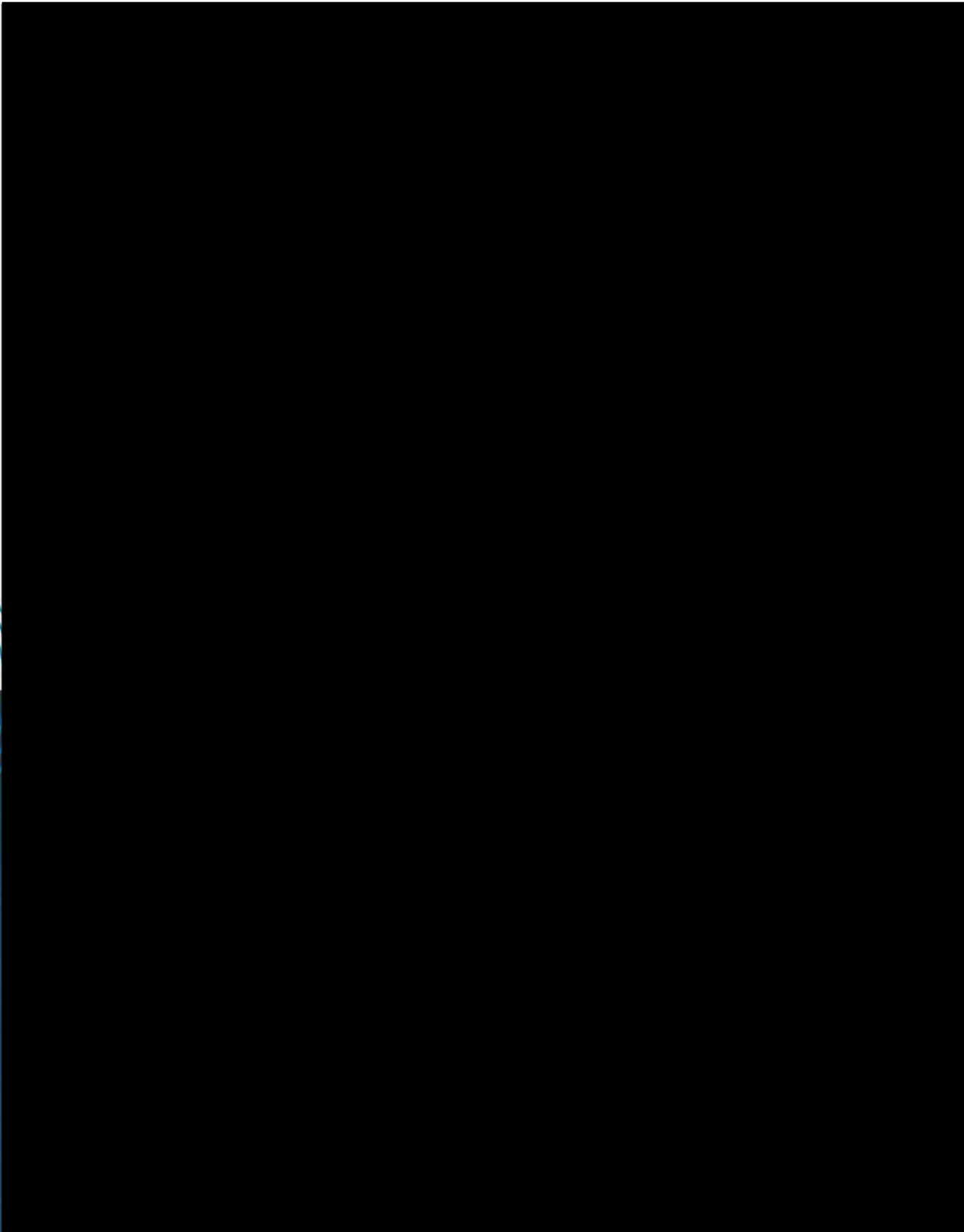
Volunteers

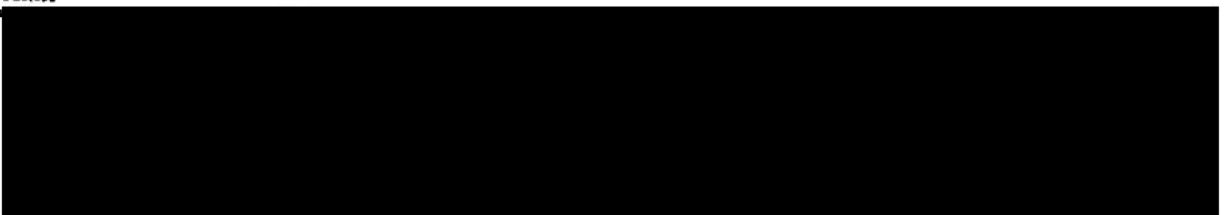
