Structure, Governance and Management

The charity is governed by a Constitution. The charity is unincorporated.

Organisation

The general management and control of the association is the Hall's Management Committee consisting of members elected annually at the Annual General Meeting or by co-option during the year. All members of the Committee shall retire at the AGM but shall be eligible for re-election.

Objectives and Activities

The aims of the Committee shall be to promote and encourage the preservation, development and improvement of all the subjects described in the Deed of Trust; to raise funds for the improvement and enhancement of Allanton Village Hall, Recreation Ground, Play Park and other subjects; to stimulate public interest in the use and care of the subject, and to carry out activities and services that will benefit the community.

Achievements and Performances

The 2023/4 year has been a great year for the hall where more of the community enjoyed the services offered by the committee, but they also got involved to help support the hall's upkeep and make it a better place to enjoy by all. This has hugely supported our main aim of providing a safe, warm place with good facilities and regular organised social activities to enable people to gather and benefit as a community.

The committee ran 10 coffee mornings and an afternoon tea, 2 fun quiz nights and a community Christmas lunch. They also organised a village volunteer day with lots of people in attendance to help litter-pick, hall gardening and woodland clearing, with picnic food served in the hall as a reward for the community's hard-work. Everyone felt the benefit and spirits were high afterwards.

Some regular activities continue such as Scottish Country Dancing, a weekly table tennis, social dance classes and some new art classes have been popular too. Local mums have also been organising a regular Lego club for kids held at the hall, which is great for our young community.

The committee undertook a project, which was grant funded, to upgrade and modernise the décor in the hall. The main hall had a fresh look with making good the tired-looking wall spaces and notice boards, and painting of the main hall giving a more modern and fresh look which the villagers have appreciated. They committee continue to look at ways to renovate and improve the hall facilities and kitchenware.

Through promoting the hall's events, whether organised by the committee or helping promote hall hirers events, it is bringing in more people from the wider community to use the hall on a more regular basis.

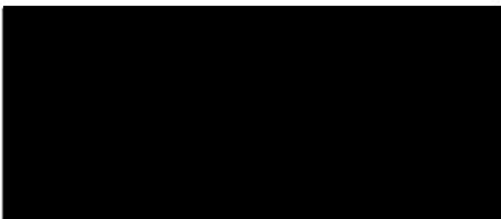
Financial Review

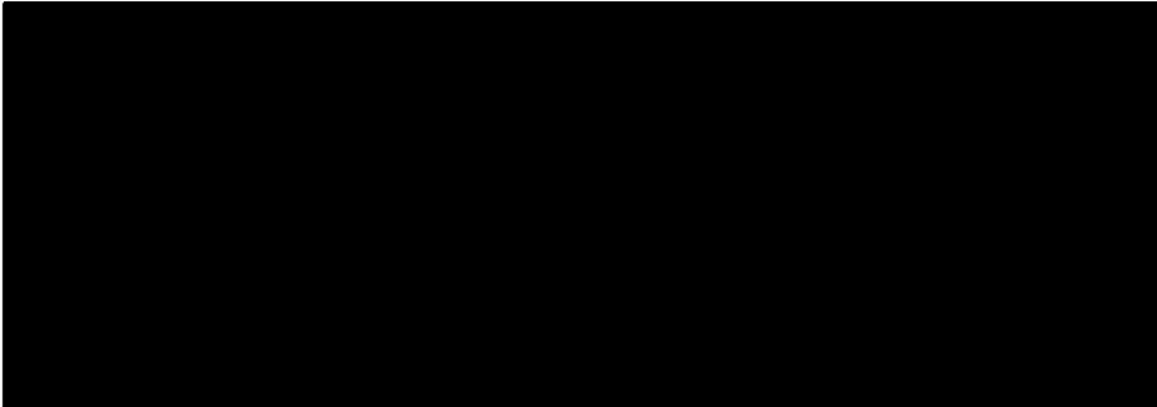

I report on the accounts for the charity for the year ended 30th September 2024 set out on pages 3-6

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with these records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
