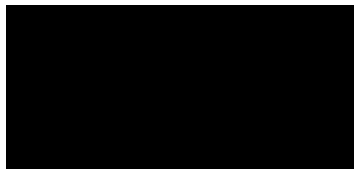

REPORT OF THE TRUSTEES

The Trustees of AKG Charitable Trust hereby submit their report and accounts for the year ended 30 June 2025.

Structure, Governance and Management

AKG Charitable Trust is a SCIO, registered in Scotland and is governed by its constitution. The trustees are responsible for the administration and direction of the charity. The charity was registered on 25 July 2018 and commenced charitable activities on 29 October 2018.

Recruitment and appointment of Trustees

All of the charity's trustees are appointed or reappointed by the members at the annual general meeting. New trustees are recruited on an ad hoc basis, as and when required.

Charitable Purposes

The aims and objectives of AKG Charitable Trust are:-

- To provide relief and assistance for people in need by reason of age, ill health, disability, financial hardship or other disadvantage.
- To assist in the advancement of education, religion and health which ultimately will aid in the saving of lives.

Activities and Achievements

During the year, the charity received rental income from properties which it owns. This allowed them to continue to donate to charities or worthwhile causes as it sees fit. This is detailed in the notes to the accounts.

Trustee Remuneration and Expenses

The trustees did not receive any remuneration or expenses during the period.

Going Concern

All rental income has continued to be received and donations from these funds were made as normal. The trustees have a reasonable expectation that the charity has adequate resources to continue in operation for the foreseeable future.

Financial Review

The net deficit on funds for the period amounted to £3,649 (2024 – surplus of £2,241). Unrestricted reserves to carry forward amount to £4,513 (2024 - £8,162).

The Trustees have agreed that a reserves policy is not required.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES

I report on the accounts of the charity for the period ended 30 June 2025 which are set out on pages 5 to 7.

Respective responsibilities of trustees and independent examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity Trustees consider that the audit requirement of the Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
