## TRUSTEES' REPORT FOR THE YEAR ENDED 31 OCTOBER 2024

---

The Trustees present their report and independently examined accounts for the year ended 31 October 2024.

### Principal activity

The organisation is a SCIO (Scottish Charitable Incorporated Organisation). The principal objects of the organisation are the advancement of public participation in sport, in particular tennis, or the training for such regardless of level of skill or physical ability and to contribute to the improvement of physical health, fitness, social and mental wellbeing of the wider community.

### Aims and Objectives

The club has been established as a charitable organisation and its purposes are:

- To advance public participation in sport, in particular tennis, or the training for such regardless of level of skill or physical ability and to contribute to the improvement of physical health, fitness, social and mental wellbeing of the wider local community.
- Encourage and provide facilities in sport in and around the local community of Stewarton, East Ayrshire, in particular to provide tennis, and generally to encourage and facilitate the growth of the sport within this community.
- Act as a means of health promotion and fitness in the local community by way of introducing an opportunity to access facilities and organised groups for the practice of the sport.
- Actively encourage young people to participate in sport for recreation and leisure in a safe environment
- Regenerate the existing sports facilities for tennis in the local community

Summary of the main activities in relation to these objectives:

- The club promotes and provides an outlet for sport and physical activity within the local community by developing the existing facilities to ensure a safe environment in which to participate
- The club has organised evenings for the adult members in which they can attend at all levels for a social hit with fellow members throughout the week
- The club has an extremely popular coaching programme for the younger members. This follows the LTA junior coaching levels from the age of 4 up to 12. This allows young members of the community to build both physical and social skills and also learn how to compete in a sporting environment
- The club also participates in Leagues for all ages to promote the sport of tennis across Ayrshire by competing against other clubs in the locality of Ayrshire.
- The Club works closely with the LTA governing body in the form of Tennis Scotland as well as East Ayrshire Council(EAC) to further develop the sport of tennis through schools and to maximise the leisure facilities the club can offer to grow the sport within the local community.

### Structure, governance and management

#### Organisational Structure

The SCIO was incorporated on 3 October 2018 (SC048737).

#### Constitution

A copy of the constitution, which deals with the appointment and termination of Trustees among other matters, is available from the Trustees at the principal office address. The clubs' governing document is in the form on the Club Constitution, this is available to members and non-members on the club website. It is also emailed out to all members on a yearly basis when they rejoin the club.

The Trustees/committee are responsible for the strategic direction and governance of the club, as well as administering the day-to-day activities of the club within the local community.

The Trustees meet regularly to discuss active matters within the club as well as future planning to grow, compete and develop the sport in the local community.

### Achievements and performance

As always, the coaching programme for the Junior members moved into the Rose Reilly sports centre to maintain the progress all year round for the junior members. The winter months also saw the club enter 3 teams into the Tennis Ayrshire Mini Leagues 23/24. This allows the junior members the opportunity to gain match play experience against other clubs across Ayrshire monthly. As the players play both singles and doubles this allows them to gain the experience of being part of a team. The 8U team was a real triumph for the club winning their division and going unbeaten in the process.

Away from the team events the early months of 2024 saw junior members compete in the Ayrshire Indoor singles competitions, this saw the club having players represent the club in 8U, 9U and 10U levels. This shows the progress the club is having at the junior levels with more players competing regularly in competitions across Ayrshire.

The new season in 2024 saw a fresh intake of Amazon Prime Youth Girls sessions being put on by the coaches at the club. This gives girls aged between 5–9-year-old an entry into the sport of tennis. They get a 6-week course and receive a racket, balls, T shirt and wristbands. This has been a great success at getting more players into the sport who had never tried it before.

As well as this the club has now alongside the coaches introduced a Tennis Express session. This is aimed at adult beginner players or rusty racket players who wish to re-engage with the sport. The class is open to members and non-members who wish to take up the sport of tennis. This has been extremely popular with 2 courses of lessons being carried out over the summer. We hope to attract more players and get the sport out to as many players as possible in the local community

The Summer again saw the return of the annual Tennis Ayrshire Summer Leagues, this year Stewarton Tennis Club managed to field 5 adult teams in the leagues. This time there was 3 gent's teams and 2 ladies teams. Again, this saw a number of the junior members who've come through the coaching programme feature for the adult teams. This year saw the gent's 1<sup>st</sup> team and the ladies 2<sup>nd</sup> team both gain promotion from their respective divisions. This will see the Gents 1<sup>st</sup> team next season play in the top division in Ayrshire.

As always, the start of the tennis season in 2024 saw the annual club Open Day. This saw another successful Parent/Child tournament to start the proceedings, with 26 pairs competing for the coveted inflatable trophy. As usual fun and games followed, and an adult social tournament rounded off the day. This is always a highlight in the calendar as it allows the entire community to come and enjoy the facilities and try out tennis.

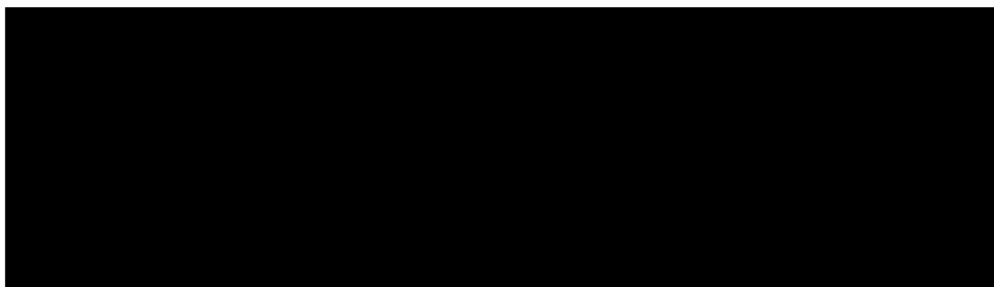
The summer also saw the annual Bonnet Guild Tennis event, this is part of a range of activities that run across the week as a celebration for the entire town. It's always greatly attended by competitors and spectators who get to watch the tennis on show.

The club also took part in Tennis Ayrshires Masters competition. The team winning the second division. This is a competition for players over the age of 45 to encourage tennis for all age groups.

Stewarton Tennis Club alongside both Kilmarnock and Kilmaurs Tennis Club have also been awarded funding from East Ayrshire Council to promote Tennis in the local schools. This will see the clubs coaches going into the local primary schools and providing a course of lessons to the pupils. It will also allow funding for a open day, celebration of tennis to be held.

### Trustee recruitment and appointment

Membership to the committee is open to all eligible members of the club. The Trustees are appointed at each AGM. At each AGM, all the charity Trustees must retire from office – but may then be re-elected at the same AGM

### Independent Examiner

[REDACTED] JRD LLP was appointed as independent examiner during 2023 in respect of the accounts for the year ended 31 October 2023. He was reappointed at the subsequent AGM in respect of the accounts for the year ended 31 October 2024.

### Review of Financial Year

The receipts and payments account at page 2 of the accounts shows an excess of payments over receipts of £6,975 (2023: excess receipts over payments £7,415). An analysis by restricted and unrestricted funds is shown at note 5 on page 5 of the accounts.

### Reserves Policy

Total unrestricted funds at 31 October 2024, on a cash basis, were £39,780 (2023: £42,162). A formal reserves policy is under consideration by the current Trustees, taking into consideration the charity's specific activities and circumstances.

### Future plans

Continuation of the planning to replace the existing 100 year-old Clubhouse. This project has been a number of years in the planning with regards to fundraising and planning. A new Clubhouse would allow further future development of the club and the sport of tennis in the wider community.

### Trustees responsibilities

The Trustees are required to act in accordance with the constitution and within the framework of relevant charity legislation. They are responsible for keeping proper accounting records, which disclose with reasonable accuracy at any time the charity's financial position, and to enable them to ensure that the accounts comply with the applicable requirements of the following:

- Charities and Trustee Investment (Scotland) Act 2005.
- Charities Accounts (Scotland) Regulations 2006 (as amended).

The Trustees have the responsibility for taking reasonable steps to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

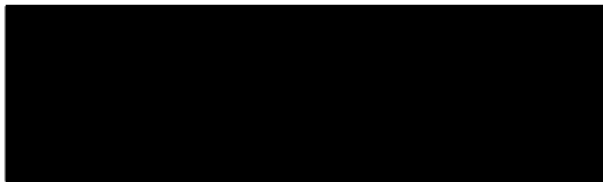
