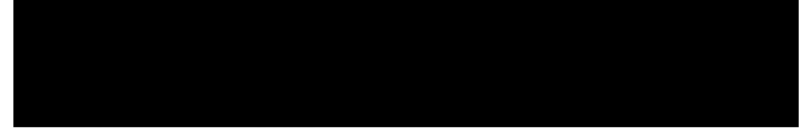

Report of the Trustees for the year ended 31 May 2020

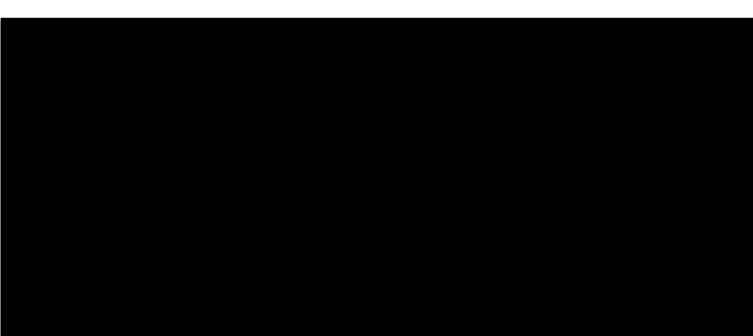
The Trustees are pleased to present their report together with the financial statements of the charity for the year ended 31 May 2020.

Legal Structure

St Peters Football Club was registered with the Office of the Scottish Charity Regulator on 10 October 2018 as a Scottish Charitable Incorporated Organisation. The charity registration number is SC048750.

Trustees

The Trustees who served during the year and to the date of this report were as follows:



Appointment of Trustees

New Trustees are appointed as and when required by the charity's needs. Appointment is through a process of strict criteria that has been agreed upon by the current Trustees. No set time limit is agreed for Trustees though the Trustees review their involvement annually.

Charitable Objectives

The charity was established to complete the following objectives:

- The advancement of public participation in sport in Renfrewshire and surrounding areas.
- The provision of recreational facilities, or the organisation of recreational activities, with the objective of improving the conditions of life for the persons for whom the facilities or activities are primarily intended.

Principal Activities

St Peters Football Club is a Community Sports Club that incorporates Football and Netball teams within the Governing Body of the SFA and Netball Scotland.

Fees are gathered per age group/team and the Club also receives sponsorship and grants to generate income, with the aim to expand the Club.

Achievements and Performance

The Club has grown from strength to strength due to new age groups starting with further groups to be added, which will contribute to the growth of the Organisation. The Club has over 400 children and 100 Volunteer qualified coaches and helpers.

Financial Review

The Trustees are pleased to record that income for the year amounted to £11,364 (period ended 31 May 2019: £25,336 including £16,934 of funds accumulated by the charity prior to its registration with OSCR). The charity's principal funding source is fee income from the netball and football groups. There is a net excess of payments over receipts in the year of £12,886 (period ended 31 May 2019: excess of receipts over payments of £21,206).

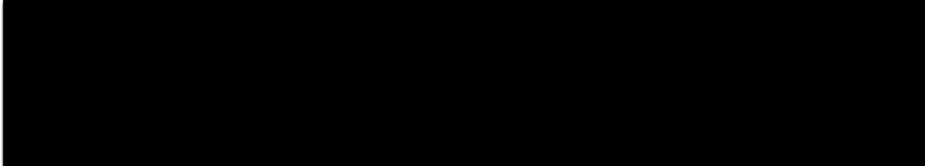
Basis of Independent Examiner's Statement
