- Sponsorship of children through compassion program increased to 3 during the year. Sponsorship of the child in Uganda directly through a local Pastor progressed well during the year.

More success was recorded in our various outreaches for the year as highlighted below:

- Reach out to the single parents and witnessed to many more people on broken homes were reached and ministered to during the year while regular home visits continued.
- Many of these people are continually feelings of abandonment and discouragements were regularly addressed and we always leave with smiles on their faces.
- We had more questions from young people on the street ranging from issues with smoking, alcoholism etc to issues of homelessness. A project to start up a venue in the needy area was proposed for the coming year.
- English classes continued and many more nationalities struggling with English language continue to attend with more days now being offered.
- We were able to offer support and encouragement to much more people than we did in the last year.
