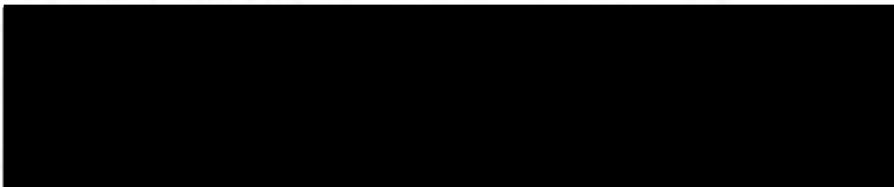

We held our annual BBQ in the summer which was well attended and enjoyed by all.

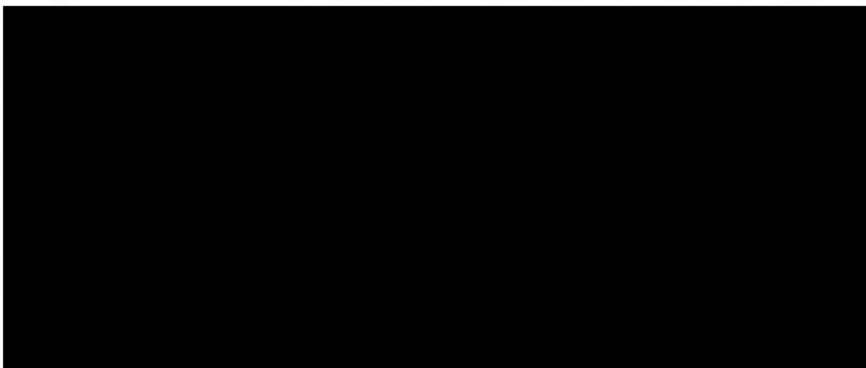
Trustees Remuneration

Independent Examiner's Report to the Trustees of the Bolton East Lothian Community Association

I report on the accounts of the charity of the year ended 31st January 2025 which are set out on pages 3 to 5.

Respective Responsibilities of the Trustees and Examiner

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.
