**What the charity does:** The charity was originally set up to help eliminate common causes of curable blindness globally, namely cataract and corneal blindness, and to support other causes of curable and treatable blindness. Since 2020 and the restrictions surrounding the Covid pandemic, the focus of the charity was shifted to helping vulnerable people within the local community. With nominations from local optometry practices, successful candidates are selected for funded cataract treatment who would otherwise be increasingly struggling with their day to day activities whilst waiting on NHS treatment. We have now successfully carried out campaigns in 2022, 2023, 2024 and we are currently in the process of a new campaign for 2025.

**Objectives:** 4.The organisations purposes are: 4.1 to help to eliminate common causes of curable blindness globally namely cataract and corneal blindness and to support other causes of curable and treatable blindness.

## APPENDIX 1

### Other optional information

'Gift of Sight' programme was originally launched with local optometry practices in January 2022. Optometrists were asked to nominate patients awaiting treatment on NHS who could not afford to seek treatment privately but would benefit greatly from their treatment being carried out quickly. Social, financial and health criteria were to be considered to ensure that the most vulnerable and deserving patients could benefit from the programme. This programme was opened again on 30<sup>th</sup> September 2024 and a deadline of 30<sup>th</sup> November 2024 was set for the receipt of nominations.

Trustees met on 6<sup>th</sup> January 2025 to discuss nominations received from optometry practices through the 'gift of sight' programme described above. Each case was discussed to ensure each patient met the criteria set out and if treatment was appropriate. 4 patients requiring unilateral cataract surgeries were identified. Each identified patient received their treatment at Ayrshire Eye Clinic at no cost to them. Ayrshire Eye Clinic facility costs, staff costs, required consumables and instruments were donated to the programme.

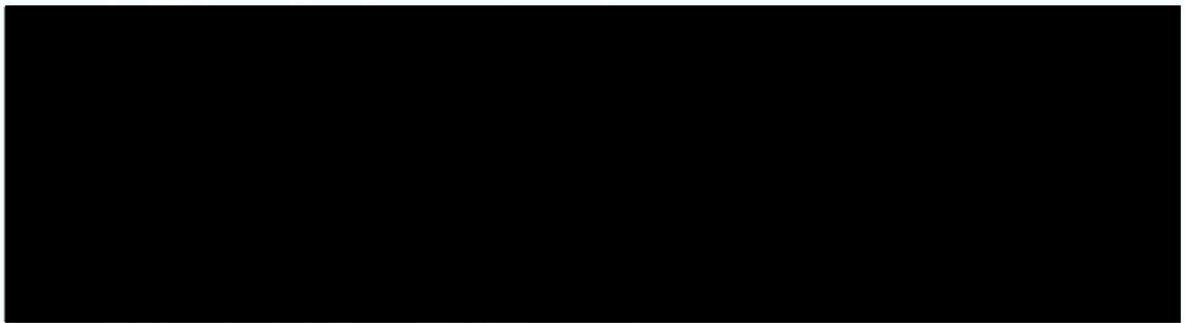
